Notice of Approval of Amendment

Amendment GC143

The Minister for Planning has approved Amendment GC143 to the Casey Planning Scheme and Greater Dandenong Planning Scheme (planning schemes).

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment facilitates the Cranbourne Line Upgrade by making the following changes to the planning schemes:

- Amends the schedule to Clause 45.12 Specific Controls Overlay to insert the *Cranbourne Line Upgrade Incorporated Document, February 2020* (incorporated document) facilitating use and development of land for the project.
- Amends the schedule to Clause 72.03 What Does this Scheme Consist of to amend and introduce new planning scheme maps.
- Amends the schedule to Clause 72.04 Documents Incorporated in this Planning Scheme to insert the incorporated document.

For the Greater Dandenong Planning Scheme, the Amendment:

- Applies the Public Acquisition Overlay to land in Dandenong South required for the Port Rail Shuttle and amends the schedule to Clause 45.01 (Public Acquisition Overlay) to list the Secretary to Department of Transport as the acquiring authority.
