#### Amendment C193moon

The Minister for Planning has approved Amendment C193moon to the Moonee Valley Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment implements the findings of the *Moonee Valley Planning Scheme Review 2018* and the land use and development directions of the *MV2040 Strategy 2018*, by replacing the Municipal Strategic Statement at Clause 21 and Local Planning Policies at Clause 22 of the Moonee Valley Planning Scheme with a Municipal Planning Strategy and local policies within the Planning Policy Framework, consistent with the structure introduced by Amendment VC148.
