#### Notice of Approval of Amendment

#### Amendment GC150

The Minister for Planning has approved Amendment GC150 to the Casey, Hume, Melton, Mitchell, Whittlesea, and Wyndham Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment replaces the existing Small Lot Housing Code incorporated document in the respective Casey, Hume, Melton, Mitchell, Whittlesea and Wyndham Planning Schemes with the new version of the code titled '*Small Lot Housing Code (Victorian Planning Authority, November 2019)*' to address recurring misinterpretations and provide greater clarity in the incorporated document's definitions and standards.
