Transport (Compliance and Miscellaneous) Act 1983

AMENDING CONDITIONS NO. 6/2020 MADE UNDER SECTION 220D

The Head, Transport for Victoria, the entity established under section 64A of the **Transport Integration Act 2010**, under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, hereby determines the following conditions (the Amending Conditions No. 6/2020) which amend the Conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** dated 23 December 2019, published in the Victoria Government Gazette No. S 558 dated Monday 23 December 2019, effective 1 January 2020, as amended previously by amending conditions published in the Victoria Government Gazette on Friday 28 February 2020 (No. S 96), Friday 3 April 2020 (No. S 178), Thursday 7 May 2020 (No. S 228), Friday 12 June 2020 (No. S 282) and Thursday 2 July 2020 (No. S 335).

The Amending Conditions No. 6/2020 take effect from and including 13 July 2020. Dated 7 July 2020

AMENDING CONDITIONS NO. 6/2020

The conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** dated 23 December 2019, published in the Victoria Government Gazette No. S. 558 dated Monday 23 December 2019, effective 1 January 2020, as amended previously by amending conditions published in the Victoria Government Gazette on Friday 28 February 2020 (No. S 96), Friday 3 April 2020 (No. S 178), Thursday 7 May 2020 (No. S 228), Friday 12 June 2020 (No. S 282) and Thursday 2 July 2020 (No. S 335) (the Conditions) are amended as follows:

In Chapter 4 of the Conditions, under the subheading 'Touch on/touch off conditions – bus' for the following –

'For a journey on a bus (other than a bus used for a night coach network service) –

- (a) unless subparagraph (b) applies, a customer must touch on the myki immediately upon boarding the bus;
- (b) if it is necessary for a myki to be purchased or for value to be loaded on a myki on board the bus in order for the myki to be able to be touched on, the customer must touch the myki as soon as possible after the myki has been purchased or value has been loaded; and
- (c) a customer must touch off the myki before leaving the bus, but not before the bus leaves the second-last bus stop in that journey.

Subparagraph (b) does not apply where prepay all door boarding conditions apply, as specified in this Chapter.' –

substitute -

'For a journey on a bus (other than a bus used for a night coach network service) –

- (a) a customer must touch on the myki immediately upon boarding the bus; and
- (b) a customer must touch off the myki before leaving the bus, but not before the bus leaves the second-last bus stop in that journey.

myki-enabled bus services are now pre-pay only.

Customers may board a myki-enabled bus and touch on their myki at any door. However, staff or signage may direct customers to use a specific door.'

- 2. In Chapter 4 of the Conditions, under the heading 'TOPPING UPMYKI' for the following 'Customers cannot purchase or top up a myki on board buses
 - (a) at Doncaster Park and Ride;
 - (b) on bus route 401; or
 - (c) on selected bus routes (or at selected bus stops) where prepay all door boarding conditions apply, as specified in this Chapter.' –

substitute -

'myki-enabled bus services are now pre-pay only. Customers cannot purchase or top up a myki on board buses.

Customers travelling using a myki on myki-enabled bus services will accordingly need to hold a myki and ensure the myki is topped up, as required in accordance with the conditions in this Chapter, prior to boarding.'

3. In Chapter 4 of the Conditions, **omit** the following –

'PREPAY ALL DOOR BOARDING

For buses travelling on selected bus routes and at selected bus stops, as specified on the PTV website (or a website maintained by the Department of Transport) from time to time, the following prepay all door boarding conditions apply –

- (a) customers are not permitted to purchase or top up a myki on board the bus;
- (b) customers must hold a myki prior to boarding;
- (c) customers must top up a myki, as required in accordance with the conditions in this Chapter, prior to boarding; and
- (d) customers may board the bus and touch on their myki at any door.'

The amendments made by these amending conditions apply in respect of entitlements to use a public transport service that are subject to the conditions contained in the Conditions and that are able to be exercised on or after the commencement of these amending conditions, including entitlements that existed, but had not been exercised, before these amending conditions were published in the Government Gazette.
