

At its meeting on 31 August 2020 and acting under Clause 3 of Schedule 10 to the **Local Government Act 1989**, Maroondah City Council resolved to discontinue and retain part of the road known as Pitt Street, Ringwood, being that part of the land contained in Certificates of Title Volume 2583 Folio 506 and Volume 3041 Folio 062 shown shaded grey on the plan below (Road).

The Road is to be sold subject to any right, power or interest held by Yarra Valley Water Corporation in connection with sewers, drains, pipes under the control of that authority over that part of the Road shown marked 'E-1', 'E-2' and 'E-3' and AusNet Electricity Services Pty Ltd in connection with any wires or cables under the control of that authority over that part of the Road shown marked 'E-3' and 'E-4' and Multinet Gas in connection with any pipes under the control of that authority over that part of the Road shown marked 'E-2' and 'E-3'.




