Order in Council

The Governor in Council under section 15(1)(b)(iv) of the **Local Government Act 2020** alters the name of a ward of Nillumbik Shire Council, by replacing ‘Edenvale’ with ‘Edendale’. The Nillumbik Shire Council’s electoral structure incorporating the alteration to the name of the ward is described in the plan contained in the Schedule attached to this Order.

This Order comes into effect on the date it is published in the Government Gazette.

The changes are to have effect for the purposes of the next general election of Nillumbik Shire Council.




ELECTORAL STRUCTURE OF NILLUMBIK SHIRE COUNCIL


