- 31/2020
 - (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 - (2) If a provision of this Act does not come into operation before 1 July 2021, it comes into operation on that day.
- 32/2020
 - (1) This Act, except Part 4, comes into operation on the day after the day on which it receives the Royal Assent.
 - (2) Subject to subsection (3), Part 4 comes into operation on a day or days to be proclaimed.
 - (3) If a provision of Part 4 does not come into operation before 1 September 2021, it comes into operation on that day.
- 33/2020
 - (1) This Part and Division 2 of Part 3 come into operation on the day after the day on which this Act receives the Royal Assent.
 - (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
 - (3) If a provision referred to in subsection (2) does not come into operation before 28 June 2021, it comes into operation on that day.
- 34/2020
 - (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 - (2) If a provision of this Act does not come into operation before 15 September 2021, it comes into operation on that day.
