Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN
CITY OF MELBOURNE FOR THE BLACKLIGHT FEATURE FILM ON
SATURDAY 21 NOVEMBER 2020 AND SUNDAY 22 NOVEMBER 2020

1 **Purpose**

The purpose of this Declaration is to exempt participants in the filming of Blacklight Feature Film from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on Saturday 21 November 2020 and Sunday 22 November 2020.

2 **Authorising provision**

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister for Roads may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

3 **Commencement**

This notice takes effect on 3.00 pm on Saturday 21 November 2020.

4 **Expiry**

This notice expires at 7.00 am on Sunday 22 November 2020.

5 **Definitions**

In this notice, unless the context or subject-matter otherwise requires –

- a) ‘Event’ means the filming of Blacklight Feature Film, to be held on Saturday 21 November 2020 and Sunday 22 November 2020; and
- b) ‘Participants’ means participants in the Event, including officers, members and authorised agents of the Blacklight PSC Pty Ltd, whose presence is reasonably required to ensure the safe conduct of the Event.

6 **Declaration**

I, Neil Byrne, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by the Department of Transport and the municipal council.
