MELBOURNE CRICKET GROUND FLOODLIGHT DETERMINATION NO. 4/2020

I, Martin Pakula, Minister for Tourism, Sport and Major Events, make the following determination:

1. Title

This determination may be cited as the Melbourne Cricket Ground (Operation of Floodlights) Determination No. 4/2020.

2. Objectives

The objectives of the determination are to:

- (a) Specify the days and times during which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground (MCG) may be used; and
- (b) Specify the purposes for which the floodlights may be used on those days.

3. Authorising provision and commencement

This determination is made under section 30 of the **Melbourne Cricket Ground Act 2009** and commences on the date it is published in the Government Gazette.

4. Floodlights may be used on certain days at certain times and for certain purposes

The floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be used:

- (a) between 8.00 am and 8.00 pm from the date this determination commences to Wednesday 17 March 2021 for the purpose of aligning, testing and repairing the floodlights;
- (b) between 8.00 am and 8.00 pm from the date this determination commences to Wednesday 17 March 2021 for the purpose of cricket training;
- (c) between 7.30 pm and 11.00 pm on Thursday 24 December 2020 for the Network Nine telecast of Carols by Candlelight;
- (d) between 10.00 am and 11.30 pm from the date this determination commences to Wednesday 17 March 2021 for the purposes of playing Cricket matches, including:
 - the Boxing Day Test
 - the Big Bash
 - One Day International matches
 - The Sheffield Shield
 - The Marsh One Day Cup.

Note: Specific match dates within the period specified in clause 4(c) of this determination will be announced by Cricket Australia and published on its website.
