**Project Development and Construction Management Act 1994**

NOMINATION ORDER

Order in Council

The Governor in Council with the advice of the Executive Council under section 6 of the **Project Development and Construction Management Act 1994** ('the Act') and on the recommendation of the Premier, by Order declares the Public Housing Renewal Program Package 1 Project ('Nominated Project') to be a project to which the Act applies and, in accordance with section 7 of the Act, specifies that:

- (a) the Minister for Housing is the Minister who is to be responsible for the Nominated Project; and
- (b) the Director of Housing, being a body corporate established under section 9 of the **Housing Act 1983**, is to be the facilitating agency for the Nominated Project.

- (c) the following provisions of Part 3 of the Act are to apply in relation to the Minister for Housing, the responsible Minister for the Nominated Project: sections 19, 20, 22, 23 and 24.
