




INTERIM PROHIBITION ORDER

This Interim Prohibition Order is made pursuant to section 90 of the **Health Complaints Act 2016**.

The general health service provider named above must display a copy of this Interim Prohibition Order at their business premises and ensure that it is easily visible to the public until such time as the Interim Prohibition Order is expired or revoked. 4. The general health service provider named above must publish a copy of this Interim Prohibition Order, that is easily visible to the public, on any website or social media platform she uses to offer or promote any general health services including (but not limited to) on the homepage of the following website: <ul style="list-style-type: none"> ● https://www.thegoodlifeantiageing.com.au/ 5. The published Interim Prohibition Order must remain on websites at all times until the Interim Prohibition Order has expired or is revoked.

This updated Permanent Water Saving Plan will be for all Greater Western Water customers and come into effect from 1 July 2021.

City West Water Corporation currently has a Permanent Water Saving Plan, which sets out the common-sense rules that guide outdoor water usage and principles for considering applications for exemptions from particular rules. The rules are common across Victoria and are designed to ensure water is used sensibly and waste is avoided.

As part of our integration, the City West Water Permanent Water Saving Plan will become the basis for the new Greater Western Water Permanent Water Saving Plan.

City West Water Corporation proposes to vary its Permanent Water Saving Plan under section 170B of the **Water Act 1989**. The proposed variations will:

- change references to City West Water to Greater Western Water; and
- apply the Permanent Water Saving Plan to the water districts of Greater Western Water.

No other details are changing, including the water saving rules and criteria to apply for an exemption.
