

#### FISHERIES (ROCK LOBSTER DIGITAL TAGGING) NOTICE 2021

**1. Title**

This Notice may be cited as the Fisheries (Rock Lobster Digital Tagging) Notice 2021.

**2. Objectives**

The objectives of this Notice are –

- (a) to specify measures for the protection of rock lobster through the use of a digital tagging system to quantify the recreational take of rock lobster; and
- (b) to fix and enforce catch limits for rock lobsters that are possessed by a fisher without the use of rock lobster tags.

**3. Revocation**

The notice published in Government Gazette No. S 328 on Thursday 24 June 2021 titled ‘Fisheries (Rock Lobster Tagging) Notice 2021’ is revoked.

**4. Authorising provision**

This Notice is made under sections 67 and 152 of the Act.

**5. Commencement**

This Notice comes into operation on 16 November 2021.

## 6. Application

This notice does not apply to –

- (a) the holder of a rock lobster fishery access licence, or a person acting on behalf of that licence holder, when carrying out any fishing activities authorised by the licence; or
- (b) a person who has received rock lobster from a person referred to in sub-clause (a); or
- (c) a person who is in possession of rock lobster and the rock lobster is accompanied by a fish receipt or a catch disposal record issued to the person in respect of that rock lobster; or
- (d) an authorised officer or employee of the Victoria Fisheries Authority (VFA) in the execution of that person's power, function or duty under the Act.

## 7. Definitions

In this Fisheries Notice –

**digital tag number** means the unique identifier issued by the recreational rock lobster notification and reporting system and assigned to a rock lobster.

**recreational rock lobster notification and reporting system** means –

- (a) the Internet application (including any automated response system which captures the information provided) provided by the Victorian Fisheries Authority that is known as the 'GoFishVic app' through which –
  - (i) a person may notify their intention to the Victorian Fisheries Authority to take rock lobsters for recreational purposes during a specified rock lobster season; and
  - (ii) a person may notify specified details to the Victorian Fisheries Authority for each rock lobster that has been taken; and
  - (iii) the Victorian Fisheries Authority may provide confirmation to a person of the receipt of information provided by the person to the Victorian Fisheries Authority under this Notice.
- (b) if the Internet application is not available, an alternative system approved by the Victorian Fisheries Authority.

**Note** All other words and phrases in this notice have the same meanings as in the **Fisheries Act 1995** and the **Fisheries Regulations 2019**.

## 8. Limit on the take and possession of rock lobster for recreational purposes unless certain conditions are met

- (1) For the purposes of section 152(1)(a) of the Act, and subject to this notice, the catch limit with respect to the taking or possession of rock lobster anywhere in Victoria is zero.
- (2) Sub-clause (1) does not apply to a person who has –
  - (a) registered their intent to be active in the current rock lobster season via the recreational rock lobster notification and reporting system and in the manner required by the Victorian Fisheries Authority; and
  - (b) provided to the Victorian Fisheries Authority, via the recreational rock lobster notification and reporting system and in the manner required by the Victorian Fisheries Authority, no more than 7 days after taking rock lobster, the following information for each rock lobster taken –
    - i. the digital tag number; and
    - ii. the location at which the tag was used; and
    - iii. the date the rock lobster was caught; and
    - iv. the carapace length of the rock lobster to which the digital tag is assigned; and
    - v. the sex of the rock lobster to which the digital tag is assigned; and

- vi. the number of hours that fishing took place; and
  - vii. the catch method used to take the rock lobster.
- (3) Sub-clause (1) does not apply to a person under the age of 18 years who is directly supervised by a person to whom sub-clause (1) applies.

**Notes**

1. Any person who complies with sub-clause (2) is subject to the catch limits for rock lobster that are set out in regulation 367 and subject to all provisions relating to the taking of rock lobsters in regulations 360-374 of the Fisheries Regulations 2019.
2. There are offences in sections 68A and 68B of the **Fisheries Act 1995** relating to taking or possessing fish of a species in excess of the catch limit specified for that species of fish in the Fisheries Regulations 2019. Various penalties apply.

**9. Application to fisheries reserves**

For the purposes of section 152(4) of the Act, this notice applies to all fisheries reserves.

**10. Revocation**

Unless sooner revoked, this Notice will be revoked on 15 November 2022.

**Plant Biosecurity Act 2010****ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION OF MATERIALS WHICH ARE HOSTS OF SPIRALLING WHITEFLY**

I, Rosa Crnov, as delegate of the Minister for Agriculture, being of the reasonable suspicion that the exotic pest spiralling whitefly exists within Australia but outside Victoria, make the following Order.

**1 Objective**

The objective of this Order is to prohibit, restrict or impose conditions upon the entry or importation into Victoria of materials which are hosts of spiralling whitefly.

**2 Authorising provision**

This Order is made under section 36(1) of the **Plant Biosecurity Act 2010** (the Act).

**3 Commencement**

This Order comes into force on the day of making.

**4 Revocation**

The Order entitled *Order prohibiting or restricting the entry or importation into Victoria of materials which are hosts of spiralling whitefly* made under section 36(1) of the **Plant Biosecurity Act 2010**, prohibiting or restricting the entry or importation of spiralling whitefly host materials into Victoria, and published in Victoria Government Gazette G45 on 12 November 2020 at pages 2301–2302 is **revoked**.

**5 Definitions**

In this Order –

‘**spiralling whitefly**’ means the exotic pest *Aleurodicus dispersus* (Russell);

**‘host material’** means any plant or plant product intended for propagation in a glasshouse, hothouse or indoor area.

## 6 Prohibitions, restrictions and conditions

The following prohibitions, restrictions and conditions are specified in relation to the entry or importation of host material.

- (a) The entry or importation into Victoria of any host material is prohibited.
- (b) Subclause (a) does not apply if the host material –
  - (i) originates from an area for which there is currently in force an area freedom certificate, being a certificate issued by an officer responsible for agriculture in the State or Territory from which the host material originated, certifying that the area from which the host material originated is known to be free of spiralling whitefly; or
  - (ii) is accompanied by a plant health certificate, assurance certificate or plant health declaration, certifying or declaring that the host material has been treated in a manner described in the Schedule to this Order; or
  - (iii) enters Victoria under and in accordance with a permit issued by an inspector and there is compliance with any conditions or requirements set out in the permit.

## 7 Verification of consignments

Where requested by an inspector, host material imported into Victoria, which is required by clause 6(b)(ii) to be accompanied by a certificate or declaration must be

- (a) presented to an inspector for inspection, or
- (b) verified by a person accredited to do so by the Department of Jobs, Precincts and Regions.

## 8 Expiry

This Order remains in force for a period of 12 months from the date of making.

### Schedule

Host material must be –

- (1) grown on a property located more than 10 km from a detection of spiralling whitefly; or
- (2) grown on property known to be free from spiralling whitefly; or
- (3) inspected and found free of spiralling whitefly; or
- (4) treated by –
  - (a) cover spraying, to the point of run off, with a mixture of a commercial wetting agent at the rate specified on the registered label of the product, and –
    - (i) 0.75 ml of a concentrate containing 400 g/l dimethoate per litre of water; or
    - (ii) 0.5 ml of a concentrate containing 80 g/l bifenthrin per litre of water; or
    - (iii) 0.4 ml of a concentrate containing 100 g/l bifenthrin per litre of water; or
  - (b) full immersion in a mixture containing 0.75 ml of concentrate containing 400 g/l dimethoate per litre of water for a minimum of 10 seconds; and
- (5) packed so as to prevent infestation by spiralling whitefly.

## NOTICE OF DECISION

## Control of Weapons Regulations 2021

I, Lisa Neville, Minister for Police, and Minister responsible for administering the **Control of Weapons Act 1994** give notice in accordance with section 12 of the **Subordinate Legislation Act 1994** of my decision to make the proposed Control of Weapons Regulations 2021 (the proposed Regulations).

The proposed Regulations prescribe –

- (a) certain articles as prohibited weapons and as controlled weapons;
- (b) certain garments or items as body armour;
- (c) categories of documents that a person may produce as evidence of identity when purchasing a prohibited weapon;
- (d) the form of record and the information to be kept in a record of every sale of a prohibited weapon;
- (e) fees to accompany an application for an approval under the Act; and
- (f) the particulars to be included in a record of a search conducted without warrant under the Act.

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Regulations, and both were released for public consultation on the Engage Victoria website ([engage.vic.gov.au](http://engage.vic.gov.au)) inviting public comments and submissions from 13 August 2021 until 16 September 2021.

A notice of preparation of the RIS in relation to the proposed Regulations was published on 13 August 2021 in the Government Gazette and in the Herald Sun, a daily newspaper circulating generally throughout Victoria.

During the period for public consultation 16 submissions were received in relation to the RIS and the proposed Regulations.

The key matters raised in the comments and submissions were –

- requests for certain articles to be excluded from the description of *sword* listed and described in item 47 of Schedule 2 to the proposed Regulations;
- requests for permits or exemptions for classes of person or classes of weapon to be inserted into the proposed Regulations.

Having ensured that all comments and submissions were considered, I have decided that the proposed Regulations should be made without further amendment.

### Victorian Managed Insurance Authority Act 1996

The insurance is to be provided at a commercial rate.
