Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES
IN MORNINGTON PENINSULA SHIRE, MOYNE SHIRE, CORANGAMITE SHIRE,
COLAC OTWAY SHIRE, AND SURFCOAST SHIRE FOR THE MAZDA NEW DAWN TVC
ON THURSDAY 11 MARCH 2021 AND FRIDAY 12 MARCH 2021

1 Purpose

The purpose of this Declaration is to exempt participants in the Mazda New Dawn TVC from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on Thursday 11 March 2021 and Friday 12 March 2021.

2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister for Roads may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

3 Commencement

This notice takes effect at 6.00 am on Thursday 11 March 2021 or when Victoria Police declare the road closed.

4 Expiry

This notice expires at 11.59 pm on Friday 12 March 2021 or when Victoria Police declare the road open.

5 Definitions

In this notice, unless the context or subject-matter otherwise requires –

- a) ‘Event’ means the Mazda New Dawn TVC, to be held on Thursday 11 March 2021 and Friday 12 March 2021; and
- b) ‘Participants’ means participants in the Event, including officers, members and authorised agents of The Producers, whose presence is reasonably required to ensure the safe conduct of the Event.

6 Declaration

I, Neil Byrne, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by the Department of Transport and the municipal council.
