ROAD DECLARATIONS AND DISCONTINUANCE

ROAD DECLARATIONS

Head, Transport for Victoria, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice revokes and declares the roads described in Schedule A and on the plans attached.

ROAD DISCONTINUANCE

Head, Transport for Victoria, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the road described in Schedule B and on the plan attached.

The effects of these Road Declarations and Road Discontinuance on road names are described in Table 1.

SCHEDULE A

ARTERIAL ROAD

- a) Those parts of Dookie – Violet Town Road identified by hatching on the plan numbered GP22198 are declared or revoked as described in the legend in the said plan.
- b) That part of Beaconsfield – Nar Nar Goon Road identified by hatching on the plan numbered GP23676 is declared as described in the legend in the said plan.
- c) Those parts of Narre Warren North Road identified by hatching on the plans numbered GP23525, GP24046, GP23524, GP24047 and GP24047A are declared as described in the legend in the said plans.

MUNICIPAL ROAD

- d) Those parts of Belgrave – Hallam Road identified by hatching on the plan numbered GP23527 are declared as described in the legend in the said plan.

SCHEDULE B

ROAD

- a) That part of road identified by cross hatching on the plan numbered GP22198 is discontinued as described in the legend in the said plan.

3. Names in Column 2 may not apply to the whole length of the road and are for general information only.


