NOTICE OF BOATING ACTIVITY EXCLUSION ZONE

I, Gareth Johnson, Acting Director Maritime Safety and delegate of the Director, Transport Safety hereby give notice under section 208(1) of the **Marine Safety Act 2010** that all persons and vessels not registered to take part in the Life Saving Victoria 2021 IRB Championship events are prohibited from entering and remaining in the following State waters.

Coastal waters adjacent to various Victorian Surf Life Saving Clubs or on coastal beaches, which will be clearly marked by signs and flags on the shore, and in the water by buoys extending up to 400 metres from shore.

The exclusion zones will be in effect between 6.30 am to 5.00 pm on the dates and locations as specified in Table 1 below.

I, Gareth Johnson, Acting Director Maritime Safety (delegate of the Director, Transport Safety), hereby advise under section 193(3)(b)(ii) of the **Marine Safety Act 2010** that the proposed waterway rule for Waranga Basin as submitted by Goulburn Murray Water on 21 April 2021 is of a material nature and that Goulburn Murray Water must comply with section 196 of the **Marine Safety Act 2010** before making a request for the making of the rule under section 194 of the **Marine Safety Act 2010**.

Section 196 of the **Marine Safety Act 2010** requires Goulburn Murray Water to invite submissions and comments in relation to the proposed requests from the public.
