ORDER UNDER SECTION 134(1)(b) DIVESTING LAND FROM A PUBLIC AUTHORITY

Order in Council

The Governor in Council under section 134(1)(b) of the **Major Transport Projects Facilitation Act 2009**, on the recommendation of the Minister for Transport Infrastructure, divests the land identified in the **Schedule**, being land in the project area of the Narre Warren Cranbourne Road Upgrade Project, from Victorian Rail Track and Melbourne Water Corporation.
