


# Control of Weapons Act 1990

# DECLARATION OF DESIGNATED AREA UNDER SECTION 10D (1)

Planned Operation in Dandenong

The Assistant Commissioner, Southern Metro Region, acting as a delegate of the Chief Commissioner of Police under section 10D (1) of the Control of Weapons Act 1990, declares as a designated area in all public places within the City of Greater Dandenong that is within the area bounded by and including South of Walker Street and George Street, Rudduck Street down to Cheltenham Road via Carroll Lane, North of Cheltenham Road to Thomas Street, through to the intersection of Walker Street as shown on the map below, but not including those roads. (Road has the same meaning as in section 3 of the Road Safety Act 1986.)



This declaration will operate on 28 September 2021 between 10.00 am and 6.00 pm during which time members of the police force are authorised to exercise the following powers:

- 1. In a public place in the designated area, without warrant, stop and search for weapons:
  - i. any person;
  - ii. any thing in the possession or control of the person;
  - iii. any vehicle with a person in or on the vehicle;
  - iv. and any thing in or on such vehicle.
- 2. Detain a person or vehicle for so long as is reasonably necessary to conduct a search.
- 3. Seize and detain any item the member reasonably suspect is a weapon, and
- 4. Request a person who is the subject of a full search to disclose his or her identity.



#### DECLARATION OF DESIGNATED AREA UNDER SECTION 10D (1)

Planned Operation in Narre Warren

The Assistant Commissioner, Southern Metro Region, acting as a delegate of the Chief Commissioner of Police under section 10D (1) of the Control of Weapons Act 1990, declares as a designated area in all public places within the City of Casey that is within the area bounded by and including the Northern side of Princes Highway, Western side of Narre Warren Road, South East of Magid Drive and South West of Monash Freeway as shown on the map below, but not including those roads. (Road has the same meaning as in section 3 of the Road Safety Act 1986.)



This declaration will operate on 27 September 2021 between 10.00 am and 6.00 pm during which time members of the police force are authorised to exercise the following powers:

- 1. In a public place in the designated area, without warrant, stop and search for weapons:
  - i. any person;
  - ii. any thing in the possession or control of the person;
  - iii. any vehicle with a person in or on the vehicle;
  - iv. and any thing in or on such vehicle.
- 2. Detain a person or vehicle for so long as is reasonably necessary to conduct a search.
- 3. Seize and detain any item the member reasonably suspect is a weapon, and
- 4. Request a person who is the subject of a full search to disclose his or her identity.



### Planned Operation in Pakenham

The Assistant Commissioner, Southern Metro Region, acting as a delegate of the Chief Commissioner of Police under section 10D (1) of the Control of Weapons Act 1990, declares as a designated area in all public places within the Cardinia Shire that is within the area bounded by and including North of Main Street, South of John Street and Henry Street, West of Slattery Place and the area intersected between Railway Avenue and Bald Hill Road as shown on the map below, but not including those roads. (Road has the same meaning as in section 3 of the Road Safety Act 1986.)



This declaration will operate on 29 September 2021 between 10.00 am and 6.00 pm during which time members of the police force are authorised to exercise the following powers:

- 1. In a public place in the designated area, without warrant, stop and search for weapons:
  - i. any person;
  - ii. any thing in the possession or control of the person;
  - iii. any vehicle with a person in or on the vehicle;
  - iv. and any thing in or on such vehicle.
- 2. Detain a person or vehicle for so long as is reasonably necessary to conduct a search.
- 3. Seize and detain any item the member reasonably suspect is a weapon, and
- 4. Request a person who is the subject of a full search to disclose his or her identity.
