DECLARATION OF DESIGNATED AREA UNDER SECTION 10D (1)

Planned Operation in Cranbourne

The Assistant Commissioner, Southern Metro Region, acting as a delegate of the Chief Commissioner of Police under section 10D (1) of the **Control of Weapons Act 1990**, declares as a designated area in all public places within the City of Casey that is within the area bounded by and including the Cranbourne Park Shopping Centre. North of Sladen Street, East of Aujla Road and Lamb Street, West of Codrington Street, South of Stawell Street and South West of High Street, including all roadways and footpaths associated with the stated road and road-related areas. (Road has the same meaning as in section 3 of the **Road Safety Act 1986**.) (refer to map below)

This declaration will operate on 26 November 2021 between 1.00 pm and 9.00 pm during which time members of the police force are authorised to exercise the following powers:

1. in a public place in the designated area, without warrant, stop and search for weapons:
 - i. any person;
 - ii. any thing in the possession or control of the person;
 - iii. any vehicle with a person in or on the vehicle;
 - iv. and any thing in or on such vehicle;
2. detain a person or vehicle for so long as is reasonably necessary to conduct a search;
3. seize and detain any item the member reasonably suspect is a weapon; and
4. request a person who is the subject of a full search to disclose his or her identity.

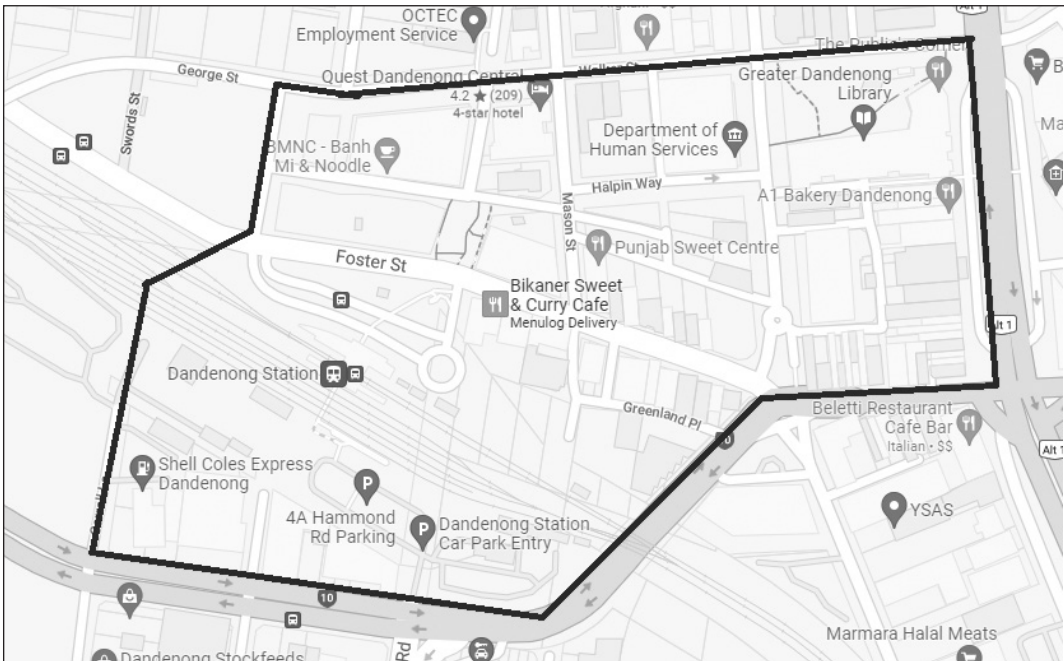

The Assistant Commissioner, Southern Metro Region, acting as a delegate of the Chief Commissioner of Police under section 10D (1) of the **Control of Weapons Act 1990**, declares as a designated area in all public places within the City of Greater Dandenong that is within the area bounded by and including South of Walker Street and George Street, North of Cheltenham Road and Foster Street, East of Rudduck Street and Carroll Lane and West of Lonsdale Street as shown on the map below, but not including those roads. (Road has the same meaning as in section 3 of the **Road Safety Act 1986**.)

This declaration will operate on 25 November 2021 between 1.00 pm and 9.00 pm during which time members of the police force are authorised to exercise the following powers:

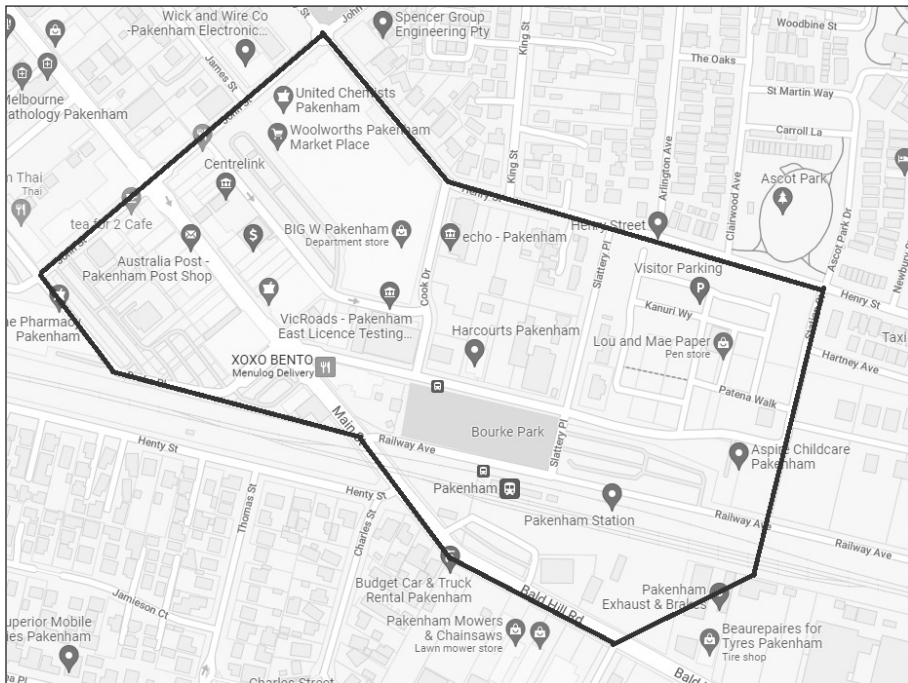
