ADVICE IN RELATION TO A NOTICE OF INTENTION TO REQUEST A WATERWAY RULE

I, Shaun Rodenburg, Director Maritime Safety (delegate of the Director, Transport Safety), hereby advise under section 193(3)(b)(ii) of the **Marine Safety Act 2010** that the proposed waterway rule for the Yarra River upstream of port waters of the Port of Melbourne, in relation to the allocation of moorings and berths for South Wharf Landing, as submitted by Parks Victoria on 12 November 2021 is of a material nature and that Parks Victoria has been granted an exemption from complying with section 196 of the **Marine Safety Act 2010** before making a request for the making of the rule under section 194 of the **Marine Safety Act 2010**.

Section 196 of the **Marine Safety Act 2010** requires Parks Victoria to invite submissions and comments in relation to the proposed requests from the public. An exemption has been provided under section 260(1)(c) as compliance would, in the particular circumstances, be impracticable, unnecessary, or inappropriate.
