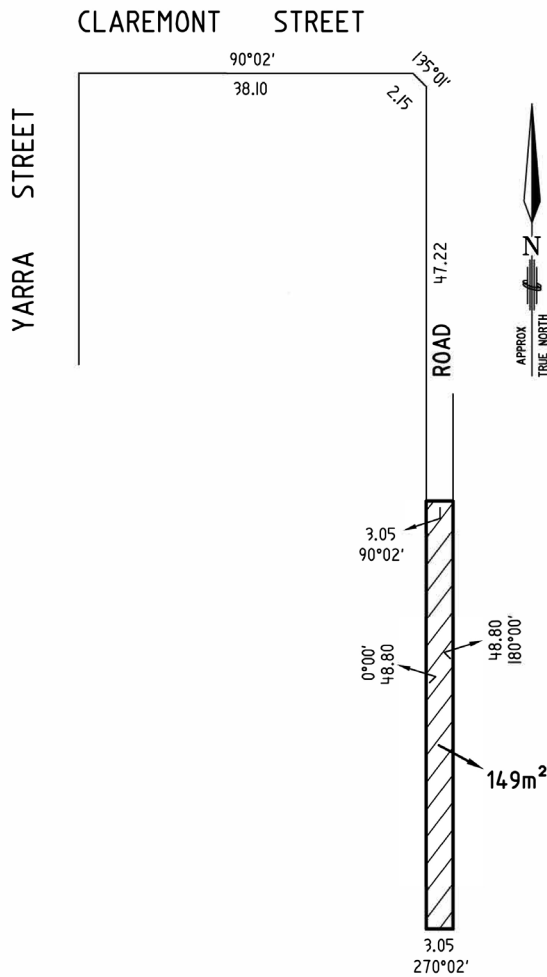

HUMAN RIGHTS LIST EXEMPTION

Application No. H220/2021

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Fernwood Womens Health Clubs (Australia) Pty Ltd (the Applicant). The application for exemption is to enable the Applicant to offer employment to female applicants only, offer health and fitness services to females only, and to advertise those services and employment positions to females only; to allow the Applicant to provide health and fitness services in an all-female environment. (the exempt conduct).

I have taken into consideration the material filed in support of this application, including a written statement from Diana Williams, Founder and Manager Director, two witness statements by Donna Hudec, Chief Financial Officer, and the oral evidence of Donna Hudec, provided at the directions hearings and the hearing on 25 March 2022, as well as the written submission provided in support of the application.

I have also taken into consideration the oral evidence from Susan Kerr provided during the hearing. Susan Kerr attended the hearing as an interested person and a member of the LGBTQIA+ community and a member of Fernwood. Susan Kerr noted the special exercise programs run by Fernwood centres attract extra cost, and raised concerns about accepting the assumption that victim survivors of sexual abuse feel safer in a female-only environment. Susan Kerr also questioned how the Applicant treats transgender females, and the practice of employing male workers to undertake repairs in centres. Susan Kerr stated they had been discriminated against in one centre prompting their move to another gym. Susan Kerr also raised concerns about the binary approach used by the Applicant in relation to gender and gender pronouns.

On the evidence before me, I am satisfied that it is appropriate to grant an exemption from sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption, I have noted:

- A copy of the application was sent by the Tribunal to the Victorian Equal Opportunity and Human Rights Commission (the Commission). The Commission did not seek leave to intervene in the proceeding.
- The Applicant was established in 1989 to provide a specialist service of an all-female environment to promote health and wellness through a variety of programs specific to females to enhance self-esteem, self-confidence and general health of all females regardless of age, backgrounds, and fitness levels. The Applicant seeks to nurture an all-female environment to make women and girls feel at ease in a non-threatening secure feminine environment that is different from traditional mixed-sex fitness centres.
- Some females are unable to, or would not choose to, exercise in the presence of males for a variety of reasons. The reasons may be religious such as Muslim women wishing to respect their cultural and religious laws, or psychological such as some females who have been subjected to sexual assault or physical or domestic violence by males. The reasons may also relate to body image and self-confidence.
- Some members attending Fernwood centres have reported feeling safer, less vulnerable and more confident than if they attended a mixed-sex facility or exercise in the presence of males in a mixed-sex fitness centre.
- Fernwood centres offer specialised exercise programs designed particularly for females, such as a pelvic floor exercises to reduce incontinence after childbirth, exercises designed to relieve the symptoms of menopause, and exercises relating to surgery such as breast cancer surgery.
- Fernwood centres hold regular educational seminars specific to females aimed at promoting the wellbeing of women and girls. Topics of such seminars include menopause, the effects of osteoporosis, early detection of breast cancer, physical improvement for women and other female health related issues. The all-female environment provides a forum for women and girls to feel safe and to ask questions they may not otherwise ask male health practitioners.
- The Australian health and fitness market, including in Victoria, has a large number and variety of mixed-sex fitness centres readily available to both males and females. There are 26 Fernwood Centres in Victoria with approximately 870 staff and contractors.
- The Applicant was granted an exemption in respect to similar conduct in Victoria in 1998 and in 2005. The Applicant has also been granted exemptions for similar conduct in South Australia and in Queensland in 2021.
- Given the Applicant's purpose to provide an environment that promotes the health and wellness of females who are unable to, or would not choose to, exercise in the presence of males, and its specialised programs and seminars, I am satisfied the services offered by the Applicant can most effectively be provided in an all-female environment by an organisation that employs and provides services to females only.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (the Charter). I have considered all the relevant factors including the nature of the right, the importance of the purpose of the limitation, the nature and extent of the limitation, and the relationship between the limitation and its purpose, and

any less restrictive means reasonably available to achieve the purpose the limitation seeks to achieve.

- This exemption limits the right to equality and in particular the right to equal and effective protection against discrimination on the basis of sex.
- I accept the reasons provided in support of the application in relation to the importance of providing an all-female environment to promote the health and wellness, self-esteem and self-confidence of females who would not otherwise access fitness and health centres.
- I accept the exemption would allow the Applicant to discriminate on the basis of sex in relation to offering employment, health and fitness services, providing an all-female environment, and to advertise such.
- I note the exemption is limited and does not permit discrimination on the basis of other protected attributes such as gender or sexual orientation.
- I also accept the exempt conduct would not prevent any prospective employees or members from working at or attending a mixed-sex health and fitness centre. I accept the evidence provided in relation to the extent of the industry in Victoria.
- I am satisfied the exempt conduct is specific and focused to ensure the Applicant can achieve its purpose.
- I also accept that given the nature of the purpose and exempt conduct, there is no less restrictive means for the Applicant to achieve its purpose.
- While I have taken the concerns raised during the hearing into consideration, I am satisfied that in all the circumstances, the limits imposed by this exemption on the right to equality are reasonable and justified under the Charter.

CONCLUSION

- Based on the evidence and considerations noted above, I am satisfied in all the relevant circumstances of the case, that it is appropriate to grant the exemption.
- I am also satisfied that the exemption should be granted for the period of five years.

The Tribunal hereby grants an exemption from the operation of sections 16, 44, 107 and 182 of the Act to enable the Applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 7 April 2027.

EXEMPTION

Application No. H7/2022

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Student Youth Network Inc (SYN Media) (the Applicant). The application for exemption is to enable the applicant to preference the recruitment of job applicants and volunteers to people under 26 years of age, offer and provide volunteering opportunities and services to people under 26 years of age, request information about the age of job applicants and volunteers, and advertise employment, volunteer opportunities and other services for people under 26 years of age (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Evrim Sen, General Manager, and the oral evidence of Evrim Sen and Anita Das, Board Member, provided at the directions hearing on 18 March 2022, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 44, 107 and 182 of the Act to enable the Applicant to engage in the exempt conduct.

In granting this exemption, the Tribunal noted:

- The Applicant was incorporated in 2000 and began full time radio broadcasting in 2003. It holds a community broadcasting licence. The Applicant's operations include SYN Radio, Podcasts, SYN TV and Screen Department, SYN Online, Syn Media Learning and SYN Production Services. Its intended audience is young people, people aged 26 years and under. The Applicant employs 18 staff and supports over 350 volunteers to produce all its radio, TV and online media content.

- The Applicant is a not-for-profit media organisation run by a community of young people that provides broadcasting and training opportunities for young Australians. Its aspiration is to empower young people through media making. It believes young people should be creators not just consumers of media.
- The Applicant derives its revenue from grants and self-generated revenue through its SYN Media Learning. Most of its funding specifies funds will be spent on projects related to young people. Syn Media Learning works with more than 100 secondary schools offering training through innovative peer-to-peer programs and works with approximately 4,000 young people per year.
- The Applicant was granted a previous exemption for similar conduct in 2012. That exemption has now expired. No exception or exemption under the Act applies. In the absence of an exemption, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). I have considered the nature of the right, the importance of the purpose of the limitation, the nature and extent of the limitation, and the relationship between the limitation and its purpose, and any less restrictive means reasonably available to achieve the purpose the limitation seeks to achieve.
- I accept the exempt conduct limits the right to equality and in particular the right to equal and effective protection against discrimination of persons aged 26 years and over who may wish to be employed or volunteer with the Applicant. This exemption will allow discrimination on the basis age. The reasons provided in support of the exemption note the underrepresentation of young people in mainstream media, and the barriers young people face in gaining experience and employment with traditional media organisations.
- The Applicant submitted a report which indicated young people make up only a fraction of coverage in traditional media content, featuring less than 3.3 per cent in articles. Young people are rarely quoted in news articles, and many media outlets use stereotypes in their coverage of young people.¹
- The Tribunal has granted an exemption for similar conduct in the past, and I accept the submissions in relation to the importance of the opportunities and experience the Applicant offers young people. While I note the exemption will allow the Applicant to discriminate on the basis of age, the exemption will not exclude potential applicants from seeking volunteer and employment opportunities from other media organisations. I am satisfied the exempt conduct is specific and focused on its purpose, and that less restrictive means are not reasonably available.
- I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 44, 107 and 182 of the Act to enable the Applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 7 April 2027.

The general health service provider named above must display a copy of this Interim Prohibition Order prominently at any premises where he provides any general health service and must ensure it is easily visible to the public until such time as the Interim Prohibition Order expires or is revoked. 3. The general health service provider named above must prominently publish a copy of this Interim Prohibition Order, in a manner that is easily visible to the public, on the homepage of any website or social media platform he uses to offer or promote any general health services.

In this Interim Prohibition Order 'general health service' and 'general health service provider' have the same meaning as in section 3 of the **Health Complaints Act 2016**.

This Interim Prohibition Order takes effect on the service of the order on the general health service provider to whom it applies.

VICTORIAN REGISTRATION AND QUALIFICATIONS AUTHORITY****SCHEDULE TO THE ORDER IN COUNCIL****1. Appointment Arrangements**

The appointments are on a part-time basis.

2. Period of Appointment

Ms Pamela Dawn White PSM is appointed as Chair and Mr James Gilbert Carvel Williamson is appointed as a member of the Victorian Registration and Qualifications Authority (VRQA) from 4 May 2022 to 3 May 2025 (both dates inclusive).

3. Duties and responsibilities of the position

The VRQA was established to provide regulation which ensures quality education and training is delivered by the providers it registers in Victoria, and to promote informed choice regarding the education and training decisions of Victorians. The VRQA is also responsible for the regulation of apprenticeships and traineeships in Victoria.

4. Termination Arrangements

Under section 4.2.4(3) of the **Education and Training Reform Act 2006** (the Act), an appointed member may resign from office by delivering to the Governor in Council a signed letter of resignation. Under section 4.2.4(4) of the Act, the Governor in Council may at any time remove an appointed member from office.

5. Payment Provisions

Under Schedule 2, section 3(1) of the Act, a member of the Authority, other than one who holds a full-time Government office, or a full-time position in the public service, teaching service, or with another statutory authority (other than a university), is entitled to receive the

remuneration and fees that are fixed in the member's instrument of appointment or are fixed from time to time by the Governor in Council for that member.

Consistent with the Premier's approved annual adjustment guideline rate of 1.5% for the 2021–22 financial year and a further 1.5% for the financial year 2022–23, the Chair is entitled to be remunerated at the rate of \$41,316 until 30 June 2022, and \$41,936 per annum from 1 July 2022. Members are entitled to be remunerated at the rate of \$16,226 until 30 June 2022, and \$16,469 per annum from 1 July 2022. In addition, in recognition for additional committee work, payments of \$5,078 per annum for the 2021–22 financial year and \$5,154 per annum from 1 July 2022 are made to the VRQA Chair and members at the end of each financial year.

6. Superannuation Obligations

Superannuation will be paid in accordance with the **Superannuation Guarantee (Administration) Act 1992**.

7. Travel and Personal Expenses arrangements

Under Schedule 2, section 3(2) of the Act, each member or acting member of the Authority is entitled to receive the personal and travelling expenses that are fixed in the member's instrument of appointment or are fixed from time to time by the Governor in Council for that member. Reasonable travel and personal expenses will be paid in accordance with normal public service practice and policy.

8. Leave Arrangements

There are no leave arrangements for this part-time statutory position.
