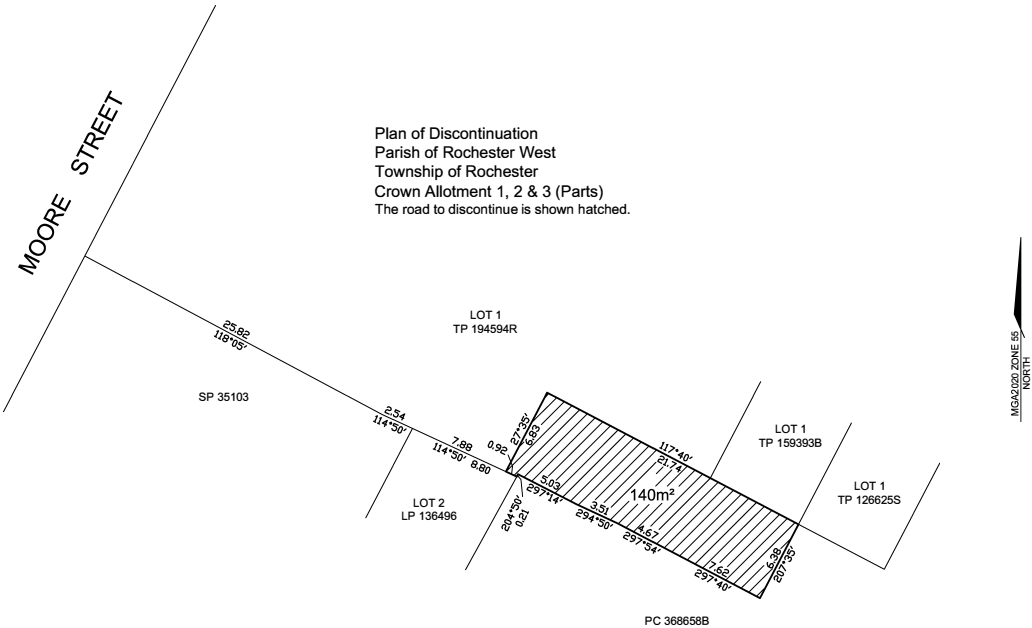

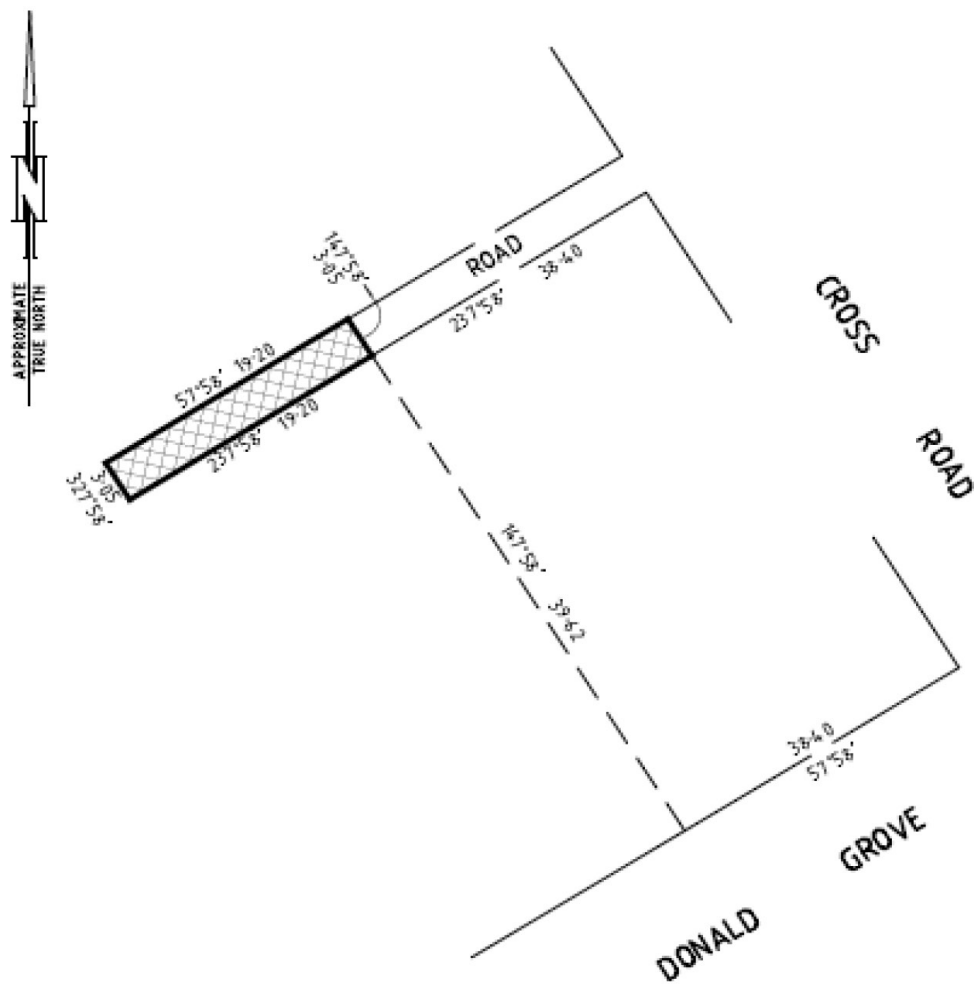

EXEMPTION

Application No. H112/2022

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Kara House Inc (the applicant). The applicant amended its initial application and now seeks an exemption to enable it to accommodate women and those who identify as women and children only, and to employ women and those who identify as women only (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Veronica Patricia Coleman, Manager of Kara Family Violence Service, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption, the Tribunal noted:

- The applicant, known as Kara Family Violence Service, provides specialist family violence support to women and those who identify as women, and children who are experiencing family violence.
- The applicant is funded by the Department of Families, Fairness and Housing to provide safe, short-term crisis accommodation in refuge to women and those who identify as

women, and children who have been forced to leave their homes due to their experience of family violence, primarily perpetrated by male intimate partners or family members.

- As a result of the recommendations of the 2015 Royal Commission into Family Violence, the applicant is currently transitioning from a communal house to a core and cluster development that will house multiple women and children on site. The development includes a staff office and meeting and activity rooms for conducting therapeutic programs.
- The women and children assisted by the applicant come from diverse cultural and linguistic backgrounds and have experienced physical, emotional, sexual and psychological abuse and control from primarily male perpetrators. This leaves many fearful and distrusting of males.
- The applicant considers family violence support is specialised and requires a particular understanding of the experience of women and children who have been abused primarily by males. In order to deliver its services effectively and sensitively, the applicant believes it should only employ women and those who identify as women.
- The applicant has been granted exemptions for similar conduct in 2009, 2012 and 2017. The most recent exemption expired on 26 April 2022.
- The Victorian Equal Opportunity and Human Rights Commission was informed of this application and has notified the Tribunal it will not seek to intervene.
- At present, the applicant has 15 staff. Some staff members work directly with clients providing counselling and support services. All staff will be located at the core and cluster development, which will accommodate staff and clients on the one site. While some administrative positions are not expected to deliver direct client program services, all staff have some degree of client contact and all staff are expected to answer telephones and doors to clients.
- On the evidence before me, I am satisfied that the services provided by the applicant are special needs services under section 88 of the Act, as they meet the special needs of its clients and their children. To the extent that accommodation is provided, I am also

satisfied that the exception contained in section 60 of the Act applies.

- I am also satisfied that the exception contained in section 28 of the Act applies to the staff positions who provide direct client services. That is because the direct client services are special services under section 88, and because I am satisfied that the direct client services can be most effectively provided by staff who are women and those who identify as women.
- I am not satisfied that all the staff positions, specifically the finance and administrative positions would come under section 28 of the Act. Therefore, in the absence of an exemption, the exempt conduct would amount to prohibited discrimination.
- I have considered the size of the applicant's organisation, its built environment where all staff and clients mix, and the expectation that all staff will have some contact with clients. I also note the vulnerability and special needs of the applicant's client group. On the evidence before me, I am satisfied that the services offered by the applicant can most effectively be provided by an organisation that employs women and those who identify as women only.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (the Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of males who wish to be employed by the applicant. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 19 May 2027.

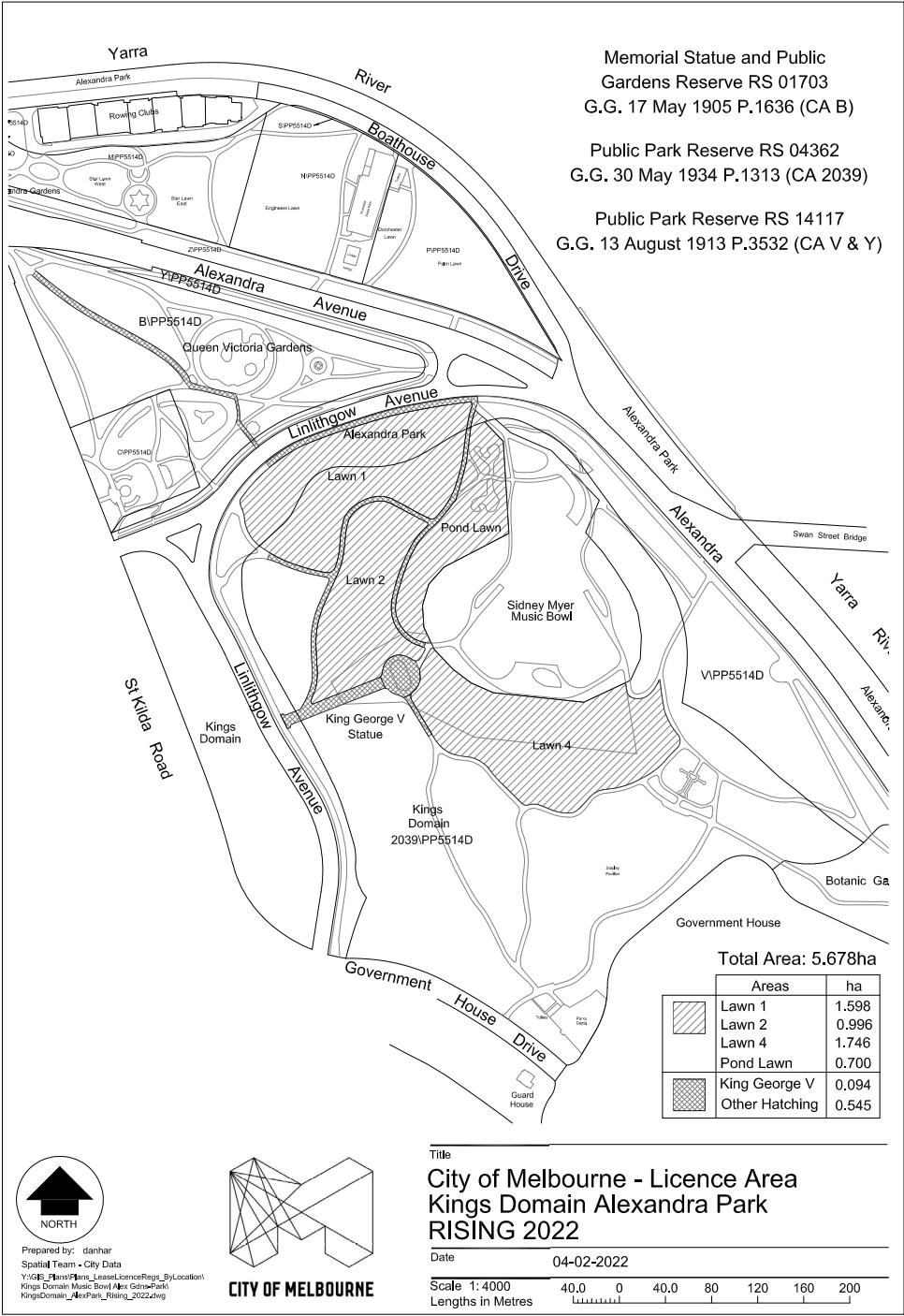

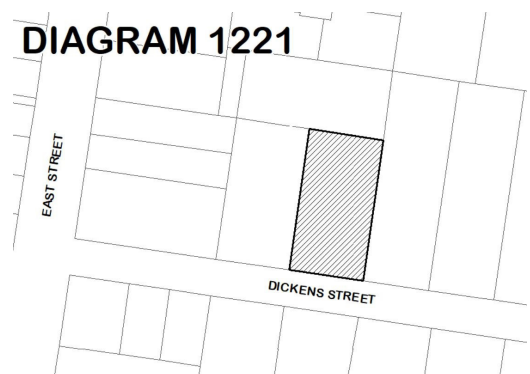

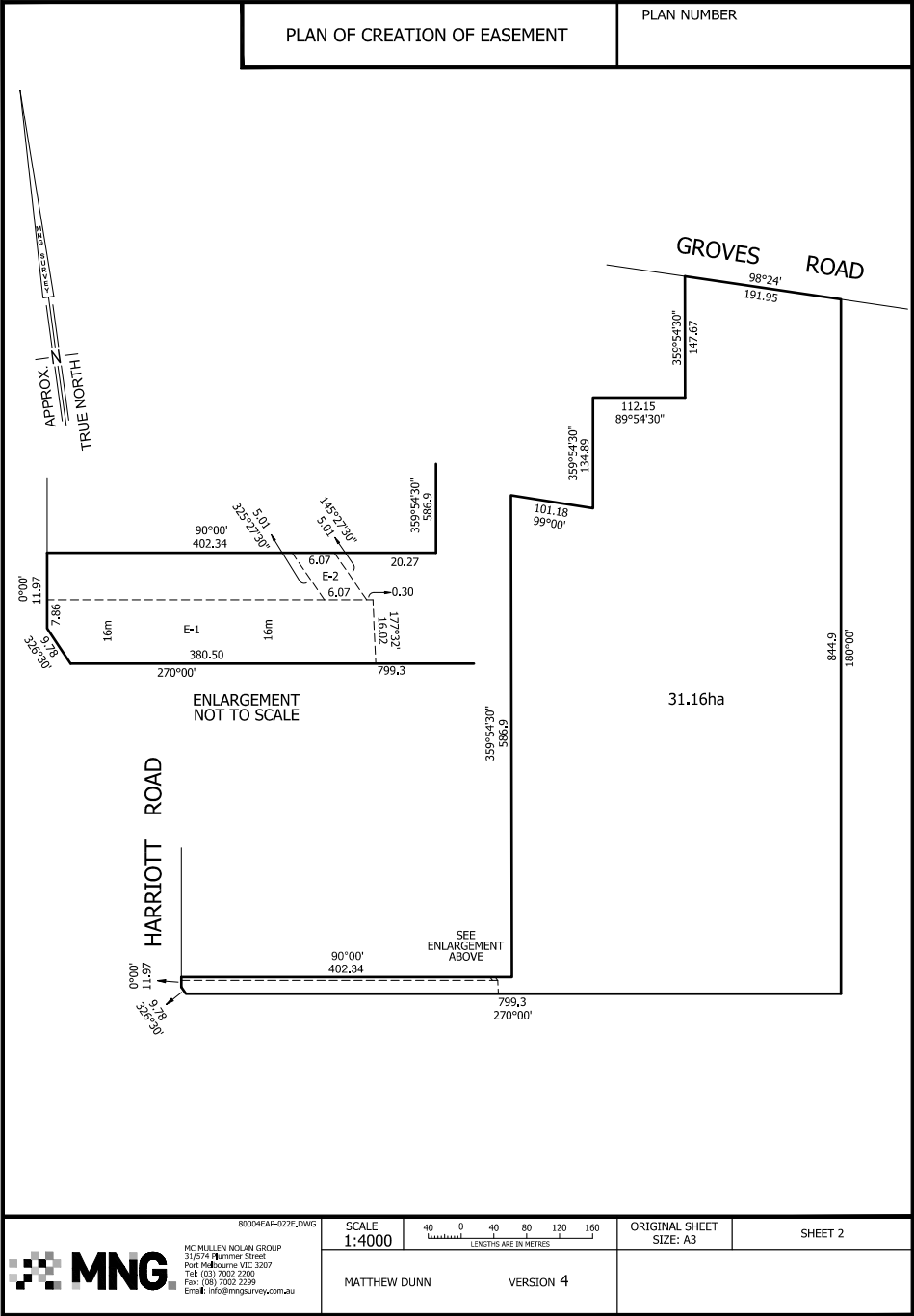

MINISTERIAL GUIDELINES CLAIM FOR COMPENSATION

I, Ingrid Stitt MP, Minister for Workplace Safety pursuant to sections 20(6), 23 and 74(1) of the **Workplace Injury Rehabilitation and Compensation Act 2013**, revoke the ‘Ministerial Guideline 2016 Claim for Compensation’, Victoria Government Gazette, No. G16, 21 April 2016, 787, and hereby issue the following guidelines with respect to:

- (1) service by a worker of a claim for compensation, claim for compensation in the form of weekly payments and claim for compensation in the form of medical and like services on an employer or self-insurer;
- (2) lodgement by a worker pursuant to section 29 or 31(4) of the **Workplace Injury Rehabilitation and Compensation Act 2013** of a claim for compensation, claim for compensation in the form of weekly payments and claim for compensation in the form of medical and like services on the Victorian WorkCover Authority; and
- (3) the forwarding of claims by employers to the Victorian WorkCover Authority.

1. Citation

These guidelines may be cited as the Claim for Compensation Ministerial Guidelines 2022.

2. Purpose

The purpose of these guidelines is to set out the methods by which:

- (1) a worker can give or serve a claim for compensation, claim for compensation in the form of weekly payments or claim for compensation in the form of medical and like services pursuant to section 20 of the **Workplace Injury Rehabilitation and Compensation Act 2013** to or on an employer or self-insurer, or lodge such claims on the Victorian WorkCover Authority pursuant to section 29 of the **Workplace Injury Rehabilitation and Compensation Act 2013**; and
- (2) an employer may forward to the Victorian WorkCover Authority a claim for compensation, claim for compensation in the form of weekly payments or claim for compensation in the form of medical and like services that the employer has received from a worker.

3. Authority

These guidelines are issued pursuant to sections 23 and 74 of the **Workplace Injury Rehabilitation and Compensation Act 2013**.

4. Commencement and Application

These guidelines come into operation on the day after it is published in the Government Gazette and apply to all claims for compensation, claims for compensation in the form of weekly payments and claims for compensation in the form of medical and like services made on or after this date.

5. Definitions

Unless the context otherwise requires, or the contrary intention appears, terms defined in the Act have the same meaning.

In these guidelines:

‘the Act’ means the **Workplace Injury Rehabilitation and Compensation Act 2013**; ‘the Authority’ means the Victorian WorkCover Authority;

‘claim’ for the purposes of these Ministerial Guidelines means a claim for compensation, claim for compensation in the form of weekly payments or claim for compensation in the form of medical and like services under section 20;

‘company’ means a company incorporated, or taken to be incorporated, under the **Corporations Act 2001** (Cth);

‘consent’ includes consent that can be reasonably inferred from the conduct of the person concerned, but does not include consent given subject to conditions unless the conditions are complied with;

‘place of business’, in relation to an employer, self-insurer or the Victorian WorkCover Authority, means a place of a non-transitory nature where any operations or business activities are carried out by that employer, self-insurer or the Victorian WorkCover Authority;

‘registered body’ has the same meaning as it has in section 9 of the **Corporations Act 2001** (Cth).

6. Making a claim

- (1) A claim may be given or served upon an employer or self-insurer in accordance with section 20 of the Act by any of the following methods:
 - (i) If the employer or self-insurer is a company or registered body:
 - the worker posts the claim to the registered office or a place of business of the employer or self-insurer; or
 - the worker delivers the claim personally at the registered office or a place of business of the employer or self-insurer, to a person apparently above the age of 16 years who is apparently in charge of that business or is duly authorised to represent the employer and to receive the claim on behalf of the employer or self-insurer.
 - (ii) If the employer is a natural person:
 - the worker delivers the claim personally to the employer, or leaves the claim in the presence of the employer; or
 - the worker posts the claim to the employer’s current or last known place of business or residence.
 - (iii) If the employer is a body corporate that is not a company or registered body, or is another form of business structure including a firm or partnership:
 - the worker posts the claim to the employer’s current or last known place of business; or
 - the worker delivers the claim personally at the employer’s registered office or place of business to a person apparently above the age of 16 years who is apparently in charge of that business or is duly authorised to represent the employer and to receive the claim on behalf of the employer; or
 - (iv) The worker transmits the claim by facsimile to any of the addresses referred to in (i) to (iii) above, where applicable; or
 - (v) The worker transmits the claim by way of email, so long as at the time the claim was transmitted by email:
 - i) it was reasonable to expect that the claim would be readily accessible so as to be usable for subsequent reference, and
 - ii) the employer or self-insurer consents to the information being given by means of an email; or
 - (vi) The worker transmits the claim through any method of electronic communication, including a designated online portal, as specified and approved by the Authority from time to time, and in accordance with guidelines as published on the Authority’s website.

- (2) A claim may be lodged upon the Authority in accordance with sections 29 or 31(4) of the Act by any of the following methods:
- (i) sending the claim by post to the registered office or other office or place of business of the Authority, or to the registered office, other office or place of business of the Authority's authorised agent who manages the worker's employer's WorkCover insurance; or
 - (ii) serving the claim by facsimile to the registered office or other office or place of business of the Authority, or to the registered office, other office or place of business of the Authority's authorised agent who manages the worker's employer's WorkCover insurance; or
 - (iii) submitting the claim to the Authority or authorised agent through any method of electronic communication, including a designated online portal, as specified and approved by the Authority from time to time, and in accordance with guidelines as published on the Authority's website.

7. Forwarding of a claim by an employer

- (1) An employer may comply with their responsibilities to forward a claim to the Authority pursuant to section 73 of the Act, by:
- (i) sending the claim by post to the registered office, other office or place of business of the Authority's authorised agent who manages the employer's WorkCover insurance, or to such other address as agreed between the employer and the authorised agent; or
 - (ii) transmitting the claim by facsimile to the registered office, other office or place of business of the Authority's authorised agent who manages the employer's WorkCover insurance, or to such other address as agreed between the employer and the authorised agent; or
 - (iii) submitting a claim through any method of electronic communication, including by email or a designated online portal, as specified and approved by the Authority from time to time, and in accordance with guidelines as published on the Authority's website.

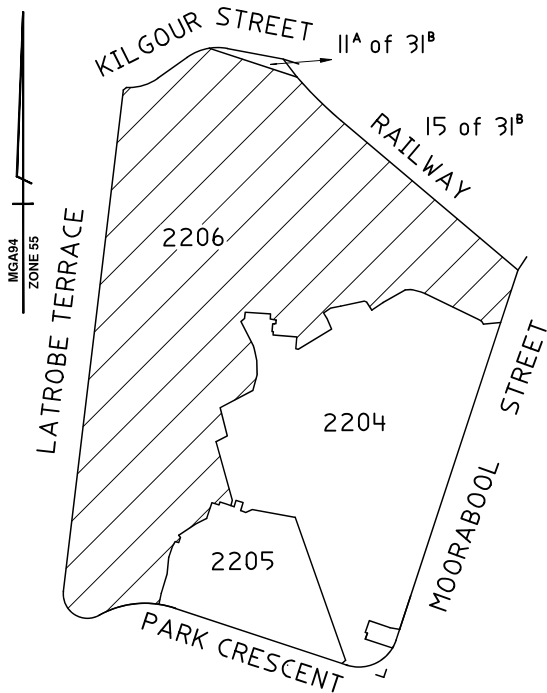
