



EXEMPTION

Application No. H294/2022

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Women's Health East Inc (the applicant). The application for exemption is to enable the applicant to:

- advertise for and employ only persons who identify as women (referred to as 'women');
- restrict individual membership of Women's Health East to women only;
- advertise for and employ women of a specified race or ethnic origin, or whose first language is a specified language other than English, to work on specific projects targeted at groups of women of that race or ethnic origin or whose first language is that language; (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Elly Taylor, Chief Executive Officer, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption, the Tribunal noted:

- The applicant is a community-based health promotion organisation, and one of 12 specialist women's health services funded through the Victorian Government Women's Health Program. The organisation works in partnership with other health and community agencies in the eastern metropolitan region of Melbourne to address health inequities and disadvantage experienced by women.
- Working within a feminist framework, the applicant advocates on behalf of women within the health system. The applicant delivers health education and training on women's health issues and gender equity, and promotes

access to appropriate services for women, with the aim of achieving better health, safety and wellbeing outcomes for women.

- The applicant has a responsibility to represent women in their region and considers the most credible and effective representatives of women's health needs and women's perspectives are women themselves, provided through an organisation run by and for women, with specialist knowledge of health inequalities and disadvantage and barriers experienced by women.
- Current programs and activities include Together with Equality and Respect: A strategy to prevent violence against women in Melbourne East; Sexual and Reproductive Health Strategic Reference Group; Gender Equity/Equality Training; Bi-cultural Health Programs; and public and professional seminars and training forums to further knowledge and strategies for addressing violence against women, women's sexual and reproductive health, gender equality, and other health and wellbeing issues affecting women.
- The applicant employs a total of 23 women. As a small organisation, all staff, including administrative and finance officers, are required to play an active and visible role in community events and campaigns which are focused on women's health and women's rights issues. All staff are required to share reception duties and all staff work as a team contributing across all areas of activity within the office environment. Women who contact the applicant often do so in circumstances where they are seeking support and referral in respect of sensitive matters. Women contact the applicant because they know they will feel safe and respected and able to seek advice and disclose deeply personal matters to someone they feel is more likely to understand their situation. They expect to be assisted by women given they are contacting a women's health organisation. Having women in all employment roles in the organisation enables flexibility while maintaining the integrity of the organisation as a women's health service, run by women for women.
- Individual membership of the applicant organisation is limited to women. Membership benefits and services include

eligibility for election to the Board of Governance, eligibility to vote in general and annual meetings of the association; invitations to special events; opportunities to contribute to the applicant's advocacy and influence via social media; participation in consultations regarding women's health issues; and opportunities to influence public policy and achieve improved health outcomes for women.

- From time to time, the applicant also develops programs to be undertaken with and for groups of women from particular cultural backgrounds and/or non-English speaking backgrounds. The success of those programs depends on having project staff from the same cultural backgrounds and language groups, wherever possible. Currently the applicant employs a group of bi-cultural workers from the Chinese and Hakha Chin communities to deliver in-language health programs within their communities.
- The Victorian Equal Opportunity and Human Rights Commission was notified of the application and has indicated it does not seek leave to intervene.
- On the evidence. I am satisfied that some of the services provided by the applicant which are designed to meet the special needs of women are special needs services under section 88 of the Act. I am also satisfied that the exception contained in section 28 of the Act applies in relation to the employment positions that deliver those special needs services. That is because I am satisfied that those services designed to meet the special needs of women, can be provided most effectively by women. However, I am not satisfied that all the services and activities undertaken by the applicant, including some of the research, policy and training activities which are provided to a broad audience including people who do not identify as women, can be provided most effectively by women. Accordingly, the section 28 exception does not apply to all employment positions within the applicant organisation.
- The applicant was granted an exemption in similar terms in 2006, 2009, 2012 and 2017. In the absence of a further exemption, the exempt conduct would amount to prohibited discrimination.

- Given the size of the organisation, the special needs of some of its clients, and the flexible requirements of all its staff in relation to roles and client services and interactions, I accept the applicant's submissions that it is preferable that only women work in the organisation, and that its membership benefits and services be limited to women only. I also accept the applicant's submissions that, where the projects targeted at specific races or ethnic origins or specified language groups which do not come within section 88 or 12 exemptions due to their broader audience or training aims, it is still appropriate for those programs to be staffed by women of the specified race or ethnic origin or language group.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (the Charter). I have considered the nature of the right, the importance of the purpose of the limitation, the nature and extent of the limitation, and the relationship between the limitation and its purpose, and any less restrictive means reasonably available to achieve the purpose the limitation seeks to achieve.
- This exemption limits the right to equality and, in particular, the right to equal and effective protection against discrimination of people who do not identify as women, or people who do not identify as women from a particular race or ethnic origin, who wish to be employed by the applicant, or who would wish to receive membership benefits and services. I accept the importance of providing a safe, respectful and flexible environment where women seeking advice feel able to disclose deeply personal matters. I accept the applicant's clients expect to be assisted by women when contacting a women's health organisation, and that having women in all employment roles, and as members of the organisation, enables flexibility while maintaining the integrity of the organisation as a women's health service, run by women for women, in order to achieve better health, safety and wellbeing outcomes for women. I consider the exempt conduct is focused and directed to deliver this, and I accept there is no less restrictive means reasonably

available to the applicant to achieve this. I note the exemption will not adversely affect anyone seeking employment or membership services from other organisations. On the evidence before me, I am satisfied that the limit imposed by this exemption is reasonable and justified under the Charter.

• I am satisfied that, taking into account all relevant factors, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 6 October 2027.

INTERIM EXEMPTION

Application No. H319/2022

The Victorian Civil and Administrative Tribunal is considering an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Women's Health in the North Inc. (the applicant). The applicant was previously granted an exemption on 21 September 2017. That exemption expired on 27 September 2022. That exemption enabled the applicant to:

- employ only females and people whose gender identity is female (referred to as 'women') to work in the applicant organisation;
- employ only women of a specified race or ethnic origin, or whose first language is a specified language other than English, to work in the applicant organisation on specific projects targeted at groups of women of that race or ethnic origin or whose first language is that language;
- from time to time, provide services, including membership services, to women only; and
- advertise those matters. (the interim exempt conduct).

The applicant has requested the Tribunal grant an interim exemption to enable the applicant to continue to undertake the conduct noted above while the current exemption application is considered and concluded.

Upon reading the material filed in support of this application, including the affidavit of Susan Rosenhain, acting CEO, the Tribunal is satisfied that it is appropriate to grant an interim exemption from sections 16, 18, 107 and 182 of the Act to enable the applicant to continue to engage in the interim exempt conduct while the current application is determined.

In granting this interim exemption, the Tribunal notes:

- The applicant is a women's health service for the Northern Metropolitan region of Melbourne. Its mission is to eliminate gender inequalities and improve the health, safety and wellbeing of women and gender diverse people.
- The applicant provides services including community and professional education, research and assessments, dissemination of information and advocacy. The applicant provides programs which engage with specific needs in the community. The applicant's priorities include programs addressing gendered violence prevention, family violence, sexual reproductive health, gender equity, health and wellbeing.
- The applicant was granted an exemption for similar conduct in 2009, 2012 and 2017.
- While I am satisfied that some of the services provided by the applicant are special needs services under section 88 of the Act, and the exception contained in section 28 of the Act applies in relation to staff positions tasked with the delivery of those special needs services, I am not satisfied that these exemptions apply to all activities and employment positions within the applicant's organisation. In the absence of an interim exemption, aspects of the interim exempt conduct would amount to prohibited discrimination. Nevertheless, given the previous exemptions granted to the applicant, the special needs services it provides, and the size and structure of the applicant organisation, I am satisfied that it is appropriate to allow the applicant to continue to operate as it has been under the most recent exemption while the current exemption application is processed.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set

out in the **Charter of Human Rights and Responsibilities Act 2006** (the Charter). This interim exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of people who do not identify as women, or people who do not identify as women from a particular race or ethnic origin, who wish to

be employed by the applicant, or who would wish to receive membership. I am satisfied that, in the circumstances discussed above, the limit imposed by this interim exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an interim exemption from the operation of sections 16, 18, 107 and 182 of the Act to enable the applicant to engage in the interim exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 23 November 2022.

Ongoing Protection Declaration for the purposes of the Aboriginal Heritage Act 2006

SECTION 1 - Identification of Aboriginal place or object

I Gabrielle Williams, Minister for Treaty and First Peoples, pursuant to section 103(1) of the **Aboriginal Heritage Act 2006** ('the Act') am satisfied that:

Ghow Swamp Aboriginal Place located at MDA/GDA94 256165.063 Easting 6014537.914 Northing, Parish of Patho, County of Gunbower, taking in Kow Swamp water reserve specifically the majority of Crown land Allotment 18 A and also includes other Crown and freehold land encompassing an area of 3177 hectares, and shown on the attached map, Gazettal Plan 3507 (refer to Plan No. LEGL./22-122 lodged in the Central Plan office for dimensions of the land)

- is an Aboriginal place; and
- it is appropriate having regard to the importance of maintaining the relationship between Aboriginal people and the place, that an ongoing protection declaration be made in relation to this Aboriginal place.

This Aboriginal place is recorded on the Victorian Aboriginal Heritage Register as Ghow Swamp Aboriginal Place (VAHR 7726-0534). Yorta Yorta Nation Aboriginal Corporation ICN 3279 is the Registered Aboriginal Party (RAP) for the majority of the Aboriginal place. A minority of the Aboriginal place falls within an area for which no RAP has been appointed at this time.

SECTION 2 - Protective measures to be taken

The following measures are required to be taken to protect Ghow Swamp Aboriginal Place, the subject of this declaration:

- 1. Construction or upgrade of infrastructure, ancillary services or works associated with the use of Ghow Swamp by the responsible water corporation as a water storage facility is prohibited within Ghow Swamp Aboriginal Place outside the footprint (at the date of this declaration) of existing water storage related infrastructure, ancillary services or works (which includes, but is not limited to, the existing footprint of the infrastructure, ancillary services and works identified in Map A).
- 2. The footprint (at the date of this declaration) of water channels within Ghow Swamp Aboriginal Place (which includes, but is not limited to, the existing footprint of the channels identified in Map B) must not be expanded or deepened. The operation and maintenance of such channels must only be undertaken by or on behalf of the responsible water corporation and in accordance with any requirements of the **Aboriginal Heritage Act 2006**.
- 3. Continued use and essential maintenance of an existing licensed water pump or irrigation outlet on Crown land and/or waters within Ghow Swamp Aboriginal Place by the licence holder is allowed; however, works associated with continued use, maintenance or replacement of an existing licensed water pump or irrigation outlet by or on behalf of the licence holder must be confined to the existing footprint (at the date of this declaration) of that water pump or irrigation outlet or its ancillary infrastructure. Works must not include the excavation of soil beyond the immediate suction line extraction point. Any works undertaken must accord with any conditions of a licence issued under the **Water Act 1989** and any requirements of the **Aboriginal Heritage Act 2006**. Extension of an existing suction line beyond the existing footprint to the extent necessary to access water must not involve ground disturbing works. Vehicle access to the existing licensed water pump or irrigation outlet is allowed for maintenance or replacement works if there is no other reasonable alternative.
- 4. Establishment of any new transmission lines or other new services or works is prohibited on Crown land and/or waters within Ghow Swamp Aboriginal Place. Maintenance and/or upgrade to existing transmission lines or services on Crown land and/waters within Ghow Swamp Aboriginal Place is not permitted outside the existing footprint (at the date of this declaration) of that existing transmission line, service, or work (which includes, but is not limited to, the footprint of the transmission lines, services and works identified in Map C).

- 5. Livestock are not permitted to enter or remain on Crown land and/or waters within Ghow Swamp Aboriginal Place. Owners of livestock are responsible for ensuring that livestock are not found trespassing on Crown land and/or waters within Ghow Swamp Aboriginal Place. Authorised officer(s) may impound animals found trespassing on Crown land.
- 6. Horse riding (including riding of any animal capable of being ridden or carrying a load) is not permitted in the entirety of the Crown land and/or waters within Ghow Swamp Aboriginal Place.
- 7. The boundaries between Crown and private land along the Ghow (Kow) Swamp foreshore are to be fenced as soon as practicable with a stock proof fence by or on behalf of the responsible public land manager. A neighboring private landowner or occupier is responsible for the maintenance of the section of the stockproof fence that separates their land from Crown land, unless an alternative maintenance agreement is in place with the public land manager. Where there is no Crown land foreshore the private landowner or occupier must prevent livestock from entering or remaining on Crown land and/waters within Ghow Swamp Aboriginal Place with stock proof fencing on the freehold property.
- 8. Gates may be installed, removed, or repositioned on the Crown and private land boundary within Ghow Swamp Aboriginal Place by or on behalf of the public land manager in consultation with the Registered Aboriginal Party(ies).
- 9. Interference with Crown land boundary survey pegs, fencing and/or gates within Ghow Swamp Aboriginal Place other than for necessary maintenance or replacement is prohibited.
- 10. Persons must not remove, destroy, or lop native vegetation on Crown land or waters within Ghow Swamp Aboriginal Place, including dead native vegetation. The introduction of non-Indigenous flora on Crown land or waters is prohibited within Ghow Swamp Aboriginal Place.
- 11. Persons may access Crown land and waters within Ghow Swamp Aboriginal Place on foot. Vehicles must remain on a road or a public parking area.
- 12. The following activities are prohibited on Crown land and waters within Ghow Swamp Aboriginal Place:
 - i. ground disturbing activities, including removal or disturbance of soil or sediments;
 - ii. camping, the lighting or maintaining of fires (including any barbeque other than an electric barbeque), firewood collection;
 - iii. hunting, use or possession of trap, snare, net or similar equipment;
 - iv. use of vehicles (including trail bikes, motorbikes, quad bikes, two/four-wheel drives, and all-terrain vehicles) off a road or a public parking area;
 - v. recreational vessel launching, landing, loading, or unloading (including with the assistance of a motorised vehicle) by any person outside any recreational facility designated for that purpose by the public land manager. This prohibition does not apply to human powered craft when there is no use of a motorised vehicle to launch, land, load or unload that craft;
 - vi. the storage, discharge, disposal of litter, dangerous litter, and waste;
 - vii. agricultural activity and installation/storage/use of agricultural related infrastructure, materials and waste, vehicles, and machinery.
- 13. Measures 5, 11 and 12(i)(iv)(vi)(vii) do not apply to the following area of Crown land until such time as the Crown land boundaries are fenced as soon as practicable with a stock proof fence by or on behalf of the responsible public land manager:
 - the area of land comprising Crown Allotment 18B, Section A on Parish Plan 3378 within the Shire of Campaspe occurring immediately south of freehold allotment 11B, Section 6 on Parish Plan 2733, which does not extend east or west of this freehold allotment and is bounded by the water channel.
- 14. Exploration or mining, extraction or production of gas, petroleum, mineral, stone, and other substances is prohibited in Ghow Swamp Aboriginal Place.

- 15. None of the specified prohibitions and restrictions apply to:
 - a) activities undertaken by or on behalf of the responsible public land manager to the extent reasonably necessary for; heritage protection and management, fire prevention, water quality monitoring, water operations and management within the footprint of the various water infrastructure described in paragraphs 1–2 above, erosion control, weed and pest control (including removal of non-native vegetation), native plant re-generation/vegetation, land management and public safety. However, these works must comply with the requirements of the **Aboriginal Heritage Act 2006**, be undertaken with reference to the *Ghow Swamp Cultural Landscape Conservation Management Plan September 2019* and in consultation with the Registered Aboriginal Party(ies);
 - b) heritage protection and management activities undertaken by or on behalf of the relevant Registered Aboriginal Party(ies) and/or a public sector employee(s) whose duties involve the administration of the **Aboriginal Heritage Act 2006**.
 - c) a Traditional Owner(s) acting in accordance with Aboriginal tradition as it relates to Aboriginal cultural heritage and the Aboriginal place; and
 - d) activities undertaken in accordance with a cultural heritage permit granted under the **Aboriginal Heritage Act 2006**.

Note:

The protective measures apply in addition to any other requirements of the **Aboriginal Heritage Act 2006**. Signs are to be erected notifying of the making of the declaration, explaining the significance of the area, and setting out the prohibitions and restrictions in the declaration.

Definitions:

Authorised Officer has the same meaning as in the Impounding of Livestock Act 1994.

Crown Land means land held by the Crown in right of the State of Victoria but does not include the eastern part of Crown Allotment 15G, section C, Parish of Patho on which sheds, part residence, gravel driveway and gardens are located.

Exploration has the same meaning as in the Mineral Resources (Sustainable Development) Act 1990.

Footprint means the area occupied.

Human powered craft are self-propelled vessels such as canoes, kayaks, row boats, surf skis and stand-up paddle boats that are not fitted with an engine that is used for propulsion.

Hunting has the same meaning as in the Wildlife Act 1975.

Litter, dangerous litter, and waste has the same meaning as in the Environmental Protection Act 2017. *Livestock* has the same meaning as in the Livestock Management Act 2010.

Mineral has the same meaning as in the Mineral Resources (Sustainable Development) Act 1990.

Mining has the same meaning as in the Mineral Resources (Sustainable Development) Act 1990.

Native vegetation has the same meaning as in the Victorian Planning Provisions.

Occupier has the same meaning as the Impounding of Livestock Act 1994.

Owners of livestock has the same meaning as in the Impounding of Livestock Act 1994.

Petroleum has the same meaning as in the Mineral Resources (Sustainable Development) Act 1990.

Public land manager has the same meaning as in the Aboriginal Heritage Act 2006.

Public parking area means an area provided on land by the public land manager for parking of vehicles by members of the public.

Road has the same meaning as in the Land Conservation (Vehicle Control) Regulations 2013.

Services include a water channel, pipeline, sewer, wire, cable, electronic communication facility, conduit pipe, tunnel, tube, manhole, antenna, mast, or similar infrastructure, that can be used for the provision or disposal of electricity, gas, water, sewerage, or drainage or for telephonic or electronic communications or similar services.

Stone has the same meaning as in the Mineral Resources (Sustainable Development) Act 1990.

Vehicle has the same meaning as in the **Road Safety Act 1986** but does not include a wheelchair; a motorised wheelchair; a pram or stroller; or any other device used for the conveyance of disabled or injured persons.

Vessel has the same meaning as in the Marine Safety Act 2010.

Water corporation has the same meaning as in the Water Act 1989.

Water channels include a cut, being a passage constructed in the ground to convey water to land.



FISHERIES (WESTERN ABALONE STOCK PROTECTION) NOTICE 2022

1. Title

This Notice may be cited as the Fisheries (Western Abalone Stock Protection) Notice 2022.

2. Objectives

The objectives of this Notice are to protect the abalone fishery by protecting areas decimated by the abalone viral Ganglioneuritis (AVG) and reducing the risk of spread of AVG due to specified activities.

3. Authorising provision

This Notice is made under sections 67, 114 and 152 of the Act.

4. Commencement

This Notice comes into operation on the day it is published in the Government Gazette.

5. Definitions

In this Fisheries Notice -

'commercial abalone equipment' has the same meaning as in the Act;

'specified waters' means all marine waters shown on the plan in the Schedule 1. This includes all Victorian waters up to the high tide mark, between Cape Bridgewater, shown at point A ($38^{\circ} 20.920'$ S, $141^{\circ} 23.130'$ E), to Point Danger shown at point B ($38^{\circ} 23.591'$ S, $141^{\circ} 39.00'$ E); and all waters south of the area between point B and point C ($38^{\circ} 23.591'$ S, $141^{\circ} 40.634'$ E), encompassing Lawrence Rocks. All areas extend from the high tide mark within these boundaries, out to a depth of 30 metres;

'coff' has the same meaning as in the Fisheries Regulations 2019;

'the Act' means the Fisheries Act 1995;

VFA' means the Victorian Fisheries Authority established under the Victorian Fisheries Authority Act 2016.

6. Prohibition on abalone fishing within specified waters

- (1) For the purposes of section 67 of the Act
 - (a) the taking of abalone from specified waters; or
 - (b) the possession of abalone in or on specified waters; or
 - (c) the landing or sale of abalone taken from specified waters –

is prohibited.

(2) For the purposes of the Act, the catch limit with respect to the taking of abalone from, or the possession of abalone in or on specified waters is zero (0).

7. Prohibition on using abalone as bait or berley

A person must not use abalone as bait or berley in Victorian waters. Penalty: 50 Penalty units.

8. Prohibition on depositing abalone shells

A person must not deposit abalone shells in any Victorian waters. Penalty: 50 Penalty units.

9. Prohibition on using a coff for abalone

- (1) For the purposes of section 114 of the Act, the use of any coff for holding abalone in marine waters is prohibited.
- (2) Sub-clause (1) does not apply to the holder of an Aquaculture (Crown Land Abalone) Licence acting in accordance with the licence.

10. Exemptions

- (1) This notice does not apply to an authorised officer, police officer or employee or agent of the VFA acting in the execution of their duties.
- (2) An authorised officer may issue a permit authorising a person to carry out one or more activities prohibited or restricted by this fisheries notice
 - a. subject to any conditions; and
 - b. to be effective for any period of time –

that the officer specifies in the permit.

(3) The holder of a permit issued under sub-clause (2) must comply with any condition to which the permit is subject.

Penalty: 50 penalty units

11. Application to Fisheries Reserves




