**Drugs, Poisons and Controlled Substances Act 1981****PUBLIC HEALTH EMERGENCY ORDER UNDER SECTION 22D**

I, Professor Euan Wallace, Secretary to the Department of Health, pursuant to section 22G of the **Drugs, Poisons and Controlled Substances Act 1981** (Act), extend and amend the public health emergency order (PHEO #4) published in the Victoria Government Gazette on 14 April 2022, in the belief that it is necessary to do so to prevent a serious risk to public health posed to the State of Victoria arising from severe acute respiratory syndrome coronavirus 2 (**SARS-CoV-2**), being the virus that causes the coronavirus disease (**COVID-19**).

The purpose of this Order is:

- (1) to facilitate a **practitioner** to obtain and possess, use, sell or supply a Schedule 4 poison or Schedule 8 poison for a person (patient) who in the opinion of the practitioner is at risk of COVID-19; and
- (2) to enable a **pharmacist** in the State of Victoria to sell or supply a Schedule 4 poison or Schedule 8 poison on an electronically transmitted digital image of a paper-based prescription transmitted directly to the pharmacist from a practitioner; and
- (3) to restrict the sale or supply of a Schedule 4 poison or Schedule 8 poison on this Order to a **hospital** pharmacy only.

For the purposes of this Order, a digital image of a prescription means an unaltered photo image and includes an unaltered facsimile image of a paper-based prescription.

By this Order, I authorise a pharmacist employed or otherwise engaged by a hospital, to sell or supply (including repeats) a Schedule 4 poison or Schedule 8 poison without an original prescription to a patient if –

- (a) provided with a digital image of the paper-based prescription transmitted directly from the practitioner (or an employee acting in accordance with the instruction of the practitioner) but not via the patient or any other intermediary; and
- (b) the pharmacist records that the sale or supply was made under this Order; and
- (c) the pharmacist retains a copy of the digital image upon which the supply is made for two years from the date the supply is made; and
- (d) the pharmacist produces a copy of the digital image required to be retained under paragraph (c) at the request of an authorised officer under the Act.

Where the paper-based prescription includes directions for repeat supply, the pharmacist receiving the digital image of the original prescription transmitted directly from the practitioner (or an employee acting in accordance with the instruction of the practitioner) should generate and retain a repeat authorisation form so that the repeat supply can be dispensed at the same pharmacy. For the avoidance of doubt, a repeat authorisation may be dispensed from the same pharmacy that received the digital image of the original prescription in accordance with this Order, including if this Order is no longer in force.

A practitioner who transmits a digital image of a paper-based prescription for the purposes of this Order must –

- (a) record that a digital image of the paper-based prescription was transmitted under this Order; and
- (b) retain the paper-based prescription for two years from the date that the digital image of a paper-based prescription was transmitted; and
- (c) produce the paper-based prescription required to be retained under paragraph (a) at the request of an authorised officer under the Act.

For the purposes of this Order, an original prescription must include the handwritten signature of the practitioner except where it is not possible for the prescription to include the handwritten signature due to operation of telehealth, in which case, the practitioner may –

- (a) include a digital image of their handwritten signature; or
- (b) give access to the digital image of their handwritten signature to an employee, where the employee acts in accordance with the instruction of the practitioner to apply the digital image of the practitioner's signature to the original prescription.

### Definitions

**Health Practitioner Regulation National Law (Victoria)** means the **Health Practitioner Regulation National Law (Victoria) Act 2009**.

**hospital** means an approved hospital authority under section 94 of the **National Health Act 1953** (Cth) for the purposes of supplying pharmaceutical benefits to patients.

**pharmacist** means a pharmacist registered under the **Health Practitioner Regulation National Law (Victoria)** to practise in the pharmacy profession (other than as a student).

**practitioner** means a medical practitioner, nurse practitioner, dentist, authorised midwife, authorised optometrist or authorised podiatrist registered under the **Health Practitioner Regulation National Law (Victoria)** to practise in their profession (other than as a student).

This Order comes into force on the date of publication in the Government Gazette and continues in force until 31 March 2023, unless revoked earlier.

**Fire Rescue Victoria Act 1958****MINISTERIAL DIRECTION**

Dear Commissioner

I write in relation to the involvement of Fire Rescue Victoria (FRV) in proceedings currently before the Fair Work Commission (FWC) (Matter No. 2022/2043), in which the United Firefighters' Union of Australia (UFU) has made an application for the FWC to deal with a dispute under Clauses 1 and Clauses 26 of, respectively, Divisions A and B of the Fire Rescue Victoria Operational Employees Interim Enterprise Agreement 2020 (the Agreement).

In the proceedings, the UFU contends that Clauses 42 and 49 of the respective divisions of the Agreement contain a commitment to the establishment of a firefighters registration board. The Clauses are identical, and are in the following terms.

FRV endorses the establishment of a firefighters registration board. FRV will demonstrate this by letter of endorsement to the UFU secretary.

The UFU, has proposed the establishment of another board, described as a 'permanent' registration board (the proposed board). The dispute concerns the establishment of such a board.

On 17 August 2022, I wrote to you indicating that I am supportive of the establishment of an appropriate scheme for firefighter registration in Victoria. However, I also stated that I consider that Ministerial consent is required, under section 25A(3) of the **Fire Rescue Victoria Act 1958** for FRV to participate in the formation of the proposed board, and for FRV to enter into an agreement with the proposed board (in the form provided to me). I stated that I was not in a position to give my consent, for the reasons set out in my letter.

My letter to you raised concerns about the transparency and oversight of firefighter registration under the proposed Services Agreement, the risks arising from the fact that the proposed Services Agreement would fetter the statutory employment powers of FRV, and the duplication of functions by the proposed board and the Firefighters Registration Board established by the **Fire Rescue Victoria Act 1958**.

The FWC matter is listed for an arbitration hearing before Commissioner Wilson on Monday 29 August 2022. FRV is required to file its submissions and evidence with the FWC in advance of that date.

On 23 August 2022, officers of FRV provided officers of the Department of Justice and Community Safety with a copy of its proposed Outline of Submissions in the proceedings (the 23 August Outline of

Submissions). The submissions address a number of matters, including, importantly, whether the FWC has jurisdiction and power to deal with the dispute, given terms of Clauses 42 and 49 of the respective divisions of the Agreement, and the operation of section 595 of the **Fair Work Act 2009** (Cth) (the Jurisdictional Issue).

I understand that FRV has not yet filed a copy of the 23 August Outline of Submissions with the FWC, and that it now proposes not to address, in its submissions, the jurisdictional issue.

It is of critical importance that the FWC have all relevant material before it that goes to whether it has jurisdiction to arbitrate this matter. Particularly as a model litigant, it is appropriate for FRV to raise this Jurisdictional Issue for the FWC's consideration, to avoid leading the FWC into error.

I therefore direct, under section 8 of the **Fire Rescue Victoria Act 1958**, FRV and you, as Acting Fire Rescue Commissioner, to file submissions with the FWC in the same form as the 23 August Outline of Submissions.

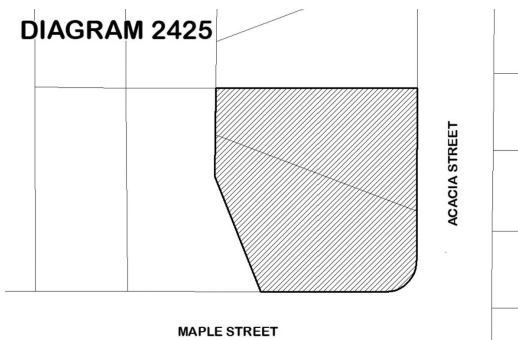

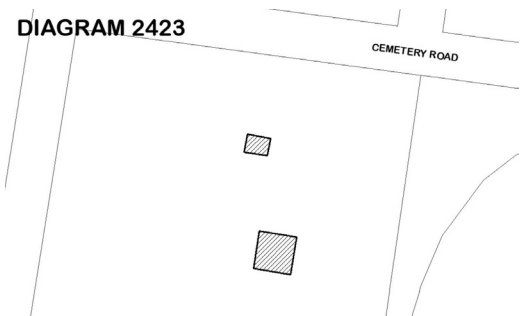

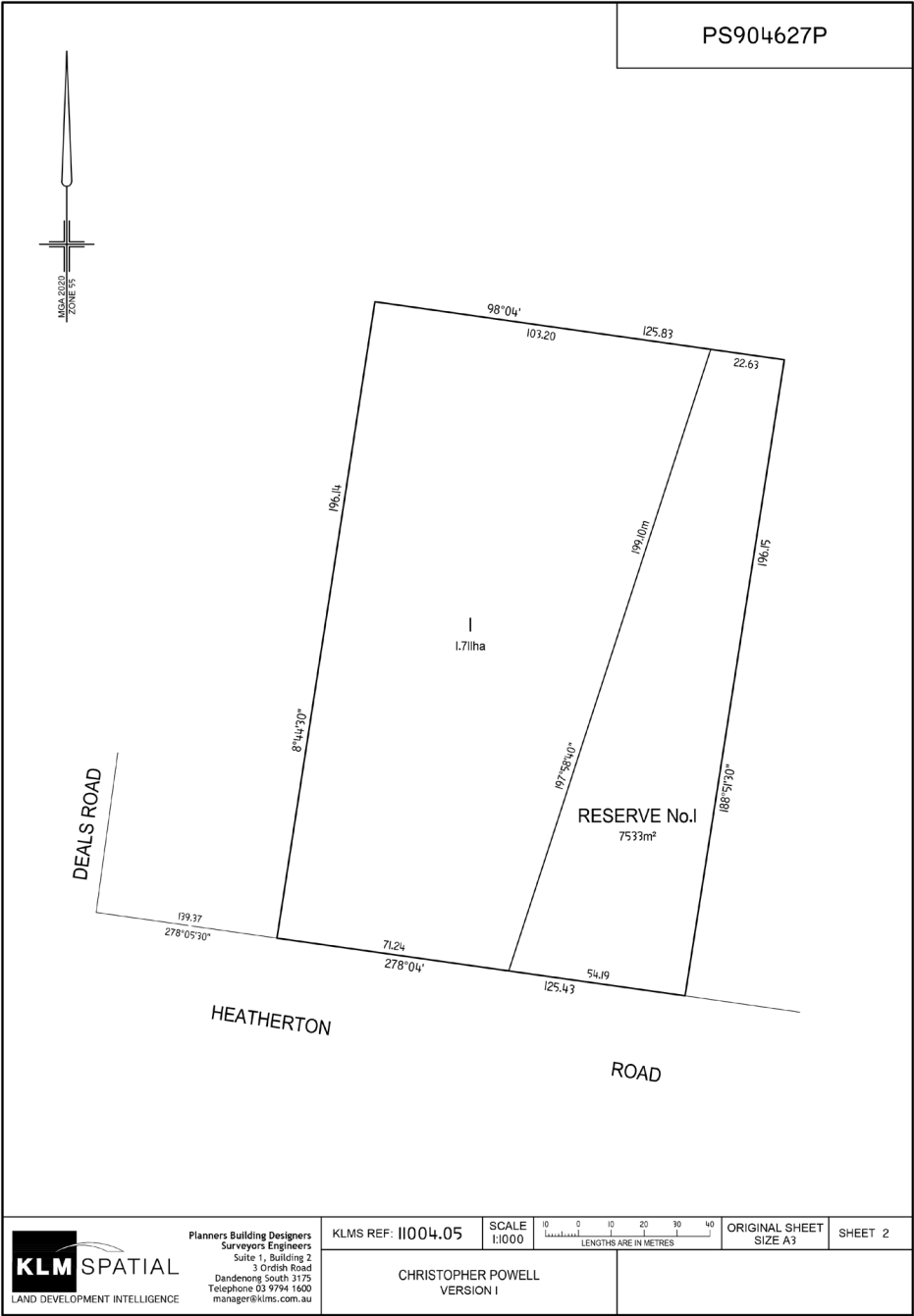

**Environment Protection Act 2017**

As Minister responsible for the **Environment Protection Act 2017**, I give notice under section 12 of the **Subordinate Legislation Act 1994** (the Act) that, further to public consultation on a regulatory impact statement (RIS), I have decided to recommend the making of the Environment Protection Amendment (Wind Turbine Noise) Regulations 2022 (proposed Regulations).

The RIS and draft proposed Regulations were advertised on Engage Victoria for public comment from 3 March to 15 April 2022. 26 submissions were received and have been considered in accordance with section 11(3) of the Act.

I hereby give notice of the decision to make the proposed Environment Protection Amendment (Wind Turbine Noise) Regulations 2022.

The proposed Regulations are intended to provide clarity and certainty regarding obligations to minimise risks of harm to the environment and human health from wind turbine noise emissions, reducing costs of regulation while supporting investment in the wind energy industry and enhancing community confidence in the regulatory framework for wind energy facility noise.

After consideration of the submissions, I have decided that the proposed Regulations should be made, with amendments to the draft proposed Regulations that were released for public comment. The key amendments include:

- clarifying when and how alternative monitoring points can be utilised, and alternative monitoring point criteria determined;
- providing for wind energy facilities with NZS 6808:1998 in their authorising document to address extraneous noise in accordance with NZS 6808:2010;
- clarifying that auditor verification is required for post-construction noise assessments, which must be conducted in accordance with NZS 6808:2010; and
- requiring an initial annual statement to be completed by 1 March 2023.
