



Education and Training Reform Act 2006

	4. The published Interim Prohibition Order must remain on any website or social media platform used to promote themselves or the supply of any goods or services until the Interim Prohibition Order has expired or is revoked.	

In this Interim Prohibition Order 'general health service' and 'general health service provider' have the same meaning as in section 3 of the **Health Complaints Act 2016**.

This Interim Prohibition Order takes effect on the service of the order on the general health service provider to whom it applies.

HEALTH PURCHASING VICTORIA

Pursuant to section 134B(5) of the **Health Services Act 1988** (the Act), notice is given of amendments to Health Purchasing Victoria (HPV) (also known as HealthShare Victoria (HSV)) Health Purchasing Policies (HPPs) initially gazetted on 26 June 2014, effective on 26 June 2016, with amendments incorporated on 25 May 2017.

These revised policies will be referred to as HSV Purchasing Policies (HSV PPs), and on 1 January 2023, a transition period for the HSV PPs will commence and be in effect for 12 months. The transition period will formally conclude on 1 January 2024, and Schedule 1 and 5 health services listed under the Act must comply with these amended HSV PPs by this date.

HSV has a responsibility to develop, implement and review policies and practices to ensure compliance and probity in procurement, and to support good procurement practices across the Victorian health sector.

The amendments to the HPPs contained within the HSV Purchasing Policies are intended to align to the Victorian Government Purchasing Board (VGPB) Supply Policies and to implement areas for improvement that have been identified. The amendments to the HSV Purchasing Policies 1–5 include:

- amendment of all HSV PPs to a principle-based purchasing policy approach for health services;
- fit-for-purpose application depending on size and complexity of a health service;
- clearer health service reporting requirements;
- alignment of the 'HSV Purchasing Policy 1. Governance' to the updated VGPB Supply Policies requirement regarding Emergency Procurement;
- updates of 'HSV Purchasing Policy 5. Collective Agreement and Supply Chain' to include the additional function of the logistics and supply chain services of HSV and the requirements of participating health services to only purchase HSV sourced goods;
- consistent definitions across all five policies.

These policy amendments have been approved by the HSV Board after a period of consultation with Victorian public hospitals, health services and impacted parties.

PUBLIC NOTICE

Declaration of Boating Activity Exemption

City of Ballarat as the declared waterway manager for Lake Wendouree, makes the following declaration under section 203(3) of the Marine Safety Act 2010.

For the purposes of boating activity conducted by Rowing Victoria, persons and vessels involved in the Rowing Victoria Lake Wendouree Regattas 2022–2023 are exempt from the following requirements:

State Rules made under the Marine Act 1988

- 1. Clause 2(c) must not exceed 5 knots within 50 metres of another vessel
- 2. Clause 3(a) must not exceed 5 knots within 50 metres of the water's edge
- 3. Clause 3(b) must not exceed 5 knots within 50 metres of a fixed or floating structure

Waterway Rules made under the Marine Safety Act 2010 / Marine Act 1988

4. Clause 42.1 of Schedule 42 – 5 knot speed restriction for all the waters of Lake Wendouree for vessels equipped with engines used for propulsion

Subject to the conditions detailed below:

- Masters of rescue vessels are only exempt from items 1 to 4 when undertaking a rescue operation to retrieve persons in distress, provide for their initial medical or other needs and deliver them to a place of safety.
- Masters of competing vessels are only exempt from items 1 to 3 for the duration of the events.
- Masters of marshal/umpire vessels are only exempt from items 1 to 4 when following competing vessels in a race or at the conclusion of a race when returning to the start line for the next race and must not exceed the speed of a competing rowing vessel.
- Occupants of powered vessels used in conjunction with the event must wear a personal flotation device at all times.

- The event is operating under the auspices of Rowing Victoria, including the Rowing Victoria Safety Management Plan, which meets the criteria of Clause 3 of the Exemption Notice made under the Marine Regulations 1999 in respect of the exemption for rowing vessels to not carry or wear a personal flotation device.
- The exemptions apply from 7.00 am to 6.00 pm for the dates and events specified in Table 1 below, within the exclusion zone waters the whole of Lake Wendouree.
- The exemptions apply provided the stated safety controls and undertakings detailed in the application form and associated documentation are adhered to.
