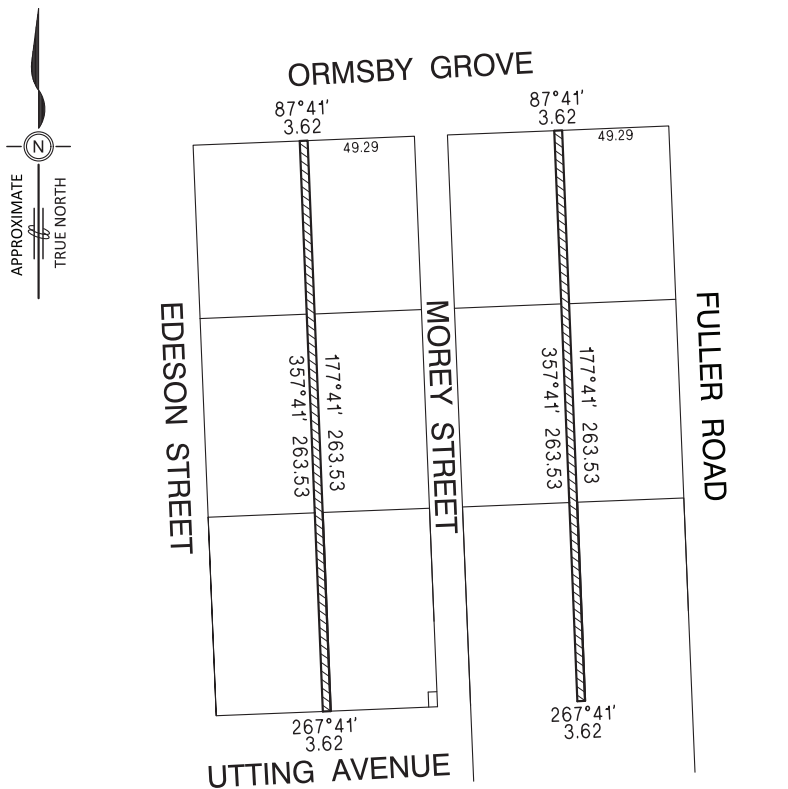

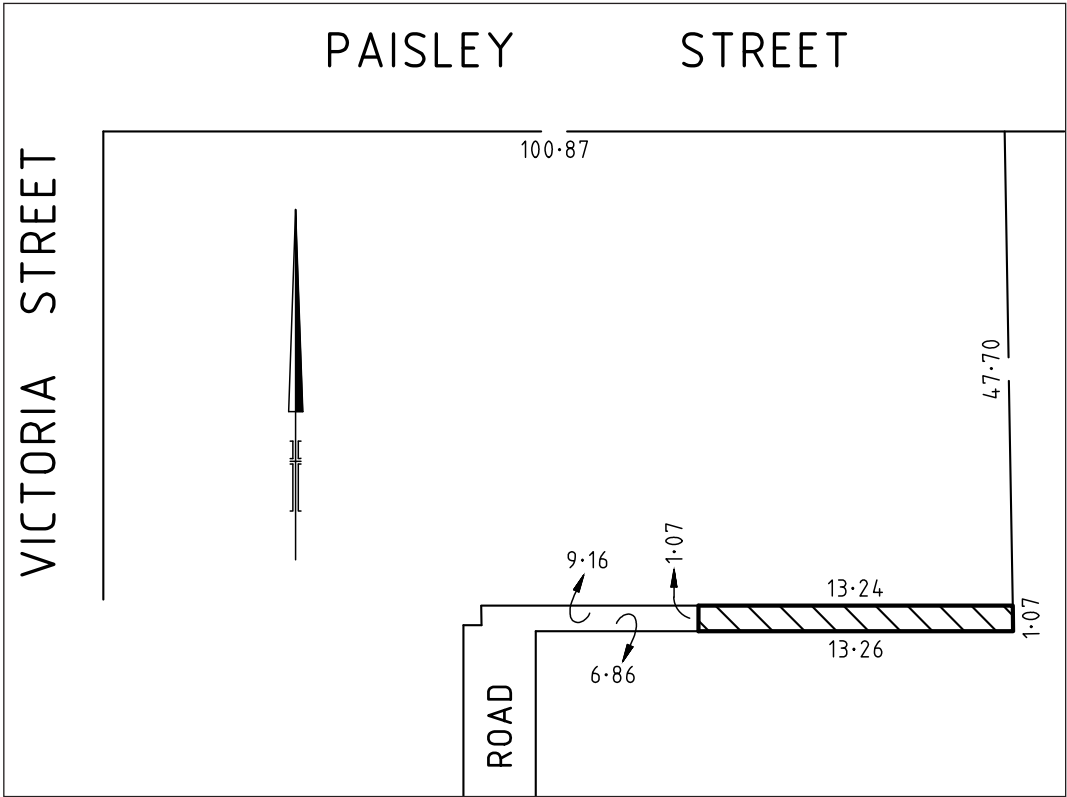


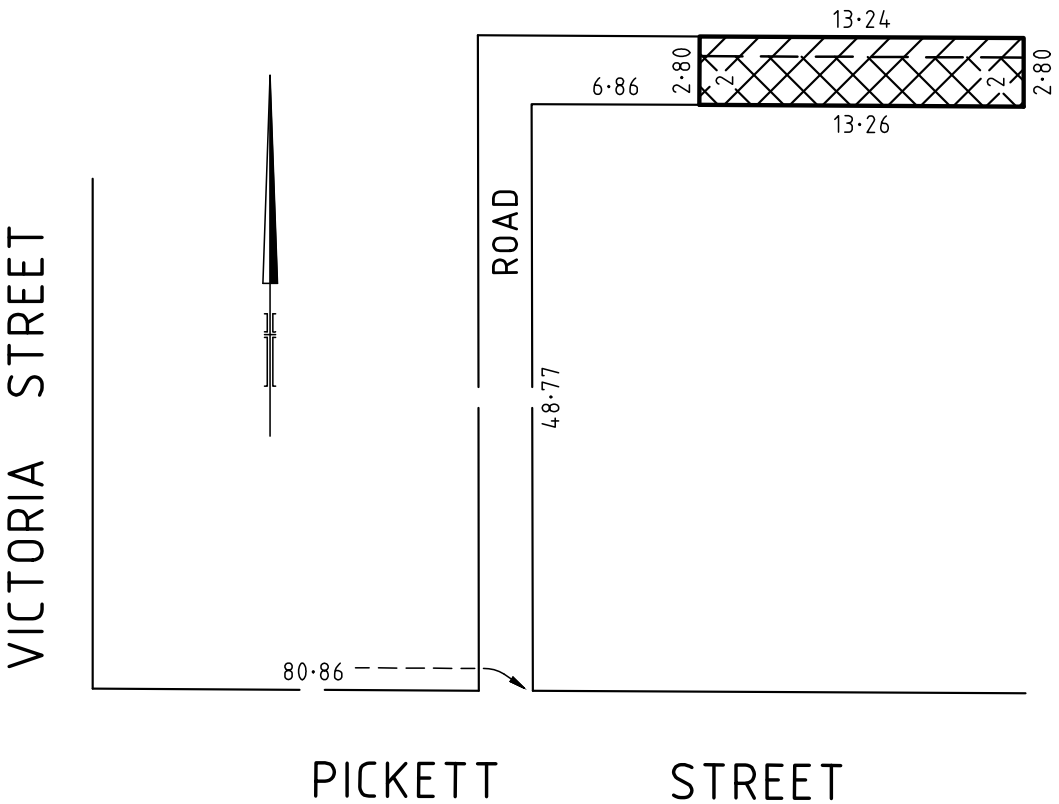
ROAD DISCONTINUANCE

Road Abutting 99, 109, 111 and 113 Paisley and 58 Pickett Streets, Footscray

Maribyrnong City Council (Council) has formed the opinion that part of the road abutting 99, 109, 111 and 113 Paisley and 58 Pickett Streets, Footscray, shown hatched and cross-hatched on the plans below, being part of the road contained in Certificate of Title Volume 8833 Folio 087 and Volume 3062 Folio 355 (Road), is not reasonably required as a road for public use. Council resolved on 18 October 2022 acting under Clause 3 of Schedule 10 and sections 206 and 207B of the **Local Government Act 1989**, to discontinue the Road and to sell the discontinued Road to the abutting owners of 97, 99, 109 and 111–115 Paisley Street, 58 and 60 Pickett Street, Footscray.

The section of road shown cross-hatched is to be sold subject to the right, power or interest held by City West Water in connection with any sewers, drains or pipes under the control of that authority.

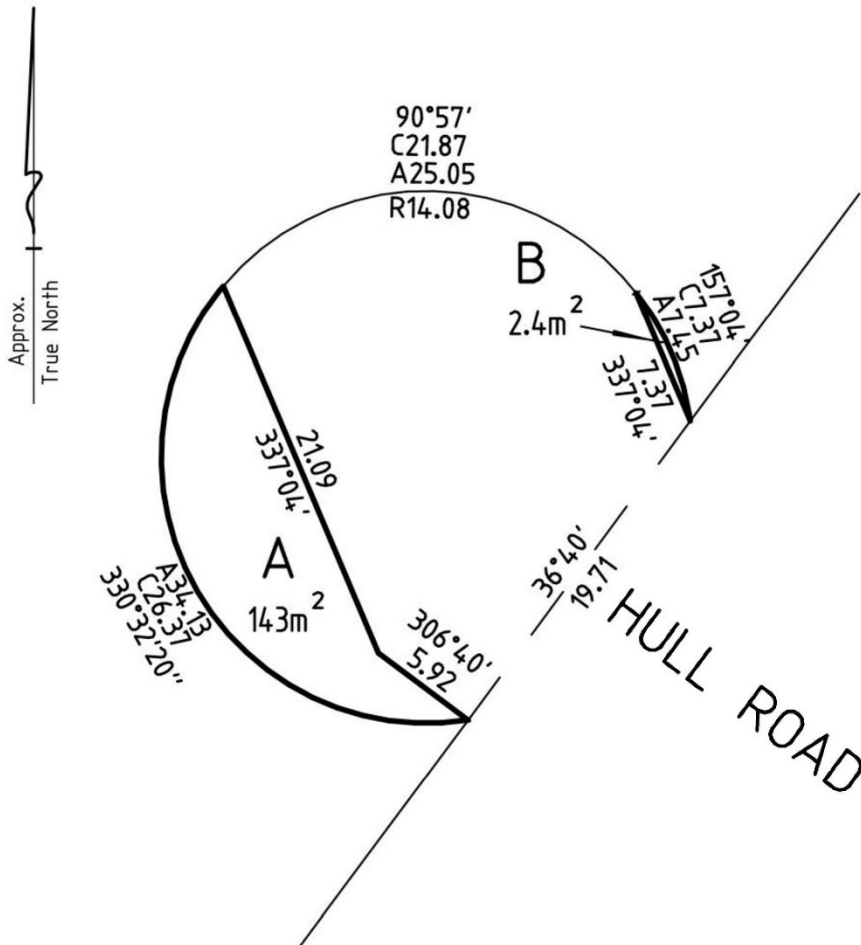

1 Title

This Order may be cited as Ministerial Order No. 1392 – Order Amending Ministerial Order No. 819 – Fees for Overseas Students in Government Schools.

2 Purpose

This Order amends the Fee Schedule and Distribution Schedule of Ministerial Order No. 819 – Fees for Overseas Students in Government Schools (Ministerial Order No. 819) to:

- (a) increase the amount that Government Schools can charge for homestay services; and
- (b) alter the distribution of fees disbursed to the school and the Secretary in relation to dependant overseas students enrolled in primary years Preparatory to Year 2 and junior secondary Years 7–10.

3 Authorising Provisions

This Order is made under sections 2.2.8, 2.2.9 and 5.10.4 of the **Education and Training Reform Act 2006**.

4 Commencement

This Order commences on the later of the day it is signed or 1 January 2023.

NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS
