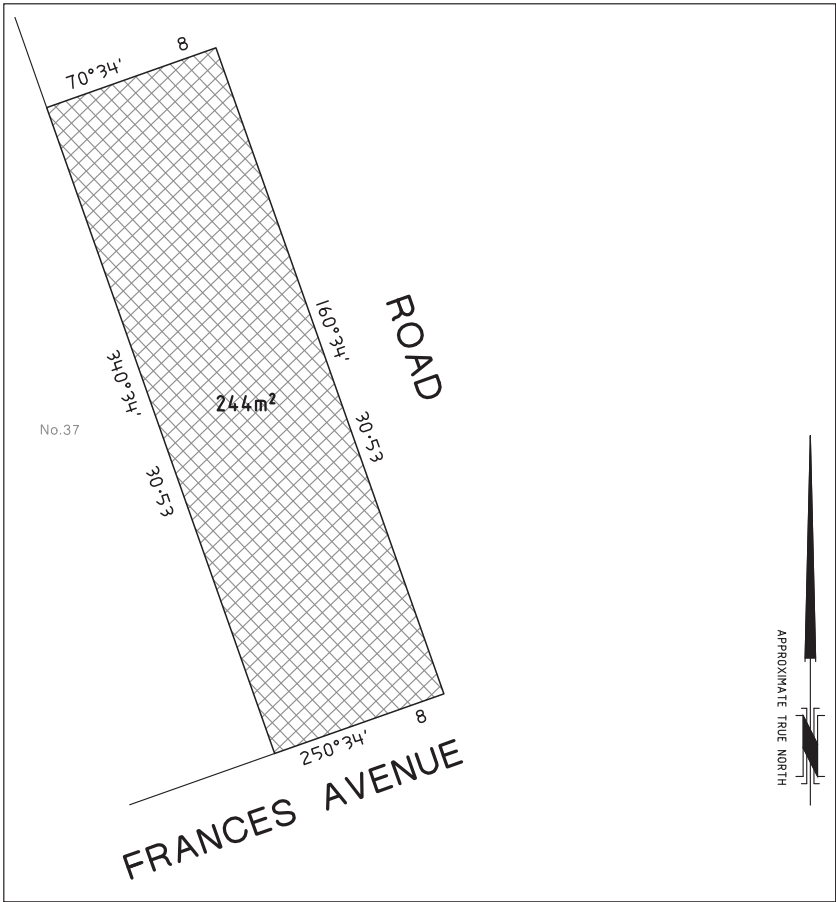

Domestic Animals Act 1994**ORDER UNDER SECTION 26(2)**

Pursuant to and in accordance with section 26(2) of the **Domestic Animals Act 1994**, Council makes the following Order:

1. Revocation of previous orders

Council revokes all previous orders made under section 26(2) of the **Domestic Animals Act 1994**.

2. Dogs and cats must be under effective control

The Owner of any dog or cat must keep the dog or cat under effective control by means of a chain, cord or leash (not exceeding 2 metres in length) while the dog or cat is in any of the following public places:

- 2.3 all Public Reserves, except those which are Designated Off Leash Areas;

If a dog is in a public place in which the Owner is not required to restrain the dog by a chain, cord or leash under this Order, the Owner must:

- 4.1 carry a chain, cord or leash sufficient to bring the dog under control by placing the dog on a chain, cord or leash if the dog behaves in a manner which threatens any person or animal;
- 4.2 remain in effective voice and/or hand control of the dog and within constant sight of the dog so as to be able to promptly bring the dog under control by placing the dog on a chain, cord or leash if that becomes necessary or desirable to avoid any wandering out of effective control or to avoid any threatening behaviour or any attack; and
- 4.3 not allow the dog to worry, rush at or otherwise threaten any person or animal, and must not allow the dog to attack any person or animal.

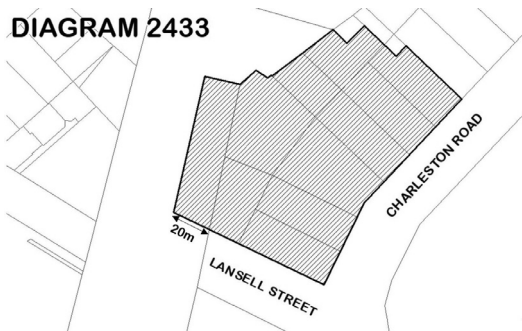

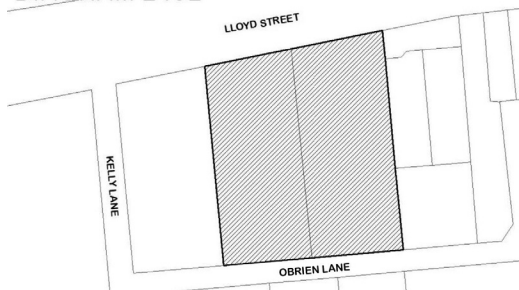

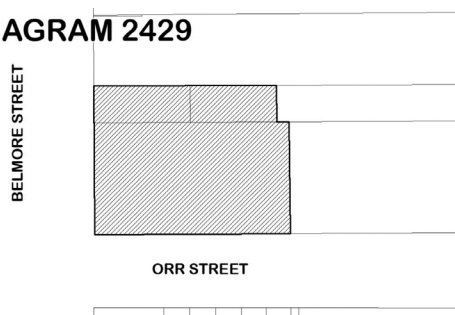

3. Clause 43.3(m) and (p) of Schedule 43 – 5 knot speed restriction areas in south-west of lake extending 100 metres from shore.

4. Regulation 96(5) – Master requirement to carry listed safety equipment on vessel on inland waters (bucket with lanyard)

Modification For the purpose of boating activity conducted by the Ski Racing Victoria 'Schedule 1 – Types of personal floatation devices', of the Marine Safety Regulations 2012 (MSR) is modified to include a personal floatation device (PFD) is a PFD type 1, 2 or 3 if it complies with the current Ski Racing Australian (SRA) rules and a PFD Type 3 if it adequately achieves the purpose of a Level 50S PFD.

Subject to the conditions detailed below:

- Masters of rescue vessels are only exempt from item 1 to 3 when undertaking a rescue operation to retrieve persons in distress, provide for their initial medical or other needs and deliver them to a place of safety.
- Masters of competing vessels are only exempt from items 1 to 4 for the duration of the events and item 3 provided they do not exceed 5 knots within 50 metres of the water's edge.
- Occupants of competing vessels must wear a PFD at all times that complies with Rule 10.6 of the current SRA Rules.
- Competing water-skiers must wear a PFD at all times that complies with Rule 10.14 of the current SRA Rules and adequately achieves the purpose of a Level 50S PFD.
- Occupants of rescue and official vessels associated with the event must wear a PFD at all times, and vessels must have all of the prescribed safety equipment.
- The exemptions apply from 7.00 am to 8.00 pm on Saturday 10 and Sunday 11 December 2022 within the exclusion zone waters – Lake Burrumbeet.
- The exemptions apply provided the stated safety controls and undertakings detailed in the application form and associated documentation are adhered to.
