### NOTICE OF BOATING ACTIVITY EXCLUSION ZONE

I, Shaun Rodenburg, Director Maritime Safety and delegate of the Director, Transport Safety hereby give notice under section 208(1) of the **Marine Safety Act 2010** that all persons and vessels not registered to take part in the 2022 LSV Champion Lifesaver event are prohibited from entering and remaining in the following State waters.

Coastal waters adjacent to the Jan Juc Surf Life Saving Club, which will be clearly marked by signs and flags on the shore, and in the water by buoys extending up to 170 metres from shore.

The exclusion zone will be in effect from 6.30 am to 5.00 pm on Sunday 6 March 2022.
