Amendment C260wsea

The Minister for Planning has approved Amendment C260wsea to the Whittlesea Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment facilitates flood mitigation works as part of the Childs Road Upgrade Project by amending the boundary of Specific Controls Overlay Schedule 7 (SCO7) to include additional land within the overlay area, remove residential land no longer required for the project from the overlay area and by removing native vegetation.
