Road Management Act 2004

DESIGNATION OF TOW-AWAY AREA UNDER SCHEDULE 4 CLAUSE 5 TOW-AWAY AREA FOR ANZAC DAY 2022 EVENT.

Clause 5 of Schedule 4 to the **Road Management Act 2004** provides that a State road authority may move, keep or impound any vehicle that is unlawfully parked or left standing in an area designated by the Minister, (referred to in this instrument as a ‘tow-away area’), and may charge the owner of the vehicle a reasonable fee.

For the purposes of that provision, I, Angela Grice, Executive Director Planned Disruptions at the Department of Transport and delegate of the Minister for Roads, designate the locations specified and shown on the attached plan, to be a tow-away area to facilitate the Anzac Day 2022 event to be held in Melbourne.

This instrument takes effect on Monday, 25 April 2022.

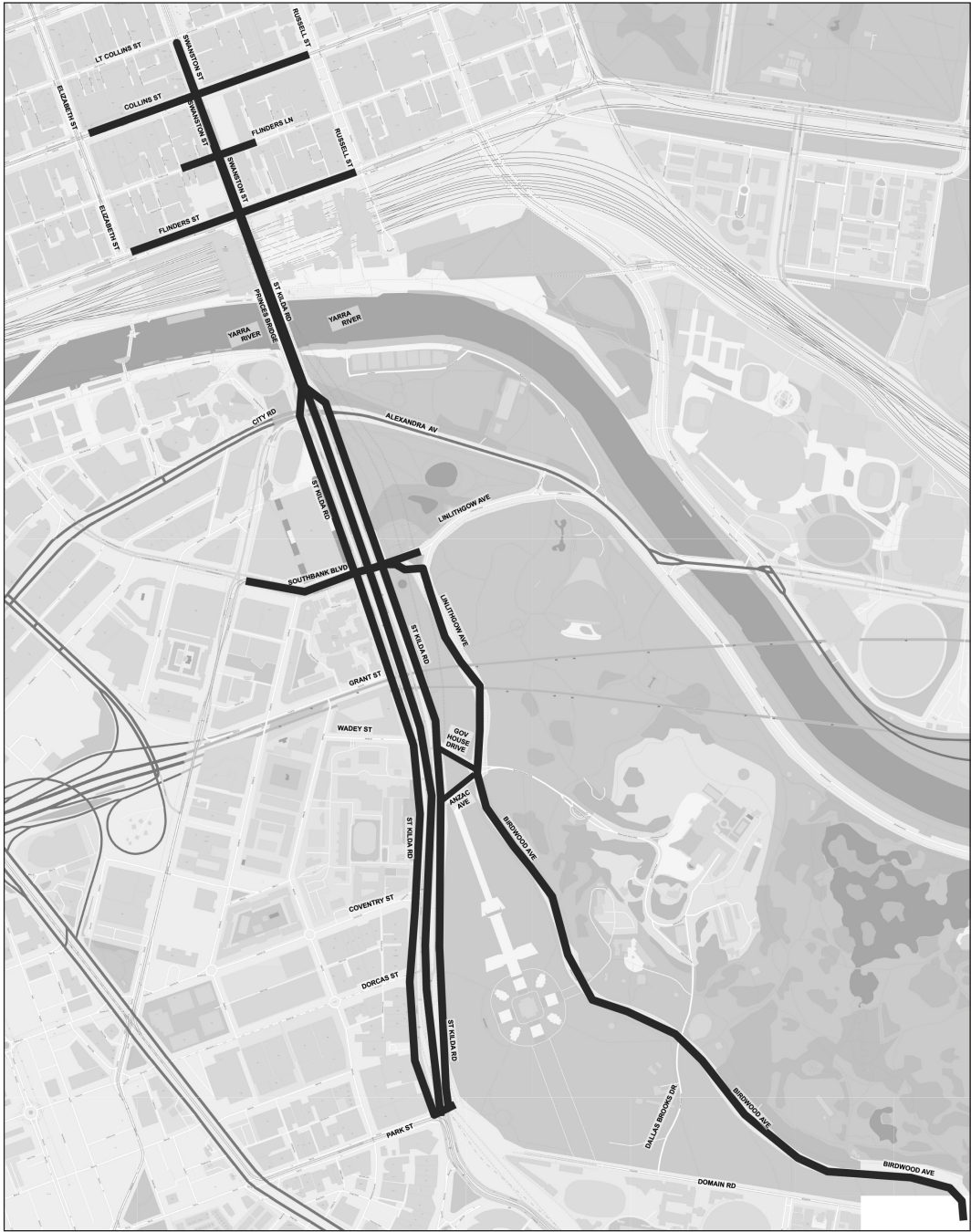
- Swanston Street between Little Collins Street and Flinders Street from 5.00 am to 2.00 pm
- Collins Street between Elizabeth Street and Russell Street from 5.00 am to 2.00 pm
- Flinders Lane between Manchester Lane and Regent Place from 5.00 am to 2.00 pm
- Flinders Street between Elizabeth Street and Russell Street from 5.00 am to 2.00 pm
- St Kilda Road between Flinders Street and Park Street from 12.01 am to 2:00 pm
- Southbank Boulevard between Sturt Street and St Kilda Road from 12.01 am to 2.00 pm
- Linlithgow Avenue (east-west section) between Linlithgow Avenue (north-south section) and St Kilda Road from 12.01 am to 2.00 pm
- Linlithgow Avenue (north-south section) between Linlithgow Avenue (east-west section) and Government House Drive from 12.01 am to 2.00 pm
- Government House Drive between St Kilda Road and Linlithgow Avenue from 12.01 am to 2.00 pm
- Anzac Avenue between St Kilda Road and Linlithgow Avenue from 12.01 am to 2.00 pm
- Birdwood Avenue between Domain Road and Linlithgow Avenue from 12.01 am to 2.00 pm.
