ROAD DECLARATIONS

Head, Transport for Victoria, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares and renames the roads described in the Schedule and on the plans attached.

The effects of these Road Declarations on road names are described in Table 1.

SCHEDULE

ARTERIAL ROAD

- a) Those parts of Northern Highway identified by hatching or heavy broken line on the plans numbered GP23566, GP23567, GP23569, GP23570, GP23571, GP23572 and GP24621 are declared or renamed as described in the legend in the said plans.
- b) Those parts of Murray Valley Highway identified by hatching or heavy broken line on the plans numbered GP23566, GP23566A and GP24621 are declared or renamed as described in the legend in the said plans.
- c) That part of Cohuna – Echuca Road identified by hatching on the plan numbered GP23570 is declared as described in the legend in the said plan.
- d) That part of Echuca – Kyabram Road identified by heavy solid line on the plan numbered GP24621 is renamed as described in the legend in the said plan.

- e) That part of Campaspe Esplanade identified by hatching on the plan numbered GP23570A is declared as described in the legend in the said plan.

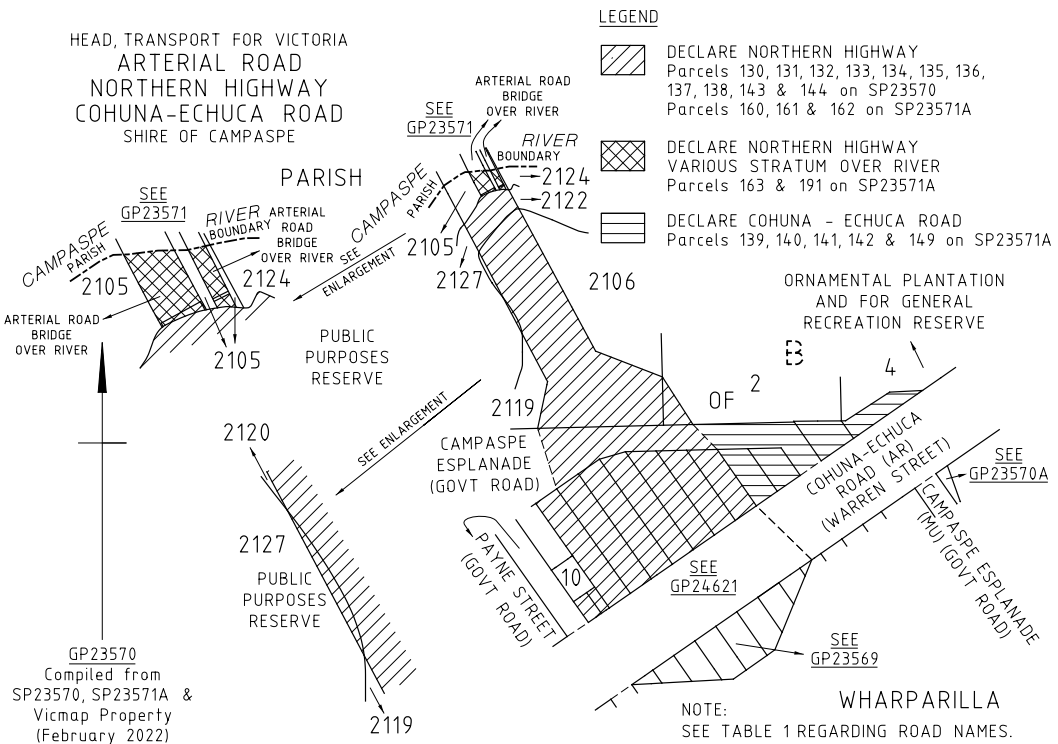
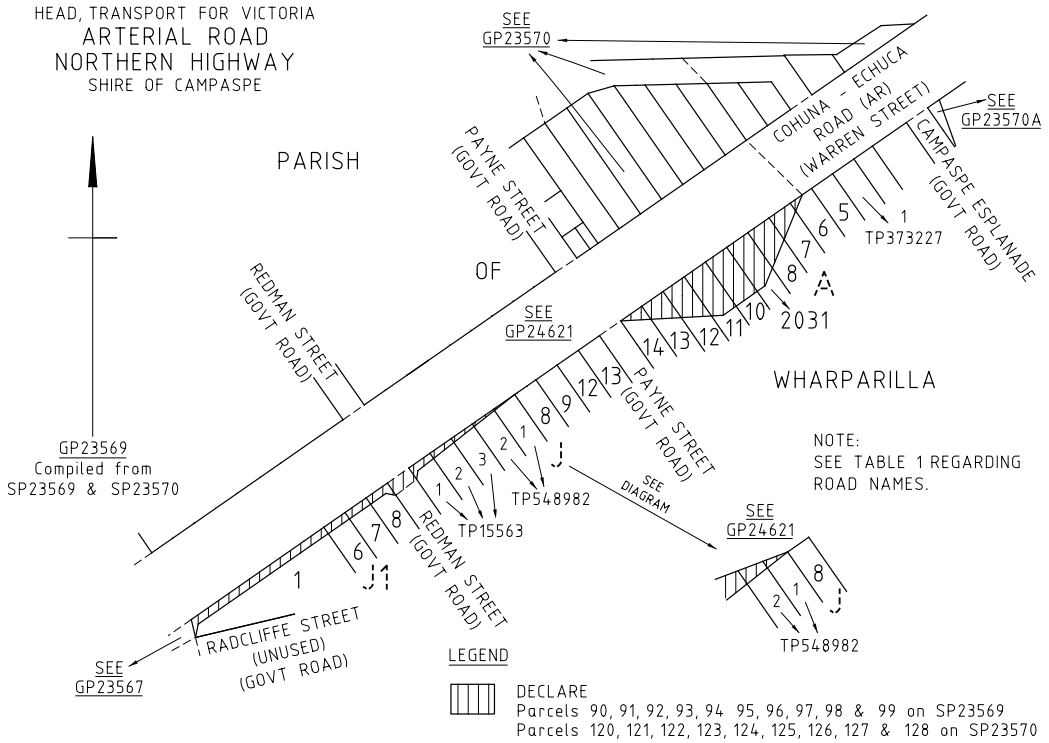
1. Names in Column 2 are existing Vicmap Address names, which are unaffected by this notice.

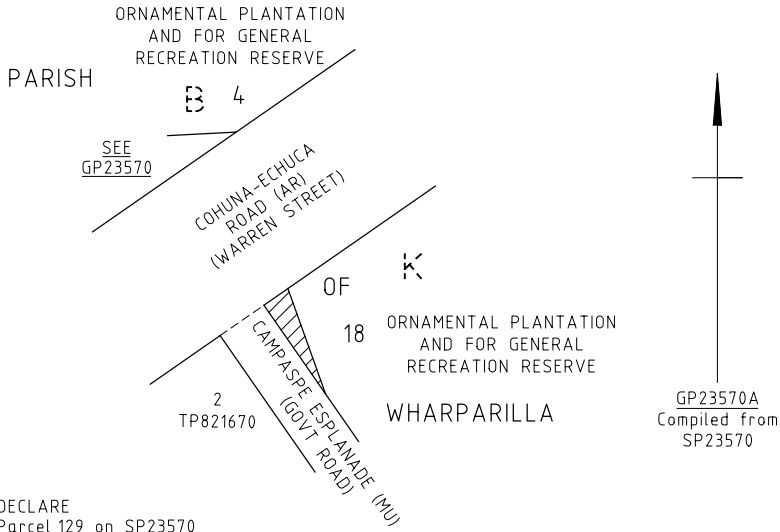
