NOTICE OF CLOSURE OF ROAD TO TRAFFIC PART OF FLINDERS STREET, MELBOURNE IN UNDERGROUND STRATA CAMPBELL ARCADE

I, Justin Deegan, Director, Legal of Rail Projects Victoria (a division of the Major Transport Infrastructure Authority), acting in my capacity as delegate of the Secretary to the Department of Transport (Secretary) under the **Major Transport Projects Facilitation Act 2009** (MTPFA), hereby close to traffic part of Flinders Street, Melbourne, in underground strata, known as Campbell Arcade, Melbourne, from 2 May 2022 until 30 April 2024 or until completion of the relevant works, whichever is earlier, for the purposes of the Melbourne Metro Rail Project.

NOTICE OF CLOSURE OF ROAD TO TRAFFIC PART OF TENNYSON STREET, KENSINGTON

I, Justin Deegan, Director, Legal of Rail Projects Victoria (a division of the Major Transport Infrastructure Authority), acting in my capacity as delegate of the Secretary to the Department of Transport (Secretary) under the **Major Transport Projects Facilitation Act 2009** (MTPFA), hereby close to traffic (other than pedestrians and cyclists) part of Tennyson Street, Kensington that was previously opened to authorised traffic by a decision under the MTPFA published in the Victoria Government Gazette on 20 September 2019 for the purpose of the Melbourne Metro Rail Project (Previous Decision).

This decision has been exercised solely under section 186D(1)(d) of the MTPFA for the purposes of the Melbourne Metro Rail Project.

For the avoidance of doubt, the effect of this decision is that the traffic conditions that existed prior to the Previous Decision are reinstated.

This decision comes into effect on 6 May 2022.
