Notice of Approval of Amendment

Amendment C385melb

The Minister for Planning has approved Amendment C385melb to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment implements the West Melbourne Structure Plan 2018 by rezoning land to the Special Use Zone (Schedule 6), applies built form controls via new schedules to the Design and Development Overlay and makes other associated changes to the Melbourne Planning Scheme.
