DAIRY FOOD SAFETY VICTORIA DETERMINATION OF LICENCE CLASSES AND FEES FOR DAIRY BUSINESSES

1 July 2022–30 June 2023

- 1) Dairy Food Safety Victoria (DFSV), being the Authority established under section 4 of the **Dairy Act 2000** (the Act) –
 - a. determines the different classes of dairy industry licences specified in Column 1 of Table 1 and Column 1 of Table 2, as provided by section 25(2) of the Act.
 - b. fixes the fees specified in Columns 2, 3, and 4 of Table 1, in respect of licence classes specified in Column 1 as provided by sections 6(f), 7(2)(b), 23(1)(c) and 24(1) of the Act.
 - c. fixes the fees specified in Columns 2, 3, and 4 of Table 2, in respect of licence classes specified in Column 1 as provided by sections 6(f) and 7(2)(b) of the Act.
- 2) In this instrument –

application fee means the fee payable to DFSV by the applicant on the making of an initial application of a dairy industry licence under section 23 of the Act;

licence class means a class of dairy industry licence as determined by DFSV under section 25(2) of the Act

licence fee means the fee payable to DFSV on the issuing or renewal of a licence by a holder of a licence under section 25 of the Act;

transfer fee means the fee payable to DFSV on the transfer of an existing licence to another person or company under section 23 of the Act.

audit fee (including time to close out corrective action requests – non conformance audits) means the fee payable to DFSV for an audit of a licensee’s food safety program(s) under section 41(1) of the Act.
- 3) This instrument comes into effect on July 1 2022.
- 4) For the avoidance of doubt, this instrument supersedes any previous instrument in which DFSV has determined licence classes and fees for dairy businesses.
