ALLOCATION OF PROPERTY, RIGHTS AND LIABILITIES OF MELBOURNE HEALTH TO NORTHERN HEALTH

Order in Council

The Governor in Council, on the recommendation of the Minister for Health made under section 248(1)(d) of the **Health Services Act 1988** ("the Act") and acting under section 248 of the Act by this Order –

- 1. Allocates such of property, rights and liabilities of Melbourne Health to Northern Health as specified in the sub-clauses below:
 - 1.1 all property, rights and liabilities in respect of the plant and equipment described in item 1 of Schedule 1;
 - 1.2 all property, rights and liabilities in respect of the motor vehicles described in item 2 of Schedule 1;
 - 1.3 all property, rights and liabilities in respect of the utilities accounts described in item 3 of Schedule 1;
 - 1.4 all property, rights and liabilities in respect of the agreements described in item 4 of Schedule;
 - 1.5 all property, rights and liabilities in respect of the leases and licences described in item 5 of Schedule 1;
 - 1.6 all property, rights and liabilities in respect of occupancy of the Crown land described in item 6 of Schedule 1;
 - 1.7 all property, rights and liabilities in respect of the Residential Agreements between Melbourne Health and the individual residents of McLellan House Hostel and Merv Irvine Nursing Home;
 - 1.8 all property, rights and liabilities in respect of:
 - (a) all medical records and medical files in whatever format; and
 - (b) all other records and files in whatever format;
 - (c) all Treatment Orders –

that relate to the treatment of patients at the:

- (i) Broadmeadows Community Care Units;
- (ii) Broadmeadows Inpatient Unit Adult (BIPU);
- (iii) Hospital Outreach Post-Suicidal Engagement (HOPE) Service;
- (iv) Hotham Street Community Team;
- (i) Jewell House Prevention & Recovery Care Service (PARC);
- (ii) McLellan House Hostel;
- (iii) Merv Irvine Nursing Home;
- (iv) Moreland Clinic;
- (v) Noogal Clinic;
- (vi) Northern Community Care Units;
- (vii) Northern Prevention and Recovery Care Service; and
- (viii) Northern Inpatient Units 1 and 2 Adult (Wards 7 and 8).

SPECIAL

DEFINITIONS AND INTERPRETATION

- 2. In this Order and in Schedule 1:
 - (a) the terms 'property', 'rights' and 'liabilities' have the meaning given to them by section 244 of the Act;
 - (b) the term 'Broadmeadows Community Care Units' means the North West Area Mental Health Service services and facility located at 12–20 Talgarno Street, Broadmeadows;
 - (c) the term 'Broadmeadows Inpatient Unit Adult (BIPU)' means the following services and facilities at the Broadmeadows Health Service campus located at 35 Johnstone Street, Broadmeadows:
 - Broadmeadows Inpatient Unit Adult (BIPU), including the facilities used to provide ECT therapy;
 - (ii) the services and facilities provided by the Hume Community Team;
 - (iii) the services and facilities provided by the Police and Clinician Emergency Response (PACER) team;
 - (d) the term 'Hospital Outreach Post-Suicidal Engagement (HOPE) Service' means the services and facilities of:
 - (i) the Northern Area Mental Health Service of that name at the Northern Hospital Campus located at 185 Cooper Street, Epping; and
 - the North West Area Mental Health Service of that name located at 362 Bell Street, Pascoe Vale South;
 - (e) the term 'Hotham Street Community Team' means the services and facilities provided by the community team located at 83–85 Hotham Street, Preston South;
 - (f) the term 'Jewell House Prevention & Recovery Care Service (PARC)' means the North West Area Mental Health Service and facility located at 6–10 Talgarno Street, Broadmeadows;
 - (g) the term 'McLellan House Hostel' means the services and facility located at 2–6 Robinson Street, Jacana;
 - (h) the term 'Merv Irvine Nursing Home' means the services and facility located at 1231 Plenty Road, Bundoora;
 - (i) the term 'Moreland Clinic' means the North West Area Mental Health services and facilities provided at 130 Bell Street, Coburg (excluding Glencairn Consulting Suites) and includes the services provided by the:
 - (i) Moreland Community Team; and
 - (ii) Police and Clinician Emergency Response (PACER) team;
 - (j) the term 'Noogal Clinic' means the Northern Area Mental Health services and facility located at 16–20 Oleander Drive, Mill Park and includes the services provided by the Noogal Community Team;
 - (k) the term 'Northern Community Care Units' means the services and facilities located at 2–4 Pleasant View Drive, Preston and includes the services and facilities of the Northern Community Care Units;
 - (1) the term 'Northern Prevention and Recovery Care Services' means the Northern Area Mental Health Service and facility located at 123 Wood Street, Preston;
 - (m) the term 'Northern Inpatient Units 1 and 2 Adult (Wards 7 and 8)' means each of the inpatient units located at the Northern Hospital Campus at 185 Cooper Street, Epping and includes the services and facilities provided by the:
 - Northern Inpatient Units 1 and 2 Adult (Wards 7 and 8) and the facilities used to provide ECT therapy;
 - (ii) Emergency Mental Health;

- (iii) Police and Clinician Emergency Response (PACER) team; and
- (iv) Consultation Liaison Psychiatry (CL) clinicians;
- (n) the term 'Residential Agreement' means an agreement made in accordance with the **Aged Care Act 1997** (Cth) between Melbourne Health and a resident, and includes any accommodation bonds or payments paid by the resident in accordance with that Residential Agreement;
- (o) the term 'Treatment Order' means a 'Treatment Order' or 'Temporary Treatment Order' (as the case may be) as defined in section 3 of the **Mental Health Act 2014**;
- (p) a reference to each of Melbourne Health and Northern Health is a reference to a public health service within the meaning of section 3 of the Act.
