MAJOR SPORTING EVENT ORDER FOR THE 2022 TO 2026 AUSTRALIAN MOTORCYCLE GRANDS PRIX

Order in Council

8(2)(a) Event organiser:	Australian Grand Prix Corporation Ltd, ABN 86 947 927 465
8(2)(b) Event area:	The area outlined in red and described on the plan LEGL/08-036 lodged in the Central Plan Office.
8(2)(i) Parts of the Act that apply to the major sporting event specified in this table:	Part 4 (Crowd Management)
8(2)(e) Crowd Management Period	2022 – From 12.01am 13 October 2022 until 11.59pm 17 October 2022. 2023 to 2026 – From 12.01am on the Thursday prior to the event until 11.59pm on the Monday after the event.
