Order in Council

The Lieutenant-Governor, as the Governor's deputy, with the advice of the Executive Council, under section 134(1)(b) of the **Major Transport Projects Facilitation Act 2009**, on the recommendation of the Minister for Transport Infrastructure, divests the land as described in the table below, contained within the project areas across Melbourne including for the Caulfield Dandenong Rail Upgrade Project, Toorak Road Level Crossing Removal Project, the Cranbourne Line Duplication Project, Cardinia Road Level Crossing Removal Project and the Kananook Train Storage Facility Project.
