NOTICE UNDER SECTION 186E(1) OF TEMPORARY CLOSURE OF ROADS TO TRAFFIC AND NOTICE OF OPENING OF ROADS TO TRAFFIC

Borlase Steet and Drysdale Street, Yallambie

I, Roman Garrido, on behalf of the D&C Contractor Representative and Managing Director of the D&C Contractor for the North East Link Project (Project), a declared project under the **Major Transport Projects Facilitation Act 2009** (MTPF Act), acting in my capacity as subdelegate of the project contractor under the MTPF Act pursuant to:

- an instrument of delegation under section 105(1) of the MTPF Act dated 6 December 2021; and
- an instrument of sub-delegation under section 106 of the MTPF Act dated 14 December 2021,

hereby notify that pursuant to section 186D(1)(d) of the MTPF Act the following roads will be closed to traffic:

- parts of Borlase Street between Debra Court and Coleen Street, Yallambie (as shown on the plan in the Schedule and marked 'Borlase Street and Drysdale Street – Road Closure') from 1 September 2022 until 31 December 2028 for the purposes of the Project;
- parts of Drysdale Street between Borlase Street and Greensborough Road, Yallambie (as shown on the plan in the Schedule marked 'Borlase Street and Drysdale Street – Road Closure') from 2 August 2022 until 31 December 2028 for the purposes of the Project;

and

hereby notify that pursuant to section 186D(1)(e) of the MTPF Act the following roads will be opened to traffic:

- parts of Borlase Street connecting with Lower Plenty Road, Yallambie (as shown on the plan in the Schedule and marked 'Borlase Street and Drysdale Street – Road Openings') from 2 August 2022 until 31 December 2028 for the purposes of the Project;
- parts of Drysdale Street connecting with Lower Plenty Road, Yallambie (as shown on the plan in the Schedule marked 'Borlase Street and Drysdale Street – Road Openings') from 2 August 2022 until 31 December 2028 for the purposes of the Project.

These decisions have been exercised solely under sections 186D(1)(d) and (e) of the MTPFA for the purposes of the Project.

These decisions come into effect on the date it is published in the Government Gazette.
