### MINISTERIAL ORDER NO. 1365

Order Amending Ministerial Order No. 1228 – Victorian Institute of Teaching Registration Fees  
The Minister for Education makes the following Order –

**1. Title**

This Order may be cited as Ministerial Order No. 1365 – *Order Amending Ministerial Order No. 1228 – Victorian Institute of Teaching Registration Fees.*

**2. Purpose**

This Order amends Ministerial Order No. 1228 – *Victorian Institute of Teaching Registration Fees (Ministerial Order No. 1228)*, made by the Minister for Education on 16 July 2019 and amended from time to time, to fix new fee rates for existing fees charged by the Victorian Institute of Teaching, including teacher and early childhood teacher registration fees, and to fix fees in relation to pathway programs, for the period 1 September 2022 to 30 August 2023.

**3. Authorising provision**

This Order is made under sections 2.6.77(1), 5.10.4(1) and Clause 3 of Schedule 6 to the **Education and Training Reform Act 2006**.

**4. Commencement**

This Order commences on 1 September 2022.

**5. Clause 4 substituted**

For Clause 4 of Ministerial Order No. 1228 **substitute** –  
'The fees in Clause 5 are for a 12-month period commencing 1 September 2022.'

**6. Clause 5 substituted**

For Clause 5 of Ministerial Order No. 1228 **substitute** –  
'The following fees are fixed pursuant to section 2.6.77 of the Act:

Initial registration (applicants with Victorian qualifications) / permission to teach pursuant to sections 2.6.7(2), 2.6.12A(2)* and 2.6.13(2)	\$147
Initial registration (applicants with interstate or overseas qualifications) / permission to teach pursuant to sections 2.6.7(2) and 2.6.13(2)*	\$170
Application for second registration pursuant to section 2.6.7(2), 2.6.12A(2) and 2.6.77A	\$35
Annual registration/renewal of registration if paid by 30 September pursuant to sections 2.6.18 and 2.6.21**	\$110
Annual registration/renewal of registration if paid from 1 October to 31 December which incorporates the late processing fee/additional fee pursuant to sections 2.6.18 and 2.6.21**	\$145
Annual registration /Renewal of registration for second registration pursuant to section 2.6.18, 2.6.21 and 2.6.77A**	\$25
National criminal history check (known as the Nationally Coordinated Criminal History Check) pursuant to section 2.6.22A(3)	\$63
Late processing fee/additional fee pursuant to sections 2.6.18 and 2.6.21	\$35

Statement of good standing pursuant to section 2.6.4(2)(g)	\$50

\* There may be an additional cost for a Nationally Coordinated Criminal History Check.

\*\* Annual registration fee is payable where registration is not due for renewal. In all other cases the renewal fee applies.'
