## Road Safety Act 1986

### ORDER UNDER SECTION 96A

#### Variation of the Road Safety (Drivers) Regulations 2019

Under section 96A of the **Road Safety Act 1986**, I, the Hon. Ben Carroll, Minister for Roads and Road Safety, declare that the Road Safety (Drivers) Regulations 2019 are varied as follows –

- (1) In regulation 104(1), for ‘regulations 105’ **substitute** ‘regulations 104A, 105’.
- (2) After regulation 104 **insert** –  
**‘104A Free first probationary driver licence**
  - (1) The fee payable by a person for the grant of a probationary driver licence is nil.
  - (2) The fee payable under subregulation (1) only applies the first time the person is granted a probationary driver licence and does not apply to any future renewals of that person’s probationary driver licence.’
- (3) In Schedule 6 –
  - (a) for items 2 and 3 **substitute** –

‘2	Written, computer-based or on-line test (other than an on-line test to which item 3 applies) conducted by the Secretary for a learner permit	23(2)	1·66 fee units
3	On-line test conducted by the Secretary at a place other than premises provided by or on behalf of the Department for a learner permit, if the applicant takes the on-line test within 12 months after the date of first enrolment	23(2)	nil
3A	Written, computer-based or on-line test (other than an on-line test to which item 3B applies) conducted by the Secretary for a car driver licence or a motor cycle licence	23(2)	1.27 fee units
3B	First on-line test conducted by the Secretary at a place other than premises provided by or on behalf of the Department for a car driver licence or motor cycle licence	23(2)	nil
3C	Written or computer-based test conducted by the Secretary for a variation of a car driver licence (other than a variation of a car licence in order to grant a heavy vehicle licence to which item 3D applies) or motor cycle driver licence	23(2)	1·27 fee units
3D	Written or computer-based test conducted by the Secretary for a heavy vehicle driver licence or variation of a heavy vehicle driver licence	23(2)	1·37 fee units’
  - (b) for item 8 and 9 **substitute** –

‘8	First grant of a motor cycle learner permit	23(2), 62(2)	nil
8A	Second or subsequent grant of a motor cycle learner permit	23(2), 62(2)	1·7 fee units

**SPECIAL**

9	First grant of a car learner permit	23(2), 62(2)	nil
9A	Second or subsequent grant of a car learner permit	23(2), 62(2)	1·7 fee units
9B	Renewal of a car learner permit	23(2), 62(2)	1·7 fee units'

This Order commences on 15 August 2022.

This Order is revoked on 1 October 2022.
