Transport (Compliance and Miscellaneous) Act 1983

AMENDING CONDITIONS NO. 2/2022 MADE UNDER SECTION 220D

The Head, Transport for Victoria, the entity established under section 64A of the **Transport Integration Act 2010** hereby determines, under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, the following conditions (the Amending Conditions No.2/2022) which amend the Conditions under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983** published in the Victoria Government Gazette No. S 731 dated Tuesday 21 December 2021, effective 1 January 2022, as amended by amending conditions published in the Victoria Government Gazette No. S 362 dated Friday 15 July 2022, effective 16 July 2022.

The Amending Conditions No. 2/2022 take effect from and including the day they are published in the Government Gazette.

AMENDING CONDITIONS NO. 2/2022

The Conditions under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983** published in the Victoria Government Gazette No. S 731 dated Tuesday 21 December 2021, effective 1 January 2022, as amended by amending conditions published in the Victoria Government Gazette No. S 362 dated Friday 15 July 2022, effective 16 July 2022, are amended as follows:

1. Repeal Clause 3.79.
2. For Clause 3.155(a) **substitute** –
'(a) customers using a myki are not required to touch on and off;'
3. After Clause 5.4 **insert** new Clause 5.4A as follows –
'5.4A A customer who purchases a V/Line ticket online will be taken to hold a valid V/line ticket, subject to all other Conditions, if –
 - (a) the customer can produce a legible copy (which may be an electronic or hard copy) of the email confirmation received from V/Line, in the format it was received from V/Line, in respect of that ticket; and
 - (b) the customer collects their paper ticket at the first reasonable opportunity.'
4. In Clause 5.15(d)c.iv. for '\$8.20' **substitute** '\$8.40'.
5. After Clause 5.19 **insert** new Clause 5.19A as follows –
'5.19A The conditions in clauses 5.16 to 5.19 providing for additional travel authorised by V/Line tickets only apply where a customer holds a paper V/Line ticket and do not apply where a customer is relying on an email confirmation received from V/Line in respect of a V/Line ticket purchased online to authorise their travel as provided for in Clause 5.4A.'
6. In Clause 7.1, for 'groups of 12 or more people (up to a maximum of 35 people on trams, 25 people on buses and 35 people per train carriage)' **substitute** 'groups of 12 or more people (up to a maximum of 35 people on a tram or bus or 35 people per train carriage)'
7. In Clause 7.8(b) for 'Table 8' **substitute** 'Table 7'.
8. For Clause 7.11(a)(i) **substitute** –
'(i) from 9.00am to 4.00pm; and'
9. In **Table 7** for '25 per service' **substitute** '35 per service'.
10. **Repeal** Clause 7.31.
11. For Clause 7.32 **substitute** –
'7.32 A Day, 7 Day or 30 Day Travel Pass cannot be reissued or exchanged by the Head, Transport for Victoria.'

The amendments made by these amending conditions apply in respect of entitlements to use a public transport service that are subject to the conditions contained in the Conditions and that are able to be exercised on or after the commencement of these amending conditions, including entitlements that existed, but had not been exercised, before these amending conditions were published in the Government Gazette.
