NOTICE OF DECISION TO DISCONTINUE PARTS OF ROADS

PORTIONS OF BUCKLEY STREET, BROADMEADOWS-TULLAMARINE ROAD,
GOVERNMENT ROAD ABUTTING BUCKLEY STREET (CROWN ALLOTMENT 2261),
RUSSELL STREET AND ROSE STREET TO BE DISCONTINUED

Under section 186A(1)(a) of the **Major Transport Projects Facilitation Act 2009** (Act), I, Matt Thorpe, Program Director, Level Crossing Removal Project, as delegate of the project authority for the Buckley Street, Essendon Level Crossing Removal Project and the Camp Road, Campbellfield Level Crossing Removal Project, hereby discontinue the parcels of the roads described in Schedule A and on the plans attached in Schedule B (Road Portions).

The decision to discontinue the Road Portions takes effect upon publication of this notice under section 186A(1)(a) of the Act.

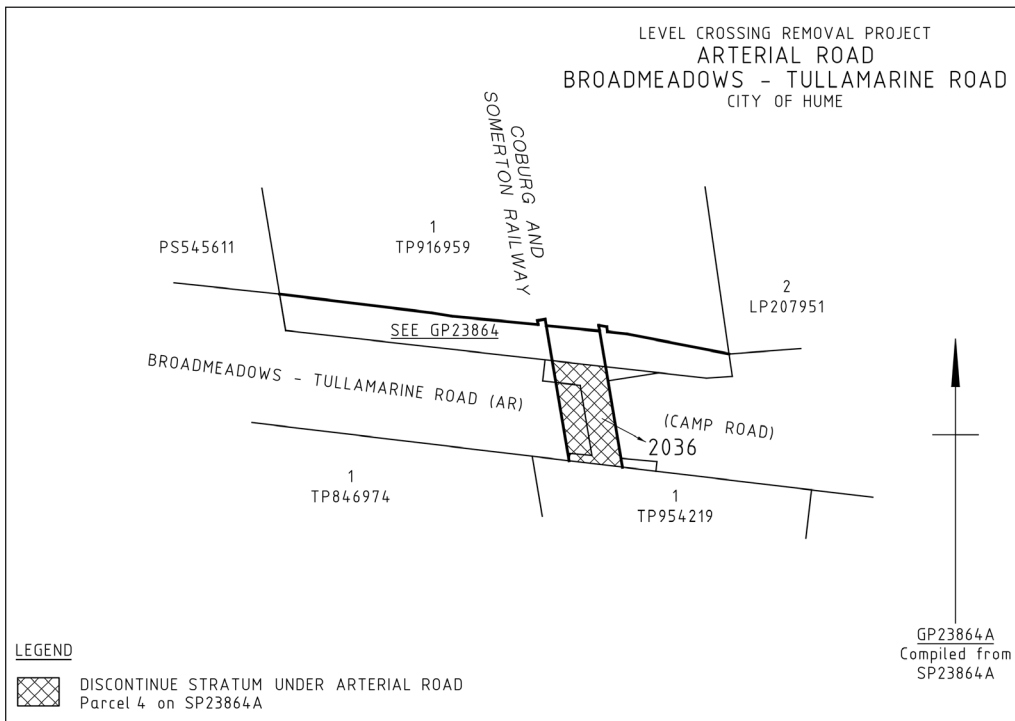
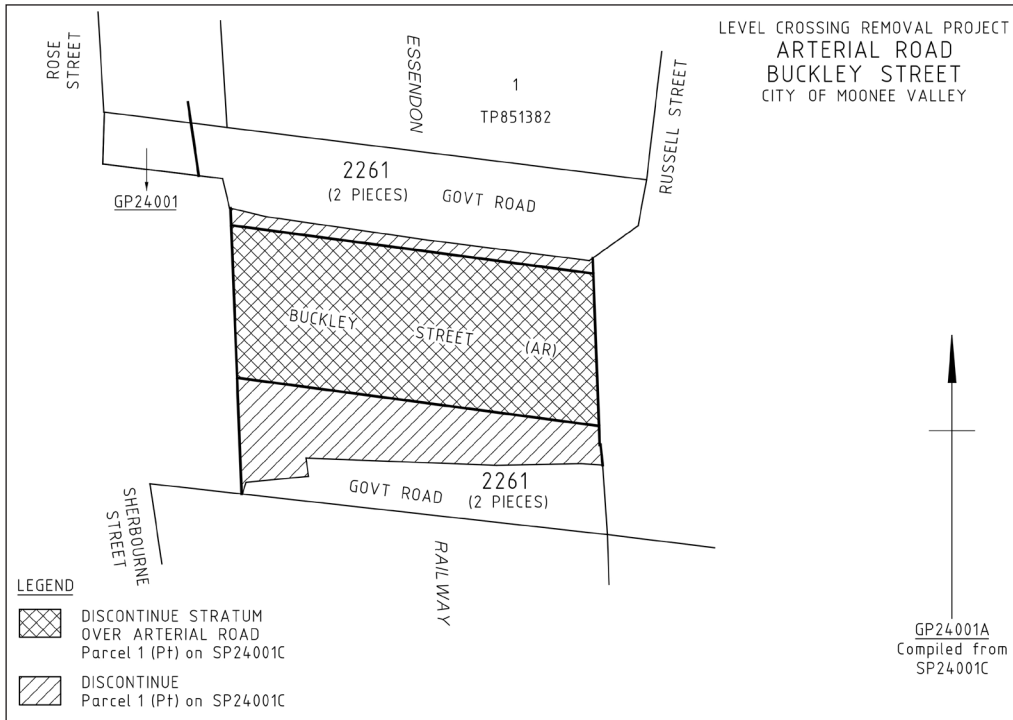
- 1) Parcel 1 of Buckley Street identified by hatching on the plan numbered GP24001A is discontinued as described in the legend in the said plan.

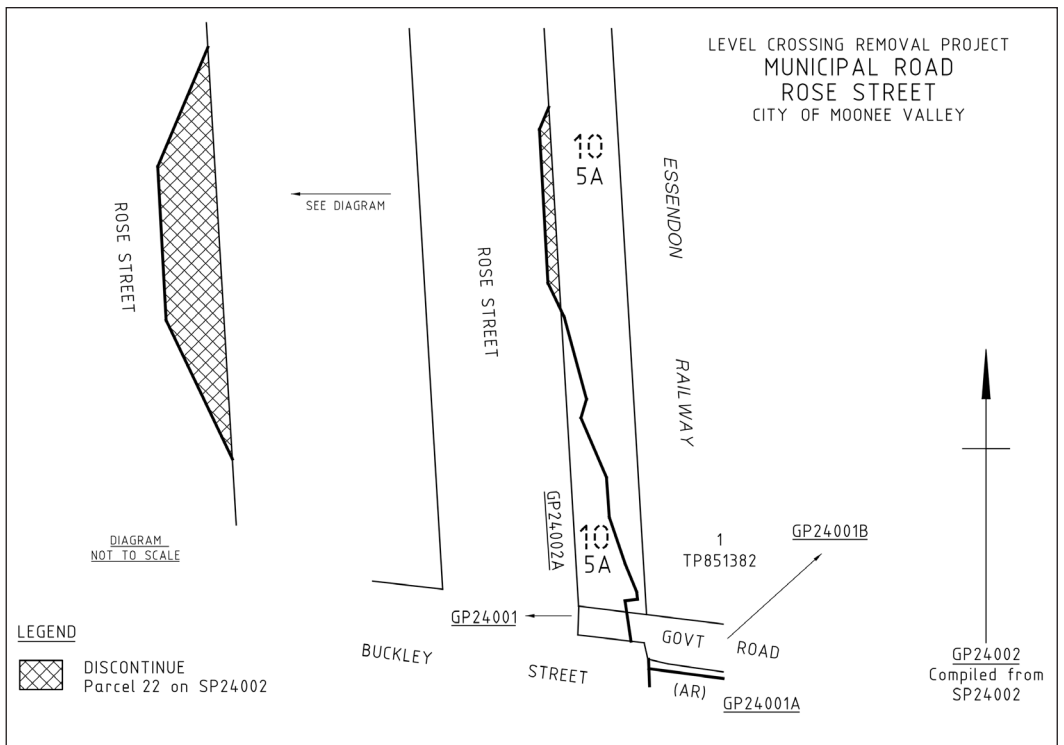
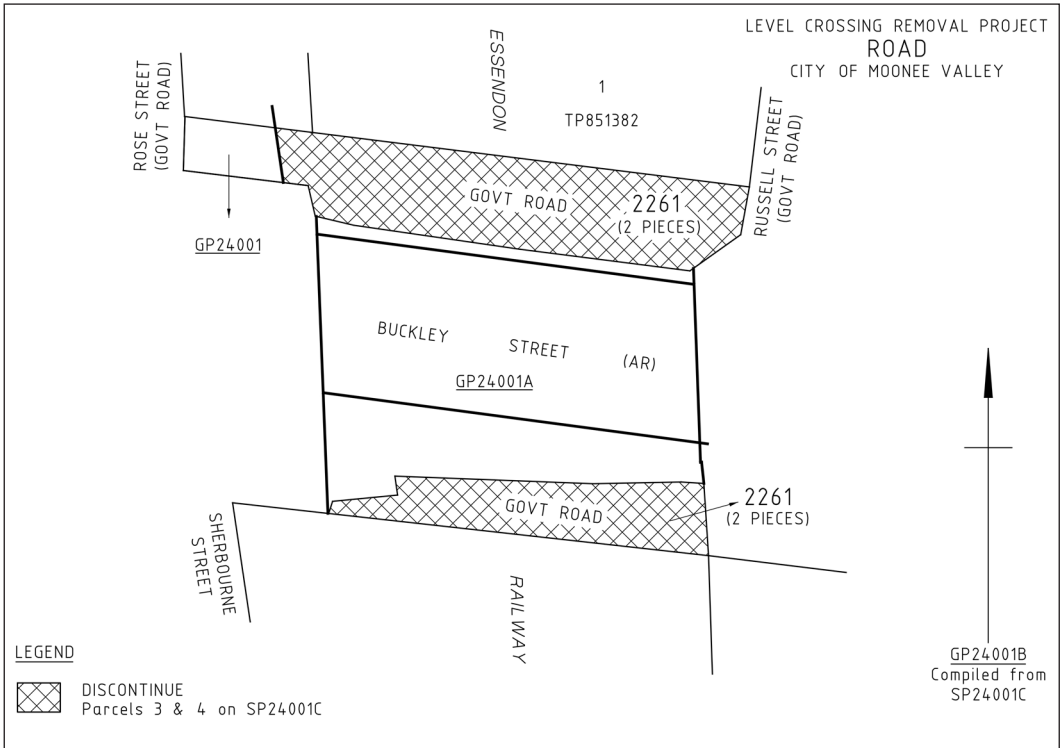
Municipal Road

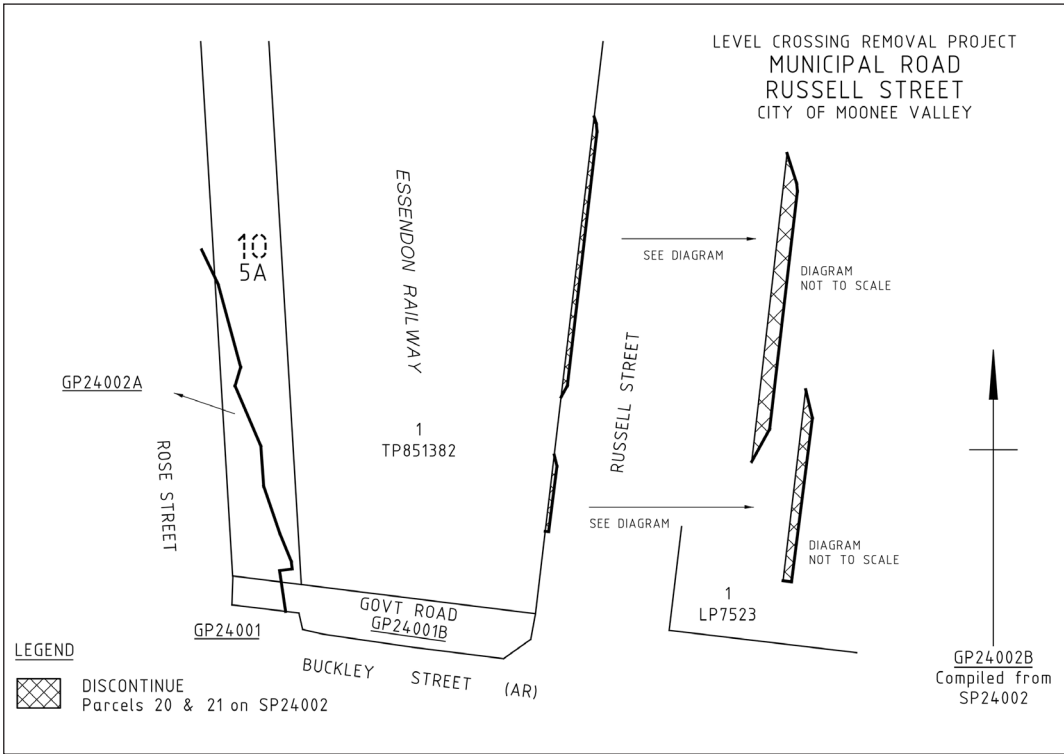
