NOTICE OF DECISION TO DISCONTINUE PARTS OF ROADS

PORTIONS OF CARDINIA ROAD, GOVERNMENT ROAD ABUTTING CARDINIA ROAD,
GOVERNMENT ROAD ABUTTING EVANS ROAD, EVANS ROAD, SALISBURY ROAD
AND WINDSOR AVENUE TO BE DISCONTINUED

Under section 186A(1)(a) of the **Major Transport Projects Facilitation Act 2009** (Act), I, Andrew Peplinkhouse, Program Director, Level Crossing Removal Project, as delegate of the project authority for the Cardinia Road Level Crossing Removal Project, the Evans Road Level Crossing Removal Project and the Car Parks for Commuters Project (collectively the Projects), hereby discontinue the parts of the roads described in Schedule A and on the plans attached in Schedule B (Road Portions).

The decision to discontinue the Road Portions takes effect upon publication of this notice under section 186A(1)(a) of the Act.

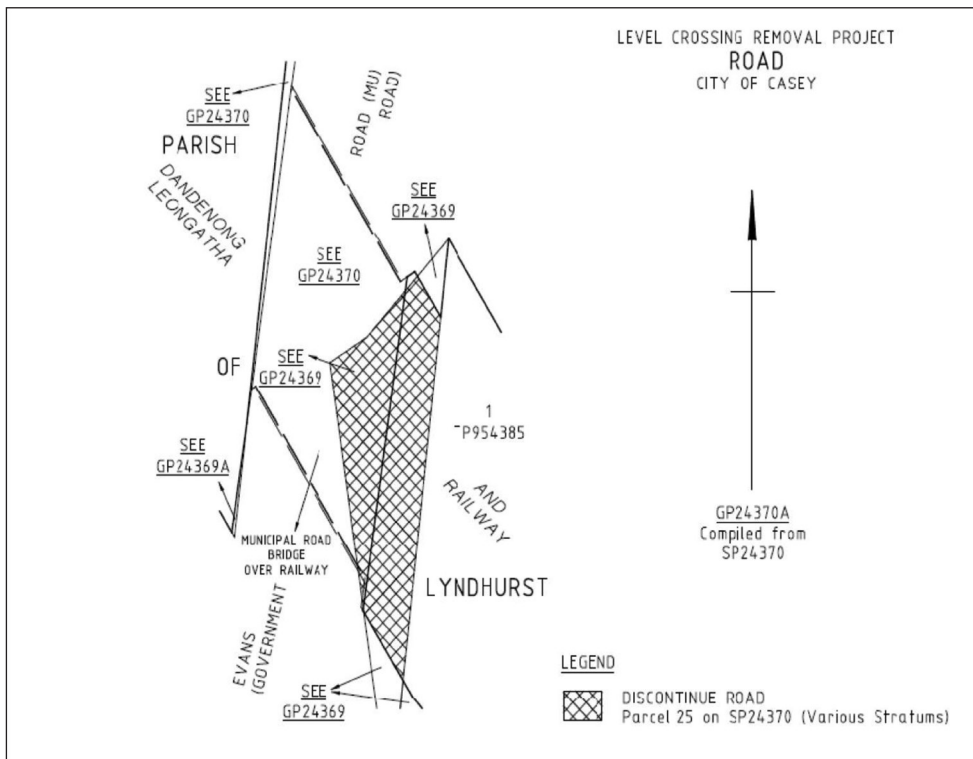
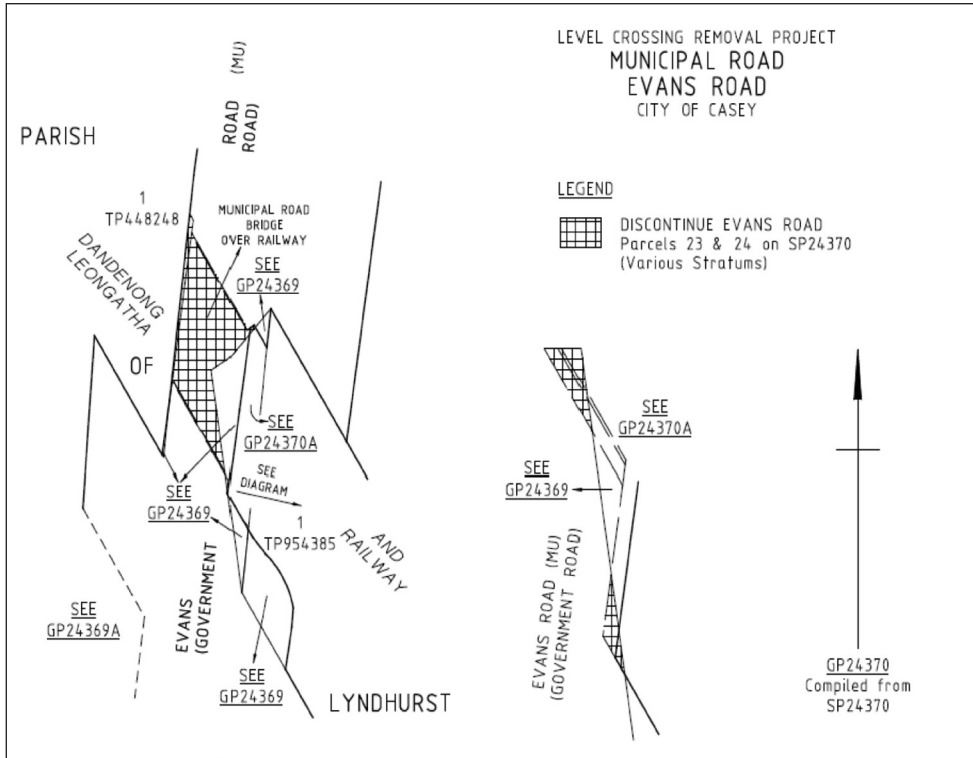
Municipal Road

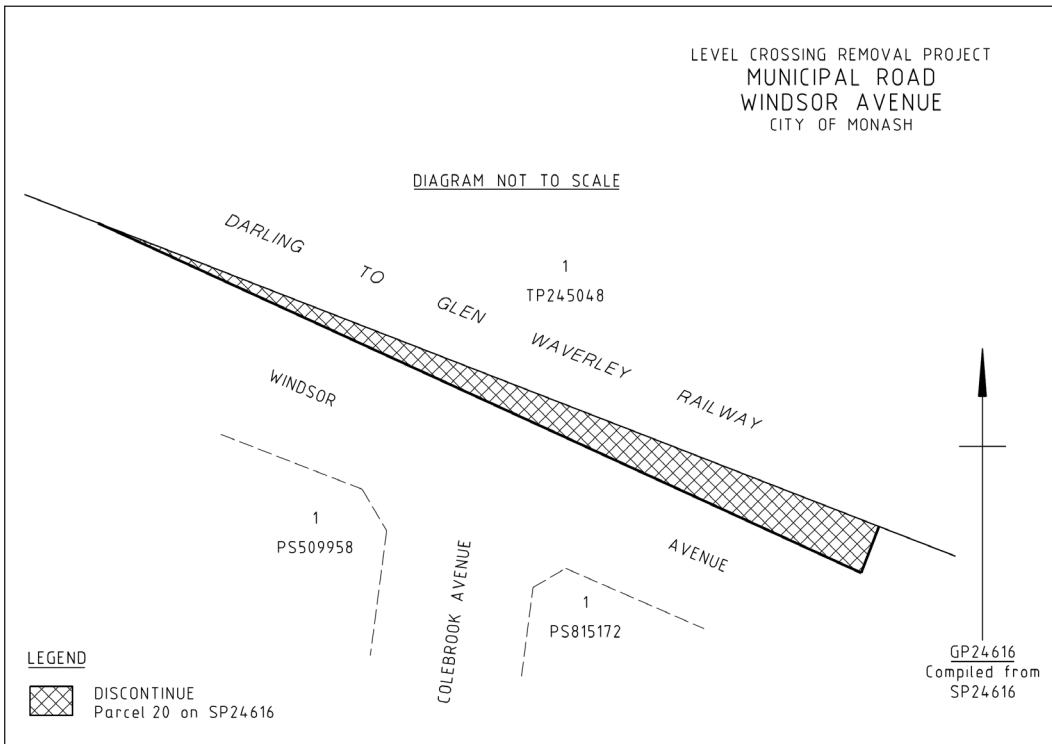
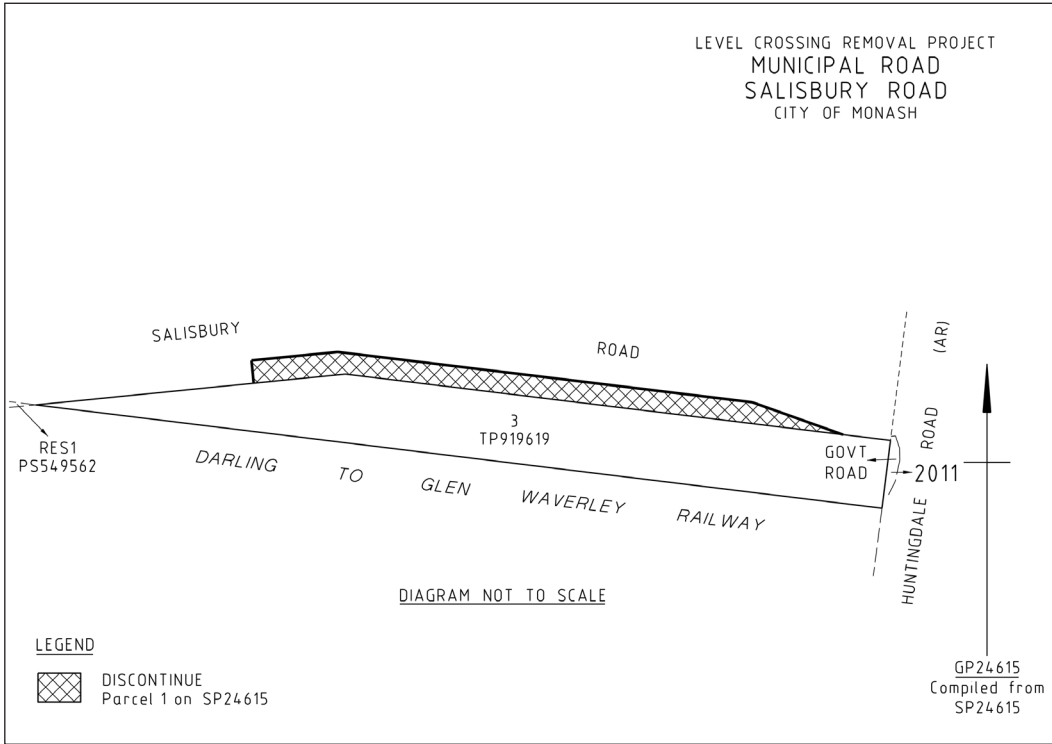

- 3) Parcel 25 on SP24370 of Government Road abutting Evans Road as identified by the hatching on the plan numbered GP24370A is discontinued as described in the legend in the said plan.
- 4) Parcel 1 on SP24615 of Salisbury Road as identified by cross-hatching on the plan numbered GP24615 is discontinued as described in the legend in the said plan.
- 5) Parcel 20 on SP24616 of Windsor Avenue as identified by the cross-hatching on the plan numbered GP24616 is discontinued as described in the legend of the said plan.
