ROAD DECLARATION

Head, Transport for Victoria, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares the road described in Schedule A and on the plan attached. The effects of this Road Declaration on road names is described in Table 1.

Head, Transport for Victoria, also authorises the access point described in Schedule B and on the plan attached.

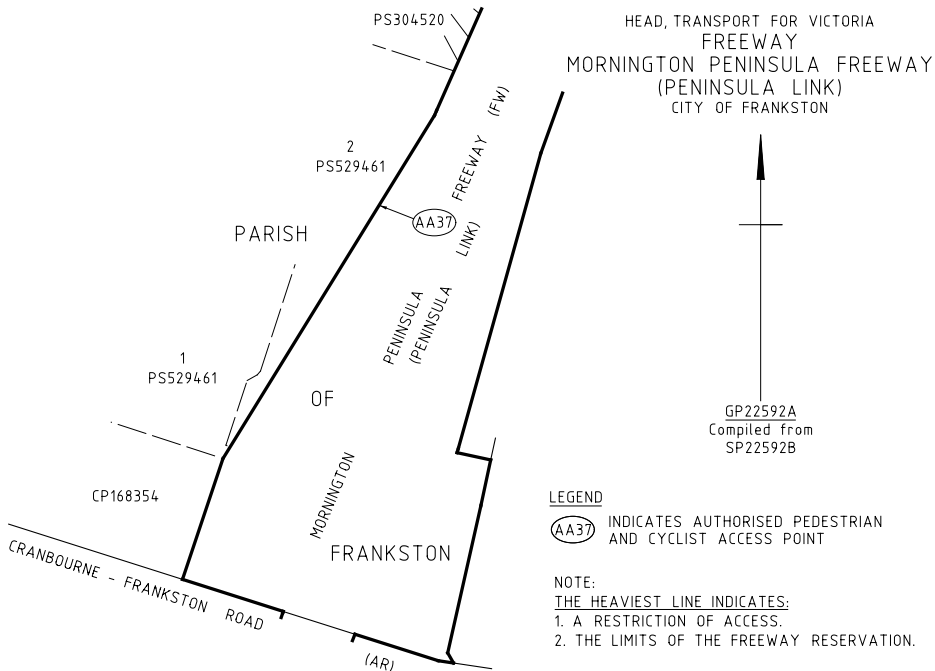
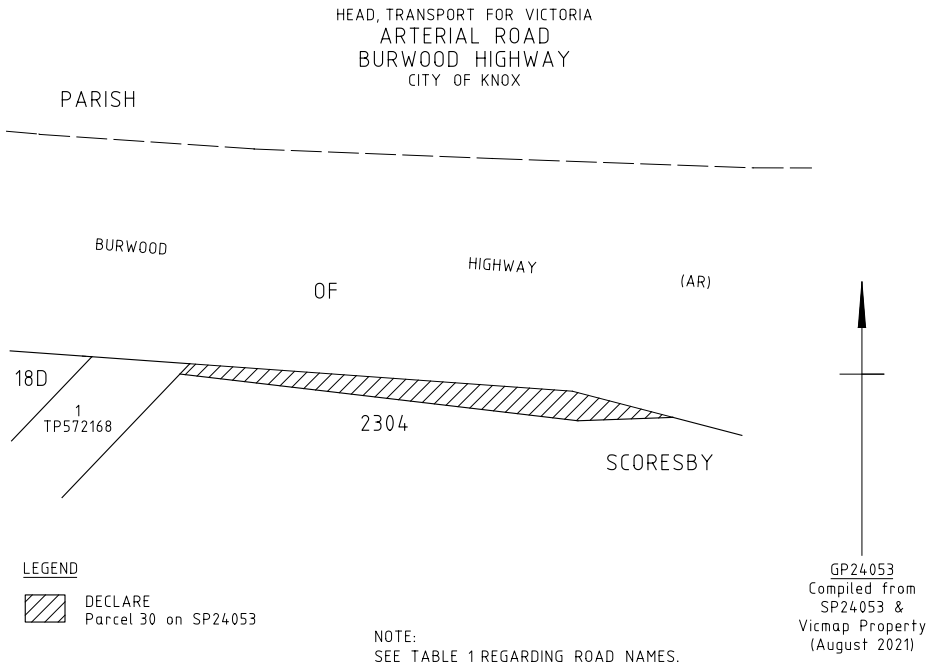

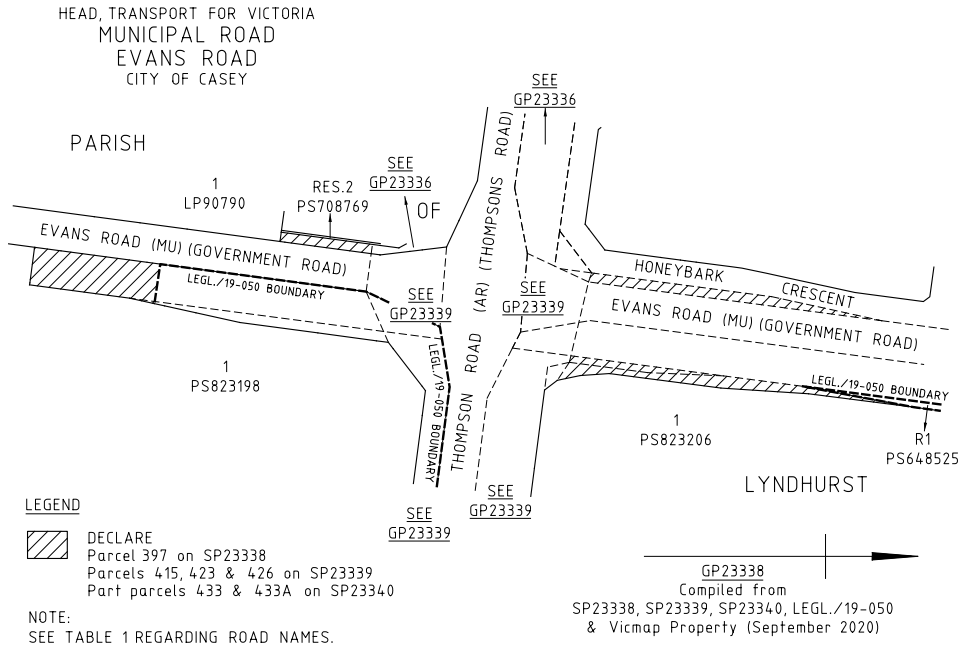
