ROAD DECLARATIONS

Head, Transport for Victoria, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares and revokes the roads described in the Schedule and on the plans attached.

The effects of these Road Declarations on road names are described in Table 1.

SCHEDULE

ARTERIAL ROAD

- a) Those parts of South Gippsland Highway identified by hatching on the plans numbered GP20714, GP20715, GP20716 and GP20717 are declared or revoked as described in the legend in the said plans.
- b) That part of Davey-Hastings Road identified by hatching on the plan numbered GP24651 is declared as described in the legend in the said plan.
- c) That part of Murray Valley Highway identified by hatching on the plan numbered GP24675 is declared as described in the legend in the said plan.

MUNICIPAL ROAD

- d) That part of Prosser Road identified by hatching on the plan numbered GP20715A is declared as described in the legend in the said plan.

TABLE 1

EFFECTS ON ROAD NAMES

1. Names in Column 2 are existing Vicmap Address names, which are unaffected by this notice.
2. **Names in Column 1 are for Department of Transport administrative purposes only and are independent of names in Column 2.**
3. Names in Column 2 may not apply to the whole length of the road and are for general information only.

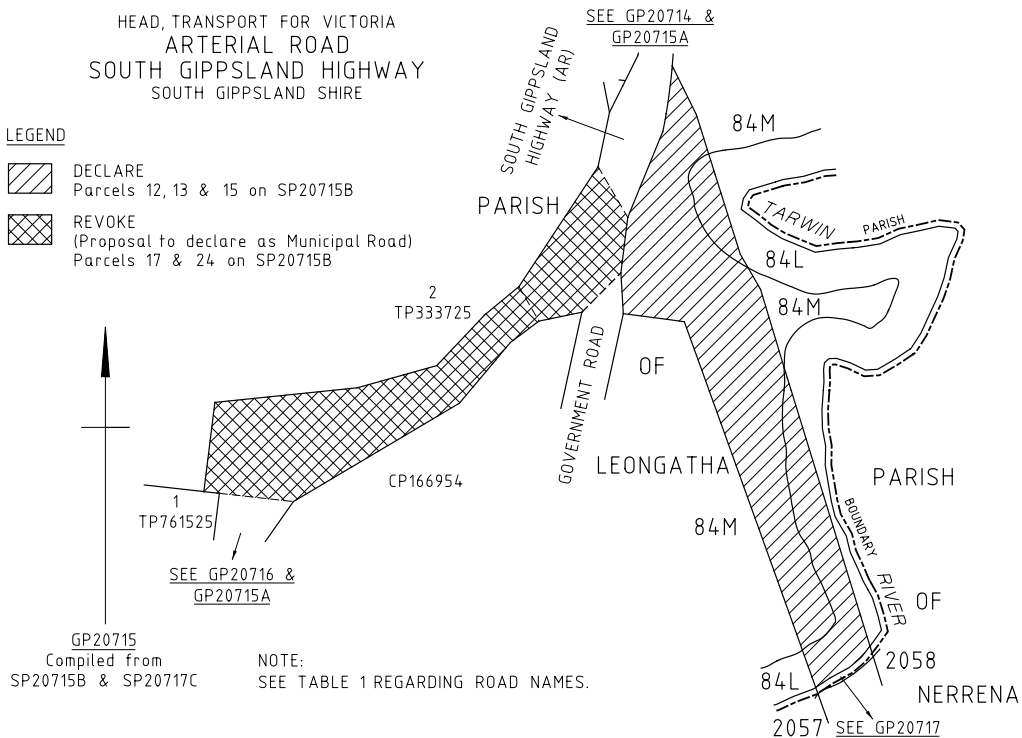
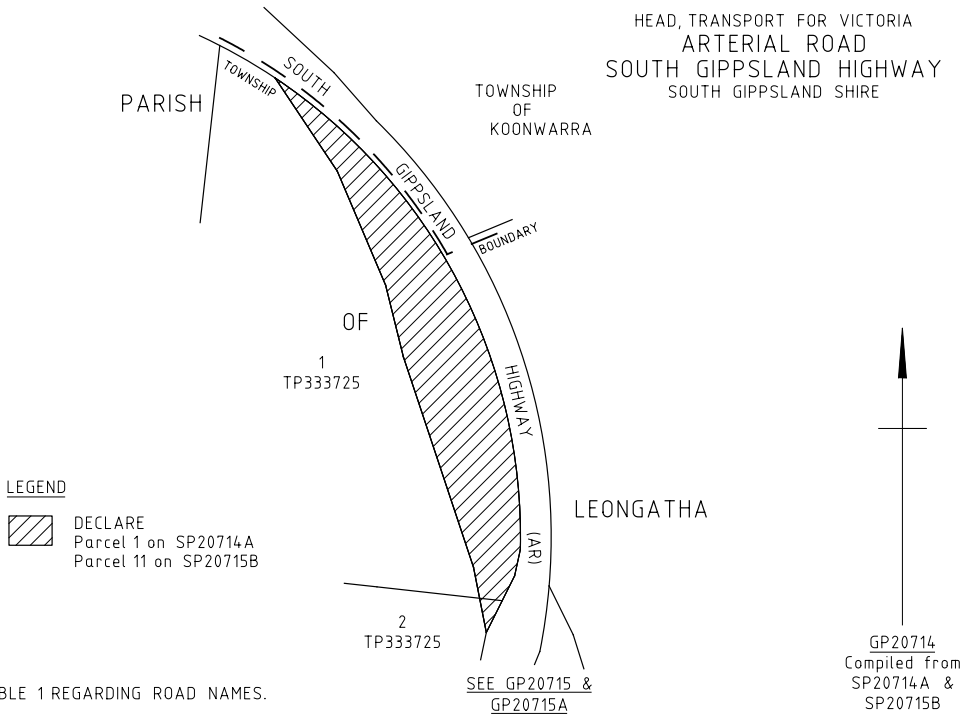
