Flora and Fauna Guarantee Act 1988

NOTICE OF DECISION UNDER SECTION 16G

In accordance with section 16G of the **Flora and Fauna Guarantee Act 1988**, Lily D'Ambrosio, Minister for Environment and Climate Action, and Gayle Tierney, Minister for Agriculture have:

- (i) considered the recommendations of the Scientific Advisory Committee regarding *Hyridella depressa* (Depressed Freshwater Mussel) and *Hyridella narracanensis* (Narracan Corrugated Mussel) as published on the internet at https://www.environment.vic.gov.au/conserving-threatened-species/threatened-list and in the Government Gazette on 7 July 2022; and
- (ii) decided to recommend to the Governor in Council that the taxa described in Column 1 of Table 1 in the Schedule to this Notice be specified in the Threatened List as Endangered in Victoria for the reasons that they meet the criterion shown in Column 5 of that Table.

SCHEDULE

In Table 1 in this Schedule -

4.1 means Primary Criterion **4.1** of the Flora and Fauna Guarantee Regulations 2020 and that the taxon of flora or fauna is Endangered.

4.1.2 means Subcriterion **4.1.2** of the Flora and Fauna Guarantee Regulations 2020 and that the taxon's geographic distribution is highly restricted and -

- (a) the distribution of the population or habitat of the taxon is severely fragmented or restricted to a limited number of threat-based locations; and
- (b) (iii) there is a continuing decline or reduction in area, extent or quality of habitat.
