Order in Council

The Lieutenant-Governor, as the Governor's deputy, with the advice of the Executive Council under section 7 of the **Major Events Act 2009** (the Act) specifies each of the matters in Column 2 of Table 1 in accordance with the corresponding section of the Act in Column 1 of Table 1.

8(1)(a)	Major sporting event:	2022 AFL Grand Final Parade
8(1)(b)	Event venue:	The event venue (parade route) comprises the made surface of the identified paths and bridges as shown by the yellow line and yellow filled area in Schedule – Plan 1.
8(2)(a)	Event organiser:	Australian Football League
8(2)(b)	Event area:	The event area comprises the area inside the red line as shown and described in Schedule 1 – Plan 1 (excluding the Yarra River).
8(2)(i)	Parts of the Act that apply	Part 4 (Crowd Management)
8(2)(e)	Crowd Management Period	8.00 am to 1.00 pm (event venue and event area west of William Barak Bridge western steps). 8.00 am to 6.00 pm (event venue and event area east of William Barak Bridge eastern end).

AFL GRAND FINAL PARADE – PLAN 1****Purpose of Plan**

To define the perimeter of the Event Venue and Event Area for the AFL Grand Final Parade under the **Major Events Act 2009**.

Event Venue

The parade route (Event Venue) comprises the area hatched in yellow and the made surface of the identified paths and bridges as shown and described on Plan 1.

Event Area

The area in red is the Event Area and includes:

Yarra Park Reserve, together with adjoining land up to the back of the kerb along all surrounding streets including Punt Road.

Land immediately on Brunton Avenue and Brunton Avenue from its intersection with Punt Road to its intersection with Jolimont Street.

The southern bank of the Yarra River to the kerb of Alexandra Avenue from Princes Bridge to Swan Street Bridge (excludes the Yarra River).

The footpath on the eastern side of Princes Bridge.

The footpath on the southern and northern sides of Swan Street Bridge.

North-western corner of Princes Walk near the commencement of St Kilda Road at the row of bollards. From here it travels in an easterly direction along the line of the built form of Federation Square, turning north and then east again until it reaches the boundary of Birrarung Marr. It then continues easterly and then north-easterly along the wall of the car park, up some steps and along a path to the northern-east corner of Birrarung Marr at Batman Avenue. The boundary then follows the property line of Birrarung Marr south-easterly and then south along the western side of Batman Avenue until it reaches the southern corner of Birrarung Marr which is marked by an row of bollards opposite Margaret Court Arena. The boundary then continues to follow Batman Avenue south-easterly to Olympic Boulevard, westerly to the Yarra River, thence north-westerly along the northern bank of the Princes Walk from St Kilda Road. Here it turns north until it reaches the end of the bluestone wall that runs along Princes Walk from St Kilda Road. Here it turns north until it reaches the end of the bluestone wall and turns along the back of the bluestone wall to the bollards and the starting point.
