## Disability Service Safeguards Act 2018

### Section 132

#### PROHIBITION ORDER

This Prohibition Order is made pursuant to section 132 of the **Disability Service Safeguards Act 2018**.

I, Daniel Stubbs, the Victorian Disability Worker Commissioner (Commissioner) make this Prohibition Order (Prohibition Order) because the below ground(s) exists and I am satisfied that it is necessary to make this Prohibition Order to avoid a serious risk to the life, health, safety or welfare of a person or the health, safety or welfare of the public.

<b>Name of the unregistered disability worker to whom this Prohibition Order applies:</b>	Praveen Yadav
<b>Ground(s) for making the Prohibition Order:</b>	Section 133(a) and (b) of the <b>Disability Service Safeguards Act 2018</b>
<b>Date this Prohibition Order is made:</b>	20 September 2022
<b>Date this Prohibition Order takes effect:</b>	25 September 2022
<b>Date on which this Prohibition Order expires:</b>	This Prohibition Order will remain in force for 8 years from the date it takes effect and will expire on 24 September 2030 unless it is varied or revoked before that date.
<b>Effect of this Prohibition Order:</b>	<p>The unregistered disability worker is: Prohibited from providing any disability services in Victoria.</p> <p>Under section 3 of the <b>Disability Service Safeguards Act 2018</b>, a disability service means –</p> <p>(a) a service (other than a prescribed exempt service) which involves more than incidental contact with a person with a disability and is specifically provided to the person for the principal purpose of caring for, or treating, the person or supporting the person to manage the person’s limitations in undertaking one or more of the following activities –</p> <ul style="list-style-type: none"><li>(i) communication;</li><li>(ii) social or economic participation;</li><li>(iii) social interaction;</li><li>(iv) learning;</li><li>(v) mobility;</li><li>(vi) self-care;</li><li>(vii) self-management; or</li></ul> <p>(b) a prescribed service.</p>

In this Prohibition Order ‘unregistered disability worker’ and ‘disability service’ have the same meaning as in section 3 of the **Disability Service Safeguards Act 2018**.

**SPECIAL**

This Prohibition Order takes effect on the date specified in the Order.

This Prohibition Order will be published in the Victoria Government Gazette and on the internet site of the Victorian Disability Worker Commission, [www.vdwc.vic.gov.au](http://www.vdwc.vic.gov.au)

Contravention of a Prohibition Order is an offence under the **Disability Service Safeguards Act 2018**.
