### DESIGNATION OF THE PROJECT AREA FOR A DECLARED PROJECT

#### Suburban Rail Loop Project East

I, Lily D'Ambrosio, Minister for Environment and Climate Action, pursuant to section 95(2)(a) of the **Major Transport Projects Facilitation Act 2009** (the Act), designate the area of land shown on the plans signed by the Surveyor-General with references LEGL./22-118 Sheets 1 to 77 (inclusive) lodged at the Central Plan Office on 24 August 2022, and as generally indicated on the map in the Schedule, for the Suburban Rail Loop Project East declared by the Premier to be a declared project pursuant to section 10(1)(b) of the Act and published in the Government Gazette on 27 January 2022.

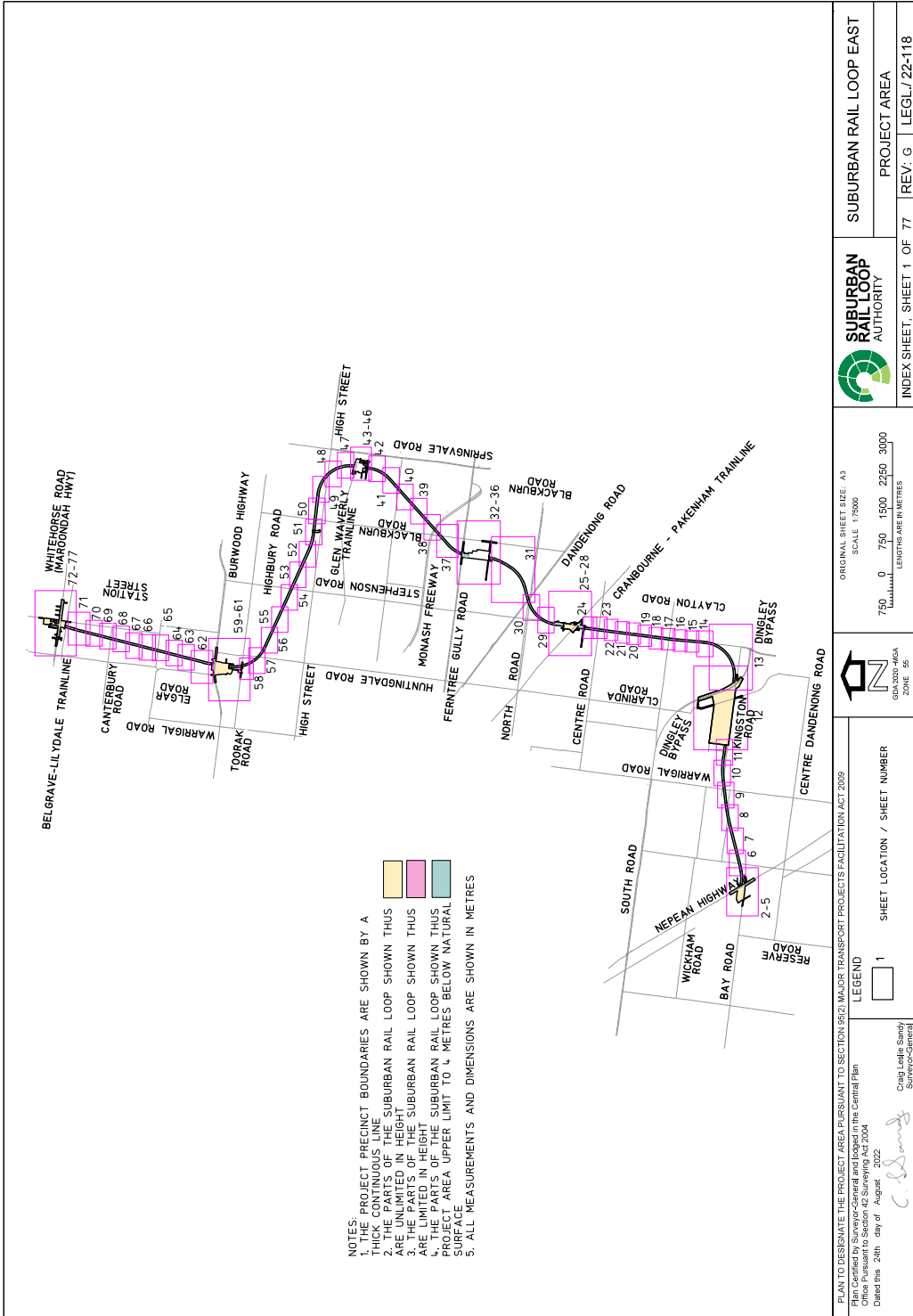
This order comes into effect from the date it is published in the Government Gazette.
