ROAD REVOCATION AND DISCONTINUANCES

ROAD REVOCATION

The Head, Transport for Victoria, pursuant to section 14 of the **Road Management Act 2004**, upon publication of this notice revokes the road described in Schedule A and on the plan attached.

ROAD DISCONTINUANCES

The Head, Transport for Victoria, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the roads described in Schedule B and on the plans attached.

The effects of the Road Revocation and Discontinuances on road names are described in Table 1.

SCHEDULE A

FREEWAY

- a) That part of West Gate Freeway identified by hatching on the plan numbered GP24202 is revoked as described in the legend in the said plan.

SCHEDULE B

ROAD

- a) Those parts of Road identified by hatching on the plans numbered GP24202 and GP24202A are discontinued as described in the legend in the said plans.

EFFECTS ON ROAD NAMES

- Names in Column 2 are existing Vicmap Address names, which are unaffected by this notice.
- Names in Column 1 are for Department of Transport administrative purposes only and are independent of names in Column 2.**

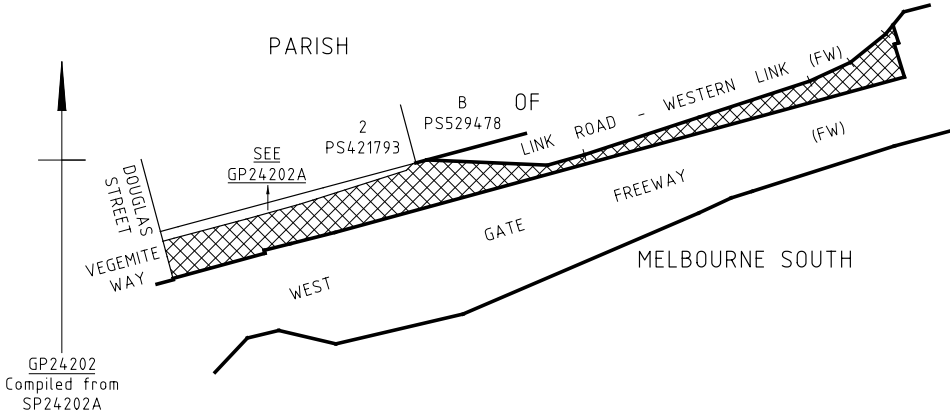

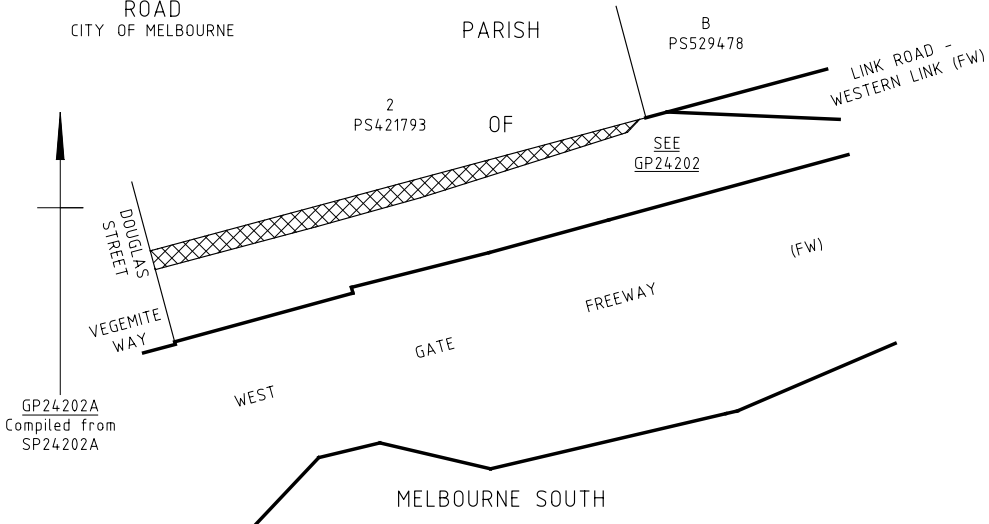
