Road Management Act 2004

DESIGNATION OF TOW-AWAY AREA UNDER SCHEDULE 4 CLAUSE 5

Tow-Away Area for the Melbourne Fringe Parade and Block Party in the City of Melbourne

Clause 5 of Schedule 4 to the **Road Management Act 2004** provides that a State road authority may move, keep or impound any vehicle that is unlawfully parked or left standing in an area designated by the Minister, (referred to in this instrument as a ‘tow-away area’), and may charge the owner of the vehicle a reasonable fee.

For the purposes of that provision, I, David Teague, Acting Executive Director Inner Metro at the Department of Transport and delegate of the Minister for Roads, designate the locations specified and shown on the attached plan to be a tow-away area to facilitate the Melbourne Fringe Parade and Block Party, to be held in and around Argyle Square, Carlton.

This instrument takes effect at 5.00 am on Saturday 15 October 2022 and expires at 11.59 pm on Sunday 16 October 2022.

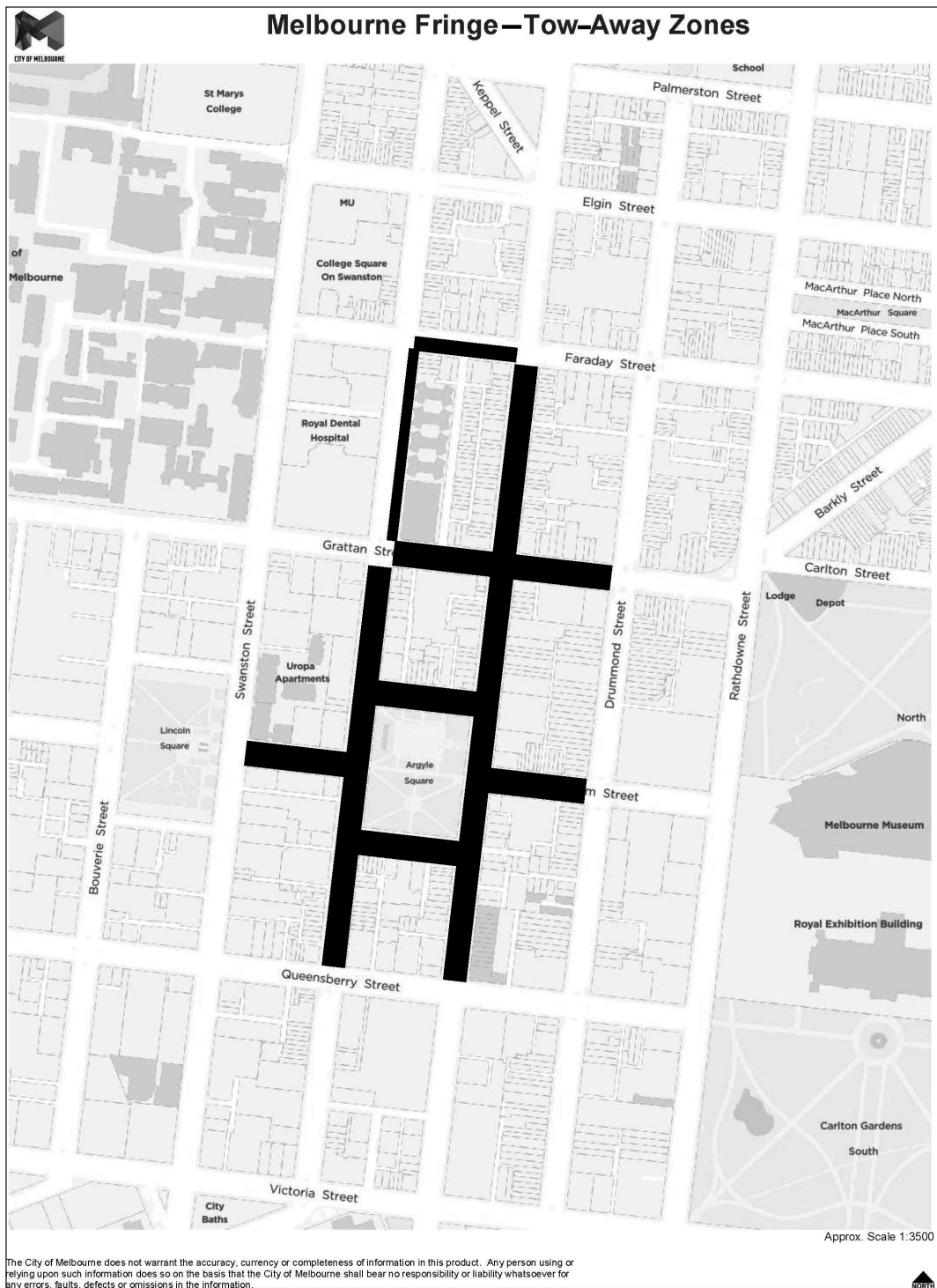
- Cardigan Street: Argyle Place North to Queensberry Street (all on-street bays);
- Cardigan Street: Grattan Street to Argyle Place North (southbound lane and median bays);
- Cardigan Street: Grattan Street to Faraday Street (southbound side only);
- Pelham Street: Swanston Street to Drummond Street (all on-street bays);
- Argyle Place South: Lygon Street to Cardigan Street (all on-street bays and median bays);
- Argyle Place North: Lygon Street to Cardigan Street (all on-street bays and median bays);
- Grattan Street: Cardigan Street to Drummond Street;
- Lygon Street: Queensberry Street to Faraday Street;
- Faraday Street: Cardigan Street to Lygon Street (westbound lane and all median bays).
